In the bill:

Page 77, Line 4: Strike "Reserve" in header replace with "Preserve"

In the report:

On page 12, on the 3rd line of Wild Horse and Burro Management change the sentence from"\$11,000,000 for research on reversible immunocontraceptive fertility control and its administration;" to " \$11,000,000 for administration of and research on reversible immunocontraceptive fertiliy;" and on line 16 change "with other Federal partners to significantly progress research on reversible immunocontraceptive fertility control and its administration." to "with other Federal partners to significantly progress the administration of and research on reversible immunocontraceptive fertility control."

On page 33 after Diversity Reporting Requirements for Special Use Permits paragraph, insert new paragraph: El Camino Real de los Tejas National Historic Trail. -- The Committee encourages the National Park Service to emphasize and increase collaborations with local non-profit organizations to support research and renewal efforts of the El Camino Real de los Tejas National Historic Trail.

On page 33, in the paragraph with the header "Outreach", after "Universities," insert "Asian American Native American Pacific Islander-Serving Institutions, Tribal Colleges and Universities,"

On page 50, strike the last sentence of the first full paragraph and insert: "The Committee expects BIA to continue funding the existing recipients at the same amount, including funding to support women and children's shelters."

On Page 50, within the Bureau of Indian Affairs, strike "The recommendation includes \$37,400,000 for Road Maintenance, as requested, and \$604,000 above the enacted level." and insert "The recommendation includes \$38,400,000 for Road Maintenance, \$1,604,000 above the enacted level. The Committee recognizes the importance of funding provided through the Tribal Transportation Program to address the deferred maintenance backlog."

On the second line on page 53, insert "an additional" after "; and" and before "\$123,000"

Page 54, within the Bureau of Indian Affairs, strike "The recommendation includes \$67,010,000 for Minerals and Mining, as requested, and \$40,304,000 above the enacted level." and insert "The recommendation includes \$66,010,000 for Minerals and Mining, \$39,304,000 above the enacted level."

On page 79, under the heading Clean Air: (1) in the first sentence of the third paragraph, strike "understands" and insert "notes", and strike "2020." and insert "2020, and looks forward to receiving the briefing the Agency was directed to provide."; (2) insert after the last sentence: "If no updates were incorporated into MOVES3, the Committee directs the Agency to provide a subsequent report within 90 days of enactment of this Act determining if updates are necessary, and if warranted, a timeline detailing planned Agency action to carry out the necessary emission studies to integrate updated data for these vehicles."

On page 85, under the heading Clean Air: (1) strike "American Innovation and Manufacturing Act of 2020," and insert "American Innovation and Manufacturing Act of 2020 (AIM Act),"; (2) at the end of the first paragraph insert the following: "As the Agency works to implement the AIM Act, the Committee directs the Agency to make reasonable accommodations to mitigate economic impacts on affected stakeholders, including industrial manufacturers."

On page 86, under the heading Compliance, in the second paragraph: (1) strike the second sentence; and (2), strike "its rulemaking" and insert "relevant rulemakings".

On page 120, after the paragraph titled Prescribed Fire Technologies, insert the following new paragraph: "Detection of Unauthorized Drones.--The Committee notes that aircraft making air drops of fire suppressant are sometimes exposed to risks when unauthorized drones are present near the fire. Drones are often difficult to detect with personnel on the ground, particularly when heavy smoke is present, which can result in the aircraft having to potentially abort and dump its payload elsewhere. The Committee encourages the Forest Service to consider the use of technology to enhance detection of unauthorized drones near forest fires to provide pilots and ground personnel with necessary situational awareness."

On page 138 after Facilities Maintenance and before the heading Facilities Capital insert the following new paragraph: "The Committee encourages the Smithsonian to work with the National Museum of American Jewish History (NMAJH) to explore a plan for acquisition of the Museum and report back within 180 days of enactment of this Act."

Make technical changes to table beginning on page 177 to include the correct fiscal years and correct advance appropriations in budget request column.
