COMMERCE, JUSTICE, SCIENCE, AND RELATED AGENCIES APPROPRIATIONS ACT, 2026

The Commerce, Justice, Science, and Related Agencies Appropriations Act provides a total discretionary allocation of \$78.011 billion. The bill provides a non-defense discretionary total of \$71.407 billion and a defense discretionary total of \$6.604 billion.

The bill supports President Trump's agenda to rein in runaway spending by rightsizing agencies and programs and directs funding to support the fight against fentanyl, state and local law enforcement, and countering the Chinese Communist Party (CCP).

- **Refocuses Washington spending, cuts wasteful bureaucracy, and supports the implementation of President Trump's agenda by:**
 - Increasing funding for the Drug Enforcement Administration (DEA) by \$63 million to end the scourge of fentanyl and other illicit drugs, and to continue to support notable takedowns, including the co-founder of the notorious Sinaloa Cartel.
 - Reversing anti-Second Amendment overreach by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) by significantly reducing overall funding by \$40 million.

- **Bolsters our national security by:**
 - Supporting the American research enterprise to counter China's increasing investments in basic research and technology development.
 - Investing in emerging technologies, including artificial intelligence, quantum, and advanced manufacturing.
 - Supporting the critical NASA Artemis program to advance American leadership in space and counter the CCP's malign ambitions.
 - Supporting DOJ grant funding for programs that assist law enforcement in addressing the opioid crisis, support President Trump's immigration agenda, combat child exploitation, eliminate the rape kit backlog, and prevent school violence.
 - Enhancing multi-agency efforts to combat transnational organized crime and reduce the availability of illicit drugs – particularly fentanyl.

- **Supports American values and principles by:**
 - Maintaining longstanding 2nd Amendment riders, including:
 - A prohibition on the use of funds to require certain export licenses for firearms.
 - A prohibition on the use of funds to deny, or fail to act on, applications to import U.S.-origin "Curio & Relic" (C&R) firearms, parts, or ammunition.
 - A prohibition on the use of funds to deny the import of shotgun models for sporting purposes.
 - Maintaining longstanding Hyde-like pro-life riders, including a prohibition on the use of DOJ funds to pay for an abortion, except where the life of the mother would be endangered.
- **Bolstering funding for programs that support everyday Americans by:**
 - Maintaining strong support for state and local law enforcement through robust funding for Byrne JAG formula grants and Community Oriented Policing Services (COPS) Hiring grants that assist state, local, and Tribal law enforcement agencies.
 - Increasing funding for the National Weather Service to protect everyday Americans from severe weather.
 - Reducing the costs of living for everyday Americans by fostering economic growth.

DETAILED FUNDING SUMMARY

Title I - Department of Commerce

Provides a discretionary total of \$10.514 billion for the Department of Commerce.

- **International Trade Administration:** Provides \$562 million for the International Trade Administration.
- **Bureau of Industry and Security:** Provides \$235 million for the Bureau of Industry and Security to combat growing threats from the illicit export of dual-use technologies.
- **Economic Development Administration:** Provides \$466 million for the Economic Development Administration.
- **Minority Business Development Agency:** \$50 million for the Minority Business Development Agency.
- **Economic and Statistical Analysis:** Provides \$118 million for Economic and Statistical Analysis.
- **Bureau of the Census:** Provides \$1.490 billion for the Bureau of the Census.

- **National Telecommunications and Information Administration:** Provides \$51 million for the National Telecommunications and Information Administration.
- **U.S. Patent and Trademark Office:** Provides \$4.956 billion for the United States Patent and Trademark Office.
- **National Institute of Standards and Technology:** Provides \$1.847 billion for the National Institute of Standards and Technology (NIST).
- **National Oceanic and Atmospheric Administration:** Provides \$6.171 billion for the National Oceanic and Atmospheric Administration.
 - Includes \$4.540 billion for NOAA Operations, Research, and Facilities.
 - Includes \$1.577 billion for NOAA Procurement, Acquisition, and Construction.
- **Departmental Management:** Provides \$92.500 million for the Department of Commerce Departmental Management Salaries and Expenses.
- **Office of Inspector General:** Provides \$48 million for the Department of Commerce Office of Inspector General.

Title II - Department of Justice

Provides a discretionary total of \$37.049 billion for the Department of Justice.

- **Justice Operations Management Accountability:** Provides \$140 million for Salaries and Expenses.
- **Justice Information Sharing Technology:** Provides \$38.460 million for Justice Information Sharing Technology.
- **Executive Office for Immigration Review:** Provides \$800 million for the Executive Office of Immigration Review (EOIR).
- **Office of Inspector General:** Provides \$139 million for the Office of Inspector General.
- **United States Parole Commission:** Provides \$13 million for the salaries and expenses of the United States Parole Commission.
- **General Legal Activities:** Provides \$900 million for General Legal Activities.

- **Antitrust Division:** Provides \$245 million for the Antitrust Division (ATR). This appropriation is offset by estimated pre-merger filing fee collections.
- **United States Attorneys:** Provides \$2.621 billion for the Executive Office for United States Attorneys and the 94 United States Attorneys' offices.
- **United States Trustee System Fund:** Provides \$205 million for the United States Trustee Program.
- **Foreign Claims Settlement Commission:** Provides \$2.504 million for the Foreign Claims Settlement Commission.
- **Community Relations Service:** Provides \$20 million for the Community Relations Service.
- **Assets Forfeiture Fund:** Provides \$20.514 million for the Assets Forfeiture Fund.
- **United States Marshals Service, Salaries and Expenses:** Provides \$1.702 billion for the salaries and expenses of the United States Marshals Service.
- **United States Marshals Service, Construction:** Provides \$8 million for the United States Marshals Service, Construction.
- **United States Marshals Service, Federal Prisoner Detention:** Provides \$2.236 billion for Federal Prisoner Detention.
- **National Security Division:** Provides \$117.2 million for the salaries and expenses of the National Security Division.
- **Interagency Crime Drug Enforcement Task Forces:** Provides \$300 million for Interagency Drug Enforcement Task Forces to enhance multi-agency efforts to combat transnational organized crime and reduce the availability of illicit drugs.
- **Federal Bureau of Investigation:** Provides \$10.624 billion for the Federal Bureau of Investigation (FBI).
- **Drug Enforcement Administration:** Provides a direct appropriation of \$3.250 billion for the salaries and expenses of the Drug Enforcement Administration (DEA). In addition, the DEA expects to derive \$669 million from fees deposited in the Diversion Control Fund to carry out the Diversion Control Program.
- **Bureau of Alcohol, Tobacco, Firearms and Explosives:** Provides \$1.585 billion for the salaries and expenses of the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF).

- **Bureau of Prisons:** Provides \$8.382 billion for the Federal Prison System (BOP).
- **Office on Violence Against Women:** Provides a total of \$720 million for the Office on Violence Against Women.
- **Office of Justice Programs:** Provides \$3.066 billion for the Office of Justice Programs.
- **Community Oriented Policing Services:** \$800 million for Community Oriented Policing Services (COPS).

Title III – Science

Provides a discretionary total of \$33.196 billion for Science.

- **Office of Science and Technology Policy:** Provides \$7.965 million for the Office of Science and Technology Policy (OSTP).
- **National Aeronautics and Space Administration:** Provides \$24.438 billion for the National Aeronautics and Space Administration (NASA).
- **National Science Foundation:** Provides \$8.750 billion for the National Science Foundation (NSF).

Title IV – Related Agencies

Provides a discretionary total of \$1.211 billion for Related Agencies.

- **Commission on Civil Rights:** Provides \$14.350 million for the Commission on Civil Rights.
- **Equal Employment Opportunity Commission:** Provides \$435.382 million for the Equal Employment Opportunity Commission (EEOC).
- **International Trade Commission:** Provides \$122 million for the International Trade Commission.
- **Legal Services Corporation:** Provides \$540 million for the Legal Services Corporation.
- **Marine Mammal Commission:** Provides \$4.3 million for the Marine Mammal Commission.

- **Office of the United States Trade Representative:** Provides \$88 million for the Office of the U.S. Trade Representative.
