FINANCIAL SERVICES AND GENERAL GOVERNMENT APPROPRIATIONS ACT, 2026

The Financial Services and General Government Appropriations Act provides a total discretionary allocation of \$26.5 billion. The defense portion of the allocation is \$45 million, and the non-defense portion of the allocation is \$26.3 billion.

The bill delivers on President Trump's America First agenda by ending divisive, liberal Biden-era policies, restoring common sense to the federal government, and ensuring the Executive Branch has the resources it needs to execute the mandate given by the nation. The measure upholds the rights of American citizens, strengthens national security, and harnesses technology to make the federal government work smarter, faster, and more efficiently for the American people.

- Providing increased funding to Make D.C. Safe Again.
- Making federal buildings Beautiful Again.
- Ensuring scholarship process is based on merit and not political ideology.
- Supporting First Amendment rights of Americans.

- **Bolsters U.S. national security and border protections by:**
 - Fully funding the Committee on Foreign Investment in the United States to ensure it has the tools to adequately scrutinize foreign investment by countries like China.
 - Enhancing funding for Treasury's Office of Terrorism and Financial Intelligence to strengthen efforts to prevent and deter terrorists, criminals, and other bad actors from using the financial system.
 - Equipping Treasury and other agencies with tools to bolster cybersecurity and stop foreign adversaries and criminals from hacking our nation's critical infrastructure.
 - Protecting Americans from deadly drugs like fentanyl by investing in the High Intensity Drug Trafficking Area (HIDTA) program to strengthen interdiction efforts and stop narcotics from entering our borders and communities.
- **Restores fiscal sanity and protects taxpayer dollars by:**
 - Continuing important oversight of remaining COVID-era programs and funding streams to stop waste, fraud, and abuse of taxpayer dollars.
 - Taking steps to identify underutilized federal office spaces to lower costs and cut wasteful Washington spending.
 - Cutting IRS enforcement funding to rein in a supercharged agency targeting hardworking Americans, and redirects resources toward customer service and technology support so taxpayers get answers and a more streamlined tax season – not supercharged audits.
- **Enforces constitutional oversight of the District of Columbia by:**
 - Maintaining pro-life safeguards on the use of government funds.
 - Retaining the conscience clause on any D.C. contraceptive requirement.
 - Banning D.C.'s harmful and addiction-enabling needle exchange program.
 - Bolstering President Trump's "Make America Safe Again" agenda by supporting offender supervision, National Guard, law enforcement, and public safety programs in the nation's capital.
 - Empowering families to choose the educational options best suited to help their kids learn and grow through school choice support.

DETAILED FUNDING SUMMARY

Department of Treasury

Provides \$13.063 billion for the Department of Treasury.

- \$21 million for the Committee on Foreign Investment in the United States.
- \$238 million for the Office of Terrorism and Financial Intelligence.
- \$324 million for the Community Development Financial Institutions Fund.
- \$59 million for the Cyber Enhancement Account.
- \$185.193 million for the Financial Crimes Enforcement Network (FinCEN).
- \$391.109 million for the Bureau of the Fiscal Service (BFS).

Administrative Provisions:

- Prohibits the IRS from targeting individuals or groups for exercising their First Amendment rights or ideological beliefs.
- Directs the Inspector General to oversee pandemic programs like the Emergency Rental Assistance Program and COVID relief payments to states and localities.
- Requires the Secretary of the Treasury to submit a report to Congress on the Strategic Bitcoin Reserve and the digital asset stockpile within 90 days on feasibility, risks, fiscal impact, and custody.

Executive Office of the President

Provides \$872 million for the Executive Office of the President.

- \$299 million for High Intensity Drug Trafficking Areas.
- \$136.15 million for other Federal Drug Control programs.
- \$129 million for Office of Management and Budget (OMB).
- Supports the Administration's request to zero out the Intellectual Property Enforcement Coordinator, eliminating redundancies across other agencies.
- \$8 million for Information Technology Oversight and Reform (ITOR) to fund DOGE.

The Federal Judiciary

Provides \$9.69 billion in discretionary funding for the Federal Judiciary.

- \$892 million for court security, to ensure judges, their families, and employees are protected.
- \$163 million to fund the Supreme Court at their requested level, to include robust funding for the personal security of the Justices.
- Ensures funding prioritized to strengthen the Federal Judiciary's cybersecurity and information technology initiatives.
- Cuts funding for fees to jurors and commissioners by more than 65%.
- Cuts funding for care of grounds by 45%.

District of Columbia

Provides \$878 million in federal funding for the District of Columbia.

- \$90 million for the Emergency Planning and Security Fund to support Presidential Events/NSSEs in the District, including all America 250 events and the upcoming State of the Union.
- \$600,000 for Major General David F. Wherley, Jr. Retention and College Access Program to support educational goals of D.C. National Guard members.
- \$17.5 million for the D.C. Opportunity Scholarship Program, the first federally funded school voucher program in the United States, authorized by the SOAR Act.
- \$3.45 million for the Criminal Justice Coordinating Council to update their criminal database information system in support of federal and local law enforcement operations.

Consumer Product Safety Commission

Provides \$150.975 million for the Consumer Product Safety Commission.

Election Assistance Commission

Provides nearly \$24 million for the Election Assistance Commission in addition to \$45 million for election security grants.

Federal Communications Commission

Provides \$416.112 million for the Federal Communications Commission, which is funded through offsets, resulting in a net appropriation of zero dollars.

Federal Election Commission

Provides \$80.857 million for the Federal Election Commission.

Federal Trade Commission

Provides \$383.6 million for the Federal Trade Commission.

General Services Administration

Provides \$9.686 billion for the General Services Administration's Federal Buildings Fund.

- \$239 million for major repairs and alterations.
- \$479 million for basic alterations and repairs.
- \$215.55 million for Special Emphasis Programs.
- \$5.57 billion to rent space for other agencies.
- \$3.01 billion for building operations.

Office of Personnel Management

Provides \$167.535 million for salaries and expenses for the Office of Personnel Management.

Public Buildings Reform Board

Provides \$3.605 million for the Public Buildings Reform Board.

Securities and Exchange Commission

Provides \$2.149 billion for the Securities and Exchange Commission.

Small Business Administration

Provides \$1 billion for the Small Business Administration (SBA).

- \$330 million for Entrepreneurial Development programs.
- \$161 million for SBA Small Business Loans program.
- \$282 million for SBA Disaster Loan program.
- \$5.25 million for the Native American Outreach program.
- \$6.27 million for the Women-Owned Small Business program.
- \$27 million for Veterans Outreach.

United States Postal Service

Provides \$312.360 million to the United States Postal Service.

- \$38.36 million for payment to the Postal Service Fund.
- \$274 million for the United States Postal Service Office of Inspector General out of the Postal Service Fund.
