HOMELAND SECURITY APPROPRIATIONS BILL, 2027

The Homeland Security Appropriations Bill provides a total discretionary allocation of \$64.9 billion for the Department of Homeland Security (DHS), of which \$2.9 billion is provided for defense activities. The bill also includes \$6.2 billion in discretionary appropriations that are offset by fee collections and \$28.39 billion as an allocation adjustment for major disaster response and recovery activities.

The legislation includes the resources required to protect the homeland and keep American communities safe, secure, and resilient. The bill provides the necessary personnel, training, and technology to secure our air, land, and maritime borders and the nation's critical infrastructure against nation-state adversaries.

 - Ensuring no funding to non-governmental organizations that facilitated the Biden border crisis.
 - Codifying the Trump Administration's reductions to bloated federal bureaucracy.

- **Bolsters U.S. national security and border protections by:**
 - Providing \$3.8 billion for ICE custody operations to strengthen the Trump Administration’s efforts to detain and deport all criminal and removable aliens.
 - Providing \$439 million to sustain 22,000 Border Patrol agents.
 - Providing \$226 million to improve baggage screening equipment at airports.
 - Providing \$135 million to counter China by increasing the Coast Guard’s Indo-Pacific footprint.
 - Providing \$97 million for unmanned systems to improve maritime domain awareness.
- **Safeguards American taxpayer dollars and preserves core functions by:**
 - Reallocating \$100 million from previous appropriations to sustain the Cybersecurity and Infrastructure Security Agency’s (CISA) core mission functions.

DETAILED FUNDING SUMMARY

Office of the Secretary and Executive Management

Provides \$339.3 million for the Office of the Secretary and Executive Management.

- Provides no funding for the Case Management Pilot Program, which funneled taxpayer dollars to non-profits serving illegal aliens, rather than enforcing immigration law.
- Provides no funding for the Office of the Immigration Detention Ombudsman, which was previously led by Biden-era anti-ICE activists.
- \$40 million for body-worn cameras for DHS law enforcement personnel.
- \$4.8 million reduction to the Office of Civil Rights and Civil Liberties.
- \$4.5 million reduction to the Office of Citizenship and Immigration Services Ombudsman.

Management Directorate

Provides \$1.8 billion for the Management Directorate. In addition, the bill includes over \$2 billion for the Federal Protective Service, which is completely offset through fee collections for Fiscal Year 2027.

- \$70.5 million for Homeland Advanced Recognition Technology to provide and operationalize an updated biometric data system for Department-wide use.
- \$41.6 million for Financial Systems Modernization to improve internal controls and audit sustainability.
- \$15.3 million to begin operations at the Joint Processing Center in El Paso, Texas.
- \$11.3 million for enhanced cybersecurity protections.

- \$3.8 million for deployment of counter unmanned aerial systems in preparation for the 2028 Summer Olympics and Paralympics.

Intelligence, Analysis, and Situational Awareness

Provides \$355.1 million for Intelligence, Analysis, and Situational Awareness.

Office of Inspector General

Provides \$227.1 million for the Office of Inspector General.

U.S. Customs and Border Protection

Provides \$18.3 billion for U.S. Customs and Border Protection.

- \$439 million to sustain funding for 22,000 Border Patrol agents.
- \$155 million for a C-130J aircraft to support extended border security operations.
- \$88 million for workforce care and suicide prevention.
- \$77 million for Light Enforcement Platform helicopters.
- \$45 million for innovative technology.
- \$35 million for Border Patrol overtime pay.
- \$30 million for small and counter unmanned aerial system efforts.

U.S. Immigration and Customs Enforcement

Provides \$10.1 billion for U.S. Immigration and Customs Enforcement.

- \$3.8 billion for custody operations to bolster the Trump Administration's efforts to detain and deport all criminal and removable aliens.
- \$750.7 million for the transportation and removal of aliens who no longer have a legal basis to remain in this country.
- \$162.2 million for fugitive operations to sustain mobile criminal alien and special response teams tasked with executing high-stakes interior enforcement actions.
- \$2.6 billion for Homeland Security Investigations, including the following:
 - \$30 million for increased investigations related to child exploitation, forced labor, and human trafficking criminal activity;
 - \$25 million for counter-fentanyl initiatives, including for additional Border Enforcement Security Task Force teams and technologies to enhance investigative capacity; and
 - \$5 million for activities at the Cyber Crime Center.

Transportation Security Administration

Provides \$11.3 billion for the Transportation Security Administration.

- \$6.1 billion for the frontline screening workforce.
- \$226 million for computed tomography (CT) systems to screen carry-on baggage at passenger checkpoints to enhance security.
- \$45.9 million for the Law Enforcement Officer Reimbursement Program.
- \$34.1 million for canine reimbursements.
- \$26.8 million for the Federal Flight Deck Officer and Crew Training Program.

U.S. Coast Guard

Provides \$14.6 billion for the U.S. Coast Guard, including enhanced resources to modernize the Coast Guard and support surge operations to safeguard our maritime borders and promote national security.

- \$148 million for Waterways Commerce Cutters, which will allow for the efficient flow of commerce through our nation's waterways.
- \$135 million for increased operations in the Indo-Pacific to counter China.
- \$97 million for unmanned systems to improve maritime domain awareness.
- \$48 million in additional funds for deferred shore-side maintenance.
- \$30 million in a technology modernization program to enhance Coast Guard capability in autonomous surface and air assets, artificial intelligence, and data analytics.
- \$21 million in additional funds for addressing deferred cutter and boat maintenance.

U.S. Secret Service

Provides \$3.3 billion for the U.S. Secret Service.

- \$1.4 billion for protective operations, including \$96.3 million for protective intelligence activities.
- \$45.5 million for hiring additional law enforcement personnel across the Secret Service.
- \$33.6 million for National Special Security Events, including the 2028 Summer Olympic and Paralympic Games in Los Angeles.

Cybersecurity and Infrastructure Security Agency

Provides \$2.4 billion for the Cybersecurity and Infrastructure Security Agency.

- \$694 million for cyber operations, including vulnerability management, capacity building, and threat hunting to promote cybersecurity.
- \$378 million for cybersecurity assets and infrastructure that proactively respond to threats and enable continuous evaluation of our Federal and select critical infrastructure partner networks.
- \$31 million to hire mission critical positions to counter threats from foreign adversaries, such as China.
- Includes strategic reductions to redundant, unauthorized, or duplicative contracts, positions, and programs.

Federal Emergency Management Agency

Provides \$34.1 billion for the Federal Emergency Management Agency to reinforce preparedness, response, and recovery capabilities across the country.

- \$28.389 billion for the Disaster Relief Fund to support response and recovery efforts following major disasters and emergencies.
- \$3.8 billion for grant programs and education, trainings, and exercises for local and state firefighters, first responders, and emergency managers throughout American communities. Total funding includes:
 - \$702 million for Assistance to Firefighters and Staffing for Adequate Fire and Emergency Response Grants to recruit, train, and equip frontline firefighters;
 - \$315 million for the Nonprofit Security Grant Program for houses of worship and other eligible organizations at risk of a terrorist attack;
 - \$106 million for the National Domestic Preparedness Consortium to deliver critical training and technical assistance to emergency first responders; and
 - \$88 million for Operation Stonegarden to enhance cooperation and coordination among law enforcement partners to bolster the security of our borders.

U.S. Citizenship and Immigration Services

Provides \$113 million for U.S. Citizenship and Immigration Services to fund E-Verify.

Federal Law Enforcement Training Centers

Provides \$403.2 million for Federal Law Enforcement Training Centers to strengthen training capacity and enhance public safety.

- \$13.7 million for repairs and upgrades to campus facilities.
- \$11.2 million to address increased demand for law enforcement training.

Science and Technology

Provides \$855.4 million for Science and Technology that will enable DHS to obtain cutting-edge technology.

- \$50 million to research and develop an effective biological threat detection system.
- \$47 million for Centers of Excellence.
- \$10 million for critical repair/replacements at Science and Technology laboratories.

Community Project Funding

Provides \$125.2 million to fund community projects within the Federal Emergency Management Agency, including 113 projects requested by 89 House Members.

- \$76.8 million for Pre-Disaster Mitigation grants.
- \$48.4 million for Emergency Operations Center grants.
