7 12402 of title 10 or section 708 of title 32, United States  
8 Code, or while serving on duty under section 12301(d) of  
9 title 10 or section 502(f) of title 32, United States Code,  
10 in connection with performing duty specified in section  
11 12310(a) of title 10, United States Code, or while under-  
12 going training, or while performing drills or equivalent  
13 duty or other duty, and expenses authorized by section

19 OPERATION AND MAINTENANCE, ARMY

20 For expenses, not otherwise provided for, necessary  
21 for the operation and maintenance of the Army, as author-  
22 ized by law, \$34,436,295,000: *Provided*, That not to ex-  
23 ceed \$12,478,000 can be used for emergencies and ex-  
24 traordinary expenses, to be expended on the approval or  
25 authority of the Secretary of the Army, and payments may

1 be made on his certificate of necessity for confidential mili-  
2 tary purposes.

3 OPERATION AND MAINTENANCE, NAVY

4 For expenses, not otherwise provided for, necessary  
5 for the operation and maintenance of the Navy and the  
6 Marine Corps, as authorized by law, \$40,213,485,000:  
7 *Provided*, That not to exceed \$15,055,000 can be used for  
8 emergencies and extraordinary expenses, to be expended  
9 on the approval or authority of the Secretary of the Navy,  
10 and payments may be made on his certificate of necessity  
11 for confidential military purposes.

12 OPERATION AND MAINTENANCE, MARINE CORPS

13 For expenses, not otherwise provided for, necessary  
14 for the operation and maintenance of the Marine Corps,  
15 as authorized by law, \$6,246,366,000.

16 OPERATION AND MAINTENANCE, AIR FORCE

17 For expenses, not otherwise provided for, necessary  
18 for the operation and maintenance of the Air Force, as  
19 authorized by law, \$38,209,602,000: *Provided*, That not  
20 to exceed \$7,699,000 can be used for emergencies and ex-  
21 traordinary expenses, to be expended on the approval or  
22 authority of the Secretary of the Air Force, and payments  
23 may be made on his certificate of necessity for confidential  
24 military purposes.

1           OPERATION AND MAINTENANCE, DEFENSE-WIDE  
2                           (INCLUDING TRANSFER OF FUNDS)

3           For expenses, not otherwise provided for, necessary  
4 for the operation and maintenance of activities and agen-  
5 cies of the Department of Defense (other than the military  
6 departments), as authorized by law, \$32,263,224,000:  
7 *Provided*, That not more than \$15,000,000 may be used  
8 for the Combatant Commander Initiative Fund authorized  
9 under section 166a of title 10, United States Code: *Pro-*  
10 *vided further*, That not to exceed \$36,000,000 can be used  
11 for emergencies and extraordinary expenses, to be ex-  
12 pended on the approval or authority of the Secretary of  
13 Defense, and payments may be made on his certificate of  
14 necessity for confidential military purposes: *Provided fur-*  
15 *ther*, That of the funds provided under this heading, not  
16 less than \$35,045,000 shall be made available for the Pro-  
17 curement Technical Assistance Cooperative Agreement  
18 Program, of which not less than \$3,600,000 shall be avail-  
19 able for centers defined in 10 U.S.C. 2411(1)(D): *Pro-*  
20 *vided further*, That none of the funds appropriated or oth-  
21 erwise made available by this Act may be used to plan  
22 or implement the consolidation of a budget or appropria-  
23 tions liaison office of the Office of the Secretary of De-  
24 fense, the office of the Secretary of a military department,  
25 or the service headquarters of one of the Armed Forces

6 vehicles; travel and transportation; care of the dead; re-  
7 cruiting; procurement of services, supplies, and equip-  
8 ment; and communications, \$975,724,000.

11 For expenses, not otherwise provided for, necessary

16 recruiting; procurement of services, supplies, and equip-  
17 ment; and communications, \$320,066,000.

19 For expenses, not otherwise provided for, necessary  
20 for the operation and maintenance, including training, or-  
21 ganization, and administration, of the Air Force Reserve;  
22 repair of facilities and equipment; hire of passenger motor  
23 vehicles; travel and transportation; care of the dead; re-  
24 cruiting; procurement of services, supplies, and equip-  
25 ment; and communications, \$3,106,066,000.

18 For the Department of the Army, \$170,167,000, to  
19 remain available until transferred: *Provided*, That the Sec-  
20 retary of the Army shall, upon determining that such  
21 funds are required for environmental restoration, reduc-  
22 tion and recycling of hazardous waste, removal of unsafe  
23 buildings and debris of the Department of the Army, or  
24 for similar purposes, transfer the funds made available by  
25 this appropriation to other appropriations made available

1 to the Department of the Army, to be merged with and  
2 to be available for the same purposes and for the same  
3 time period as the appropriations to which transferred:  
4 *Provided further*, That upon a determination that all or  
5 part of the funds transferred from this appropriation are

3 tion and recycling of hazardous waste, removal of unsafe  
4 buildings and debris at sites formerly used by the Depart-  
5 ment of Defense, transfer the funds made available by this  
6 appropriation to other appropriations made available to  
7 the Department of the Army, to be merged with and to  
8 be available for the same purposes and for the same time  
9 period as the appropriations to which transferred: *Pro-*  
10 *vided further*, That upon a determination that all or part  
11 of the funds transferred from this appropriation are not  
12 necessary for the purposes provided herein, such amounts  
13 may be transferred back to this appropriation: *Provided*  
14 *further*, That the transfer authority provided under this

25 struction prosecuted thereon prior to approval of title; and

1 procurement and installation of equipment, appliances,  
2 and machine tools in public and private plants; reserve  
3 plant and Government and contractor-owned equipment  
4 layaway; and other expenses necessary for the foregoing  
5 purposes, \$2,244,547,000, to remain available for obliga-  
6 tion until September 30, 2019.

14 layaway, \$3,102,544,000, to remain available for obliga-  
15 tion until September 30, 2019.

18 For construction, procurement, production, and  
19 modification of ammunition, and accessories therefor; spe-  
20 cialized equipment and training devices; expansion of pub-

22 thorized by section 2854 of title 10, United States Code,

18 SEC. 8002. During the current fiscal year, provisions  
19 of law prohibiting the payment of compensation to, or em-  
20 ployment of, any person not a citizen of the United States  
21 shall not apply to personnel of the Department of Defense:  
22 *Provided*, That salary increases granted to direct and indi-  
23 rect hire foreign national employees of the Department of  
24 Defense funded by this Act shall not be at a rate in excess  
25 of the percentage increase authorized by law for civilian

1 employees of the Department of Defense whose pay is  
2 computed under the provisions of section 5332 of title 5,  
3 United States Code, or at a rate in excess of the percent-  
4 age increase provided by the appropriate host nation to  
5 its own employees, whichever is higher: *Provided further*,  
6 That this section shall not apply to Department of De-  
7 fense foreign service national employees serving at United  
8 States diplomatic missions whose pay is set by the Depart-  
9 ment of State under the Foreign Service Act of 1980: *Pro-*  
10 *vided further*, That the limitations of this provision shall  
11 not apply to foreign national employees of the Department  
12 of Defense in the Republic of Turkey.

13 SEC. 8003. No part of any appropriation contained  
14 in this Act shall remain available for obligation beyond

16 SEC. 8004. No more than 20 percent of the appro-  
17 priations in this Act which are limited for obligation dur-  
18 ing the current fiscal year shall be obligated during the  
19 last 2 months of the fiscal year: *Provided*, That this sec-  
20 tion shall not apply to obligations for support of active  
21 duty training of reserve components or summer camp  
22 training of the Reserve Officers' Training Corps.

23 (TRANSFER OF FUNDS)

24 SEC. 8005. Upon determination by the Secretary of  
25 Defense that such action is necessary in the national inter-

1 est, he may, with the approval of the Office of Manage-  
2 ment and Budget, transfer not to exceed \$4,500,000,000  
3 of working capital funds of the Department of Defense  
4 or funds made available in this Act to the Department  
5 of Defense for military functions (except military con-

20 tions for reprogramming of funds, unless for higher pri-  
21 ority items, based on unforeseen military requirements,  
22 than those for which originally appropriated and in no  
23 case where the item for which reprogramming is requested  
24 has been denied by the Congress: *Provided further*, That  
25 a request for multiple reprogrammings of funds using au-

1 thority provided in this section shall be made prior to June  
2 30, 2017: *Provided further*, That transfers among military  
3 personnel appropriations shall not be taken into account  
4 for purposes of the limitation on the amount of funds that  
5 may be transferred under this section.

6 SEC. 8006. (a) With regard to the list of specific pro-  
7 grams, projects, and activities (and the dollar amounts  
8 and adjustments to budget activities corresponding to  
9 such programs, projects, and activities) contained in the  
10 tables titled Explanation of Project Level Adjustments in  
11 the explanatory statement regarding this Act, the obliga-  
12 tion and expenditure of amounts appropriated or other-  
13 wise made available in this Act for those programs,  
14 projects, and activities for which the amounts appro-  
15 priated exceed the amounts requested are hereby required  
16 by law to be carried out in the manner provided by such

15 United States Code, may be maintained in only such  
16 amounts as are necessary at any time for cash disburse-  
17 ments to be made from such funds: *Provided*, That trans-  
18 fers may be made between such funds: *Provided further*,  
19 That transfers may be made between working capital  
20 funds and the “Foreign Currency Fluctuations, Defense”  
21 appropriation and the “Operation and Maintenance” ap-  
22 propriation accounts in such amounts as may be deter-  
23 mined by the Secretary of Defense, with the approval of  
24 the Office of Management and Budget, except that such  
25 transfers may not be made unless the Secretary of Defense

1 has notified the Congress of the proposed transfer: *Pro-*  
2 *vided further*, That except in amounts equal to the  
3 amounts appropriated to working capital funds in this Act,  
4 no obligations may be made against a working capital fund  
5 to procure or increase the value of war reserve material  
6 inventory, unless the Secretary of Defense has notified the  
7 Congress prior to any such obligation.

8       SEC. 8009. Funds appropriated by this Act may not  
9 be used to initiate a special access program without prior  
10 notification 30 calendar days in advance to the congres-  
11 sional defense committees.

12       SEC. 8010. None of the funds provided in this Act  
13 shall be available to initiate: (1) a multiyear contract that  
14 employs economic order quantity procurement in excess of  
15 \$20,000,000 in any one year of the contract or that in-  
16 cludes an unfunded contingent liability in excess of  
17 \$20,000,000; or (2) a contract for advance procurement  
18 leading to a multiyear contract that employs economic  
19 order quantity procurement in excess of \$20,000,000 in  
20 any one year, unless the congressional defense committees  
21 have been notified at least 30 days in advance of the pro-  
22 posed contract award: *Provided*, That no part of any ap-  
23 propriation contained in this Act shall be available to ini-  
24 tiate a multiyear contract for which the economic order  
25 quantity advance procurement is not funded at least to

1 the limits of the Government's liability: *Provided further*,  
2 That no part of any appropriation contained in this Act  
3 shall be available to initiate multiyear procurement con-  
4 tracts for any systems or component thereof if the value  
5 of the multiyear contract would exceed \$500,000,000 un-  
6 less specifically provided in this Act: *Provided further*,  
7 That no multiyear procurement contract can be termi-  
8 nated without 30-day prior notification to the congres-  
9 sional defense committees: *Provided further*, That the exe-  
10 cution of multiyear authority shall require the use of a  
11 present value analysis to determine lowest cost compared  
12 to an annual procurement: *Provided further*, That none of  
13 the funds provided in this Act may be used for a multiyear  
14 contract executed after the date of the enactment of this  
15 Act unless in the case of any such contract—

16           (1) the Secretary of Defense has submitted to  
17           Congress a budget request for full funding of units  
18           to be procured through the contract and, in the case  
19           of a contract for procurement of aircraft, that in-  
20           cludes, for any aircraft unit to be procured through  
21           the contract for which procurement funds are re-  
22           quested in that budget request for production be-  
23           yond advance procurement activities in the fiscal  
24           year covered by the budget, full funding of procure-  
25           ment of such unit in that fiscal year;

1           (2) cancellation provisions in the contract do  
2           not include consideration of recurring manufacturing  
3           costs of the contractor associated with the produc-  
4           tion of unfunded units to be delivered under the con-  
5           tract;

6           (3) the contract provides that payments to the  
7           contractor under the contract shall not be made in  
8           advance of incurred costs on funded units; and

9           (4) the contract does not provide for a price ad-  
10          justment based on a failure to award a follow-on  
11          contract.

12          SEC. 8011. Within the funds appropriated for the op-  
13          eration and maintenance of the Armed Forces, funds are  
14          hereby appropriated pursuant to section 401 of title 10,  
15          United States Code, for humanitarian and civic assistance  
16          costs under chapter 20 of title 10, United States Code.  
17          Such funds may also be obligated for humanitarian and  
18          civic assistance costs incidental to authorized operations  
19          and pursuant to authority granted in section 401 of chap-  
20          ter 20 of title 10, United States Code, and these obliga-  
21          tions shall be reported as required by section 401(d) of  
22          title 10, United States Code: *Provided*, That funds avail-  
23          able for operation and maintenance shall be available for  
24          providing humanitarian and similar assistance by using  
25          Civic Action Teams in the Trust Territories of the Pacific

1 Islands and freely associated states of Micronesia, pursu-  
2 ant to the Compact of Free Association as authorized by  
3 Public Law 99–239: *Provided further*, That upon a deter-  
4 mination by the Secretary of the Army that such action  
5 is beneficial for graduate medical education programs con-  
6 ducted at Army medical facilities located in Hawaii, the  
7 Secretary of the Army may authorize the provision of med-  
8 ical services at such facilities and transportation to such  
9 facilities, on a nonreimbursable basis, for civilian patients  
10 from American Samoa, the Commonwealth of the North-  
11 ern Mariana Islands, the Marshall Islands, the Federated  
12 States of Micronesia, Palau, and Guam.

13       SEC. 8012. (a) During fiscal year 2017, the civilian  
14 personnel of the Department of Defense may not be man-  
15 aged on the basis of any end-strength, and the manage-  
16 ment of such personnel during that fiscal year shall not  
17 be subject to any constraint or limitation (known as an  
18 end-strength) on the number of such personnel who may  
19 be employed on the last day of such fiscal year.

20       (b) The fiscal year 2018 budget request for the De-  
21 partment of Defense as well as all justification material  
22 and other documentation supporting the fiscal year 2018  
23 Department of Defense budget request shall be prepared  
24 and submitted to the Congress as if subsections (a) and

1 (b) of this provision were effective with regard to fiscal  
2 year 2018.

3 (c) As required by section 1107 of the National De-  
4 fense Authorization Act for Fiscal Year 2014 (Public Law  
5 113–66; 10 U.S.C. 2358 note) civilian personnel at the  
6 Department of Army Science and Technology Reinvention  
7 Laboratories may not be managed on the basis of the  
8 Table of Distribution and Allowances, and the manage-  
9 ment of the workforce strength shall be done in a manner  
10 consistent with the budget available with respect to such  
11 Laboratories.

12 (d) Nothing in this section shall be construed to apply  
13 to military (civilian) technicians.

14 SEC. 8013. None of the funds made available by this  
15 Act shall be used in any way, directly or indirectly, to in-  
16 fluence congressional action on any legislation or appro-  
17 priation matters pending before the Congress.

18 SEC. 8014. None of the funds appropriated by this  
19 Act shall be available for the basic pay and allowances of  
20 any member of the Army participating as a full-time stu-  
21 dent and receiving benefits paid by the Secretary of Vet-  
22 erans Affairs from the Department of Defense Education  
23 Benefits Fund when time spent as a full-time student is  
24 credited toward completion of a service commitment: *Pro-*  
25 *vided*, That this section shall not apply to those members

1 who have reenlisted with this option prior to October 1,  
2 1987: *Provided further*, That this section applies only to  
3 active components of the Army.

4 (TRANSFER OF FUNDS)

5 SEC. 8015. Funds appropriated in title III of this Act  
6 for the Department of Defense Pilot Mentor-Protege Pro-  
7 gram may be transferred to any other appropriation con-  
8 tained in this Act solely for the purpose of implementing  
9 a Mentor-Protege Program developmental assistance  
10 agreement pursuant to section 831 of the National De-  
11 fense Authorization Act for Fiscal Year 1991 (Public Law  
12 101–510; 10 U.S.C. 2302 note), as amended, under the  
13 authority of this provision or any other transfer authority  
14 contained in this Act.

15 SEC. 8016. None of the funds in this Act may be  
16 available for the purchase by the Department of Defense  
17 (and its departments and agencies) of welded shipboard  
18 anchor and mooring chain 4 inches in diameter and under  
19 unless the anchor and mooring chain are manufactured  
20 in the United States from components which are substan-  
21 tially manufactured in the United States: *Provided*, That  
22 for the purpose of this section, the term “manufactured”  
23 shall include cutting, heat treating, quality control, testing  
24 of chain and welding (including the forging and shot blast-  
25 ing process): *Provided further*, That for the purpose of this

1 section substantially all of the components of anchor and  
2 mooring chain shall be considered to be produced or manu-  
3 factured in the United States if the aggregate cost of the  
4 components produced or manufactured in the United  
5 States exceeds the aggregate cost of the components pro-  
6 duced or manufactured outside the United States: *Pro-*  
7 *vided further*, That when adequate domestic supplies are  
8 not available to meet Department of Defense requirements  
9 on a timely basis, the Secretary of the service responsible  
10 for the procurement may waive this restriction on a case-  
11 by-case basis by certifying in writing to the Committees  
12 on Appropriations that such an acquisition must be made  
13 in order to acquire capability for national security pur-  
14 poses.

15 SEC. 8017. None of the funds available to the De-  
16 partment of Defense may be used to demilitarize or dis-  
17 pose of M-1 Carbines, M-1 Garand rifles, M-14 rifles,  
18 .22 caliber rifles, .30 caliber rifles, or M-1911 pistols, or  
19 to demilitarize or destroy small arms ammunition or am-  
20 munition components that are not otherwise prohibited  
21 from commercial sale under Federal law, unless the small  
22 arms ammunition or ammunition components are certified  
23 by the Secretary of the Army or designee as unserviceable  
24 or unsafe for further use.

1       SEC. 8018. No more than \$500,000 of the funds ap-  
2       propriated or made available in this Act shall be used dur-  
3       ing a single fiscal year for any single relocation of an orga-  
4       nization, unit, activity or function of the Department of  
5       Defense into or within the National Capital Region: *Pro-*  
6       *vided*, That the Secretary of Defense may waive this re-  
7       striction on a case-by-case basis by certifying in writing  
8       to the congressional defense committees that such a relo-  
9       cation is required in the best interest of the Government.

10       SEC. 8019. Of the funds made available in this Act,  
11       \$15,000,000 shall be available for incentive payments au-  
12       thorized by section 504 of the Indian Financing Act of  
13       1974 (25 U.S.C. 1544): *Provided*, That a prime contractor  
14       or a subcontractor at any tier that makes a subcontract  
15       award to any subcontractor or supplier as defined in sec-  
16       tion 1544 of title 25, United States Code, or a small busi-  
17       ness owned and controlled by an individual or individuals  
18       defined under section 4221(9) of title 25, United States  
19       Code, shall be considered a contractor for the purposes  
20       of being allowed additional compensation under section  
21       504 of the Indian Financing Act of 1974 (25 U.S.C.  
22       1544) whenever the prime contract or subcontract amount  
23       is over \$500,000 and involves the expenditure of funds  
24       appropriated by an Act making appropriations for the De-  
25       partment of Defense with respect to any fiscal year: *Pro-*

1 *vided further*, That notwithstanding section 1906 of title  
2 41, United States Code, this section shall be applicable  
3 to any Department of Defense acquisition of supplies or  
4 services, including any contract and any subcontract at  
5 any tier for acquisition of commercial items produced or  
6 manufactured, in whole or in part, by any subcontractor  
7 or supplier defined in section 1544 of title 25, United  
8 States Code, or a small business owned and controlled by  
9 an individual or individuals defined under section 4221(9)  
10 of title 25, United States Code.

11 SEC. 8020. Funds appropriated by this Act for the  
12 Defense Media Activity shall not be used for any national  
13 or international political or psychological activities.

14 SEC. 8021. During the current fiscal year, the De-  
15 partment of Defense is authorized to incur obligations of  
16 not to exceed \$350,000,000 for purposes specified in sec-  
17 tion 2350j(c) of title 10, United States Code, in anticipa-  
18 tion of receipt of contributions, only from the Government  
19 of Kuwait, under that section: *Provided*, That, upon re-  
20 ceipt, such contributions from the Government of Kuwait  
21 shall be credited to the appropriations or fund which in-  
22 curred such obligations.

23 SEC. 8022. (a) Of the funds made available in this  
24 Act, not less than \$40,021,000 shall be available for the  
25 Civil Air Patrol Corporation, of which—

1           (1) \$28,000,000 shall be available from “Oper-  
2           ation and Maintenance, Air Force” to support Civil  
3           Air Patrol Corporation operation and maintenance,  
4           readiness, counter-drug activities, and drug demand  
5           reduction activities involving youth programs;

6           (2) \$10,337,000 shall be available from “Air-  
7           craft Procurement, Air Force”; and

8           (3) \$1,684,000 shall be available from “Other  
9           Procurement, Air Force” for vehicle procurement.

10          (b) The Secretary of the Air Force should waive reim-  
11          bursement for any funds used by the Civil Air Patrol for  
12          counter-drug activities in support of Federal, State, and  
13          local government agencies.

14          SEC. 8023. (a) None of the funds appropriated in this  
15          Act are available to establish a new Department of De-  
16          fense (department) federally funded research and develop-  
17          ment center (FFRDC), either as a new entity, or as a  
18          separate entity administrated by an organization man-  
19          aging another FFRDC, or as a nonprofit membership cor-  
20          poration consisting of a consortium of other FFRDCs and  
21          other nonprofit entities.

22          (b) No member of a Board of Directors, Trustees,  
23          Overseers, Advisory Group, Special Issues Panel, Visiting  
24          Committee, or any similar entity of a defense FFRDC,  
25          and no paid consultant to any defense FFRDC, except

1 when acting in a technical advisory capacity, may be com-  
2 pensated for his or her services as a member of such enti-  
3 ty, or as a paid consultant by more than one FFRDC in  
4 a fiscal year: *Provided*, That a member of any such entity  
5 referred to previously in this subsection shall be allowed  
6 travel expenses and per diem as authorized under the Fed-  
7 eral Joint Travel Regulations, when engaged in the per-  
8 formance of membership duties.

9 (c) Notwithstanding any other provision of law, none  
10 of the funds available to the department from any source  
11 during the current fiscal year may be used by a defense  
12 FFRDC, through a fee or other payment mechanism, for  
13 construction of new buildings not located on a military in-  
14 stallation, for payment of cost sharing for projects funded  
15 by Government grants, for absorption of contract over-  
16 runs, or for certain charitable contributions, not to include  
17 employee participation in community service and/or devel-  
18 opment: *Provided*, That up to 1 percent of funds provided  
19 in this Act for support of defense FFRDCs may be used  
20 for planning and design of scientific or engineering facili-  
21 ties: *Provided further*, That the Secretary of Defense shall  
22 notify the congressional defense committees 15 days in ad-  
23 vance of exercising the authority in the previous proviso.

24 (d) Notwithstanding any other provision of law, of  
25 the funds available to the department during fiscal year

1 2017, not more than 5,750 staff years of technical effort  
2 (staff years) may be funded for defense FFRDCs: *Pro-*  
3 *vided*, That, of the specific amount referred to previously  
4 in this subsection, not more than 1,125 staff years may  
5 be funded for the defense studies and analysis FFRDCs:  
6 *Provided further*, That this subsection shall not apply to  
7 staff years funded in the National Intelligence Program  
8 (NIP) and the Military Intelligence Program (MIP).

9 (e) The Secretary of Defense shall, with the submis-  
10 sion of the department's fiscal year 2018 budget request,  
11 submit a report presenting the specific amounts of staff  
12 years of technical effort to be allocated for each defense  
13 FFRDC during that fiscal year and the associated budget  
14 estimates.

15 (f) Notwithstanding any other provision of this Act,  
16 the total amount appropriated in this Act for FFRDCs  
17 is hereby reduced by \$126,800,000.

18 SEC. 8024. None of the funds appropriated or made  
19 available in this Act shall be used to procure carbon, alloy,  
20 or armor steel plate for use in any Government-owned fa-  
21 cility or property under the control of the Department of  
22 Defense which were not melted and rolled in the United  
23 States or Canada: *Provided*, That these procurement re-  
24 strictions shall apply to any and all Federal Supply Class  
25 9515, American Society of Testing and Materials (ASTM)

1 or American Iron and Steel Institute (AISI) specifications  
2 of carbon, alloy or armor steel plate: *Provided further*,  
3 That the Secretary of the military department responsible  
4 for the procurement may waive this restriction on a case-  
5 by-case basis by certifying in writing to the Committees  
6 on Appropriations of the House of Representatives and the  
7 Senate that adequate domestic supplies are not available  
8 to meet Department of Defense requirements on a timely  
9 basis and that such an acquisition must be made in order  
10 to acquire capability for national security purposes: *Pro-*  
11 *vided further*, That these restrictions shall not apply to  
12 contracts which are in being as of the date of the enact-  
13 ment of this Act.

14 SEC. 8025. For the purposes of this Act, the term  
15 “congressional defense committees” means the Armed  
16 Services Committee of the House of Representatives, the  
17 Armed Services Committee of the Senate, the Sub-  
18 committee on Defense of the Committee on Appropriations  
19 of the Senate, and the Subcommittee on Defense of the  
20 Committee on Appropriations of the House of Representa-  
21 tives.

22 SEC. 8026. During the current fiscal year, the De-  
23 partment of Defense may acquire the modification, depot  
24 maintenance and repair of aircraft, vehicles and vessels  
25 as well as the production of components and other De-

1 fense-related articles, through competition between De-  
2 partment of Defense depot maintenance activities and pri-  
3 vate firms: *Provided*, That the Senior Acquisition Execu-  
4 tive of the military department or Defense Agency con-  
5 cerned, with power of delegation, shall certify that success-  
6 ful bids include comparable estimates of all direct and in-  
7 direct costs for both public and private bids: *Provided fur-*  
8 *ther*, That Office of Management and Budget Circular A-  
9 76 shall not apply to competitions conducted under this  
10 section.

11 SEC. 8027. (a)(1) If the Secretary of Defense, after  
12 consultation with the United States Trade Representative,  
13 determines that a foreign country which is party to an  
14 agreement described in paragraph (2) has violated the  
15 terms of the agreement by discriminating against certain  
16 types of products produced in the United States that are  
17 covered by the agreement, the Secretary of Defense shall  
18 rescind the Secretary's blanket waiver of the Buy Amer-  
19 ican Act with respect to such types of products produced  
20 in that foreign country.

21 (2) An agreement referred to in paragraph (1) is any  
22 reciprocal defense procurement memorandum of under-  
23 standing, between the United States and a foreign country  
24 pursuant to which the Secretary of Defense has prospec-

1 tively waived the Buy American Act for certain products  
2 in that country.

3 (b) The Secretary of Defense shall submit to the Con-  
4 gress a report on the amount of Department of Defense  
5 purchases from foreign entities in fiscal year 2017. Such  
6 report shall separately indicate the dollar value of items  
7 for which the Buy American Act was waived pursuant to  
8 any agreement described in subsection (a)(2), the Trade  
9 Agreement Act of 1979 (19 U.S.C. 2501 et seq.), or any  
10 international agreement to which the United States is a  
11 party.

12 (c) For purposes of this section, the term “Buy  
13 American Act” means chapter 83 of title 41, United  
14 States Code.

15 SEC. 8028. During the current fiscal year, amounts  
16 contained in the Department of Defense Overseas Military  
17 Facility Investment Recovery Account established by sec-  
18 tion 2921(c)(1) of the National Defense Authorization Act  
19 of 1991 (Public Law 101–510; 10 U.S.C. 2687 note) shall  
20 be available until expended for the payments specified by  
21 section 2921(c)(2) of that Act.

22 SEC. 8029. (a) Notwithstanding any other provision  
23 of law, the Secretary of the Air Force may convey at no  
24 cost to the Air Force, without consideration, to Indian  
25 tribes located in the States of Nevada, Idaho, North Da-

1 kota, South Dakota, Montana, Oregon, Minnesota, and  
2 Washington relocatable military housing units located at  
3 Grand Forks Air Force Base, Malmstrom Air Force Base,  
4 Mountain Home Air Force Base, Ellsworth Air Force  
5 Base, and Minot Air Force Base that are excess to the  
6 needs of the Air Force.

7 (b) The Secretary of the Air Force shall convey, at  
8 no cost to the Air Force, military housing units under sub-  
9 section (a) in accordance with the request for such units  
10 that are submitted to the Secretary by the Operation  
11 Walking Shield Program on behalf of Indian tribes located  
12 in the States of Nevada, Idaho, North Dakota, South Da-  
13 kota, Montana, Oregon, Minnesota, and Washington. Any  
14 such conveyance shall be subject to the condition that the  
15 housing units shall be removed within a reasonable period  
16 of time, as determined by the Secretary.

17 (c) The Operation Walking Shield Program shall re-  
18 solve any conflicts among requests of Indian tribes for  
19 housing units under subsection (a) before submitting re-  
20 quests to the Secretary of the Air Force under subsection  
21 (b).

22 (d) In this section, the term “Indian tribe” means  
23 any recognized Indian tribe included on the current list  
24 published by the Secretary of the Interior under section  
25 104 of the Federally Recognized Indian Tribe Act of 1994

1 (Public Law 103–454; 108 Stat. 4792; 25 U.S.C. 479a-  
2 1).

3 SEC. 8030. During the current fiscal year, appropria-  
4 tions which are available to the Department of Defense  
5 for operation and maintenance may be used to purchase  
6 items having an investment item unit cost of not more  
7 than \$250,000.

8 SEC. 8031. None of the funds made available by this  
9 Act may be used to—

10 (1) disestablish, or prepare to disestablish, a  
11 Senior Reserve Officers’ Training Corps program in  
12 accordance with Department of Defense Instruction  
13 Number 1215.08, dated June 26, 2006; or

14 (2) close, downgrade from host to extension  
15 center, or place on probation a Senior Reserve Offi-  
16 cers’ Training Corps program in accordance with the  
17 information paper of the Department of the Army  
18 titled “Army Senior Reserve Officers’ Training  
19 Corps (SROTC) Program Review and Criteria”,  
20 dated January 27, 2014.

21 SEC. 8032. The Secretary of Defense shall issue reg-  
22 ulations to prohibit the sale of any tobacco or tobacco-  
23 related products in military resale outlets in the United  
24 States, its territories and possessions at a price below the  
25 most competitive price in the local community: *Provided,*

1 That such regulations shall direct that the prices of to-  
2 bacco or tobacco-related products in overseas military re-  
3 tail outlets shall be within the range of prices established  
4 for military retail system stores located in the United  
5 States.

6 SEC. 8033. (a) During the current fiscal year, none  
7 of the appropriations or funds available to the Department  
8 of Defense Working Capital Funds shall be used for the  
9 purchase of an investment item for the purpose of acquir-  
10 ing a new inventory item for sale or anticipated sale dur-  
11 ing the current fiscal year or a subsequent fiscal year to  
12 customers of the Department of Defense Working Capital  
13 Funds if such an item would not have been chargeable  
14 to the Department of Defense Business Operations Fund  
15 during fiscal year 1994 and if the purchase of such an  
16 investment item would be chargeable during the current  
17 fiscal year to appropriations made to the Department of  
18 Defense for procurement.

19 (b) The fiscal year 2018 budget request for the De-  
20 partment of Defense as well as all justification material  
21 and other documentation supporting the fiscal year 2018  
22 Department of Defense budget shall be prepared and sub-  
23 mitted to the Congress on the basis that any equipment  
24 which was classified as an end item and funded in a pro-  
25 curement appropriation contained in this Act shall be

1 budgeted for in a proposed fiscal year 2018 procurement  
2 appropriation and not in the supply management business  
3 area or any other area or category of the Department of  
4 Defense Working Capital Funds.

5       SEC. 8034. None of the funds appropriated by this  
6 Act for programs of the Central Intelligence Agency shall  
7 remain available for obligation beyond the current fiscal  
8 year, except for funds appropriated for the Reserve for  
9 Contingencies, which shall remain available until Sep-  
10 tember 30, 2018: *Provided*, That funds appropriated,  
11 transferred, or otherwise credited to the Central Intel-  
12 ligence Agency Central Services Working Capital Fund  
13 during this or any prior or subsequent fiscal year shall  
14 remain available until expended: *Provided further*, That  
15 any funds appropriated or transferred to the Central Intel-  
16 ligence Agency for advanced research and development ac-  
17 quisition, for agent operations, and for covert action pro-  
18 grams authorized by the President under section 503 of  
19 the National Security Act of 1947 (50 U.S.C. 3093) shall  
20 remain available until September 30, 2018.

21       SEC. 8035. Notwithstanding any other provision of  
22 law, funds made available in this Act for the Defense In-  
23 telligence Agency may be used for the design, develop-  
24 ment, and deployment of General Defense Intelligence  
25 Program intelligence communications and intelligence in-

1 formation systems for the Services, the Unified and Speci-  
2 fied Commands, and the component commands.

3 SEC. 8036. Of the funds appropriated to the Depart-  
4 ment of Defense under the heading “Operation and Main-  
5 tenance, Defense-Wide”, not less than \$12,000,000 shall  
6 be made available only for the mitigation of environmental  
7 impacts, including training and technical assistance to  
8 tribes, related administrative support, the gathering of in-  
9 formation, documenting of environmental damage, and de-  
10 veloping a system for prioritization of mitigation and cost  
11 to complete estimates for mitigation, on Indian lands re-  
12 sulting from Department of Defense activities.

13 SEC. 8037. (a) None of the funds appropriated in this  
14 Act may be expended by an entity of the Department of  
15 Defense unless the entity, in expending the funds, com-  
16 plies with the Buy American Act. For purposes of this  
17 subsection, the term “Buy American Act” means chapter  
18 83 of title 41, United States Code.

19 (b) If the Secretary of Defense determines that a per-  
20 son has been convicted of intentionally affixing a label  
21 bearing a “Made in America” inscription to any product  
22 sold in or shipped to the United States that is not made  
23 in America, the Secretary shall determine, in accordance  
24 with section 2410f of title 10, United States Code, wheth-

1 er the person should be debarred from contracting with  
2 the Department of Defense.

3 (c) In the case of any equipment or products pur-  
4 chased with appropriations provided under this Act, it is  
5 the sense of the Congress that any entity of the Depart-  
6 ment of Defense, in expending the appropriation, purchase  
7 only American-made equipment and products, provided  
8 that American-made equipment and products are cost-  
9 competitive, quality competitive, and available in a timely  
10 fashion.

11 SEC. 8038. None of the funds appropriated by this  
12 Act and hereafter shall be available for a contract for stud-  
13 ies, analysis, or consulting services entered into without  
14 competition on the basis of an unsolicited proposal unless  
15 the head of the activity responsible for the procurement  
16 determines—

17 (1) as a result of thorough technical evaluation,  
18 only one source is found fully qualified to perform  
19 the proposed work;

20 (2) the purpose of the contract is to explore an  
21 unsolicited proposal which offers significant sci-  
22 entific or technological promise, represents the prod-  
23 uct of original thinking, and was submitted in con-  
24 fidence by one source; or

1           (3) the purpose of the contract is to take ad-  
2 vantage of unique and significant industrial accom-  
3 plishment by a specific concern, or to insure that a  
4 new product or idea of a specific concern is given fi-  
5 nancial support: *Provided*, That this limitation shall  
6 not apply to contracts in an amount of less than  
7 \$25,000, contracts related to improvements of equip-  
8 ment that is in development or production, or con-  
9 tracts as to which a civilian official of the Depart-  
10 ment of Defense, who has been confirmed by the  
11 Senate, determines that the award of such contract  
12 is in the interest of the national defense.

13       SEC. 8039. (a) Except as provided in subsections (b)  
14 and (c), none of the funds made available by this Act may  
15 be used—

16           (1) to establish a field operating agency; or

17           (2) to pay the basic pay of a member of the  
18 Armed Forces or civilian employee of the depart-  
19 ment who is transferred or reassigned from a head-  
20 quarters activity if the member or employee's place  
21 of duty remains at the location of that headquarters.

22       (b) The Secretary of Defense or Secretary of a mili-  
23 tary department may waive the limitations in subsection  
24 (a), on a case-by-case basis, if the Secretary determines,  
25 and certifies to the Committees on Appropriations of the

1 House of Representatives and the Senate that the grant-  
2 ing of the waiver will reduce the personnel requirements  
3 or the financial requirements of the department.

4 (c) This section does not apply to—

5 (1) field operating agencies funded within the  
6 National Intelligence Program;

7 (2) an Army field operating agency established  
8 to eliminate, mitigate, or counter the effects of im-  
9 proved explosive devices, and, as determined by the  
10 Secretary of the Army, other similar threats;

11 (3) an Army field operating agency established  
12 to improve the effectiveness and efficiencies of bio-  
13 metric activities and to integrate common biometric  
14 technologies throughout the Department of Defense;  
15 or

16 (4) an Air Force field operating agency estab-  
17 lished to administer the Air Force Mortuary Affairs  
18 Program and Mortuary Operations for the Depart-  
19 ment of Defense and authorized Federal entities.

20 SEC. 8040. (a) None of the funds appropriated by  
21 this Act shall be available to convert to contractor per-  
22 formance an activity or function of the Department of De-  
23 fense that, on or after the date of the enactment of this  
24 Act, is performed by Department of Defense civilian em-  
25 ployees unless—

1           (1) the conversion is based on the result of a  
2 public-private competition that includes a most effi-  
3 cient and cost effective organization plan developed  
4 by such activity or function;

5           (2) the Competitive Sourcing Official deter-  
6 mines that, over all performance periods stated in  
7 the solicitation of offers for performance of the ac-  
8 tivity or function, the cost of performance of the ac-  
9 tivity or function by a contractor would be less costly  
10 to the Department of Defense by an amount that  
11 equals or exceeds the lesser of—

12                   (A) 10 percent of the most efficient organi-  
13 zation's personnel-related costs for performance  
14 of that activity or function by Federal employ-  
15 ees; or

16                   (B) \$10,000,000; and

17           (3) the contractor does not receive an advan-  
18 tage for a proposal that would reduce costs for the  
19 Department of Defense by—

20                   (A) not making an employer-sponsored  
21 health insurance plan available to the workers  
22 who are to be employed in the performance of  
23 that activity or function under the contract; or

24                   (B) offering to such workers an employer-  
25 sponsored health benefits plan that requires the

1 employer to contribute less towards the pre-  
2 mium or subscription share than the amount  
3 that is paid by the Department of Defense for  
4 health benefits for civilian employees under  
5 chapter 89 of title 5, United States Code.

6 (b)(1) The Department of Defense, without regard  
7 to subsection (a) of this section or subsection (a), (b), or  
8 (c) of section 2461 of title 10, United States Code, and  
9 notwithstanding any administrative regulation, require-  
10 ment, or policy to the contrary shall have full authority  
11 to enter into a contract for the performance of any com-  
12 mercial or industrial type function of the Department of  
13 Defense that—

14 (A) is included on the procurement list estab-  
15 lished pursuant to section 2 of the Javits-Wagner-  
16 O'Day Act (section 8503 of title 41, United States  
17 Code);

18 (B) is planned to be converted to performance  
19 by a qualified nonprofit agency for the blind or by  
20 a qualified nonprofit agency for other severely handi-  
21 capped individuals in accordance with that Act; or

22 (C) is planned to be converted to performance  
23 by a qualified firm under at least 51 percent owner-  
24 ship by an Indian tribe, as defined in section 4(e)  
25 of the Indian Self-Determination and Education As-

19          SEC. 8042. None of the funds available in this Act  
20 may be used to reduce the authorized positions for mili-  
21 tary technicians (dual status) of the Army National  
22 Guard, Air National Guard, Army Reserve and Air Force  
23 Reserve for the purpose of applying any administratively  
24 imposed civilian personnel ceiling, freeze, or reduction on  
25 military technicians (dual status), unless such reductions

1 are a direct result of a reduction in military force struc-  
2 ture.

3 SEC. 8043. None of the funds appropriated or other-  
4 wise made available in this Act may be obligated or ex-  
5 pended for assistance to the Democratic People's Republic  
6 of Korea unless specifically appropriated for that purpose.

7 SEC. 8044. Funds appropriated in this Act for oper-  
8 ation and maintenance of the Military Departments, Com-  
9 batant Commands and Defense Agencies shall be available  
10 for reimbursement of pay, allowances and other expenses  
11 which would otherwise be incurred against appropriations  
12 for the National Guard and Reserve when members of the  
13 National Guard and Reserve provide intelligence or coun-  
14 terintelligence support to Combatant Commands, Defense  
15 Agencies and Joint Intelligence Activities, including the  
16 activities and programs included within the National Intel-  
17 ligence Program and the Military Intelligence Program:  
18 *Provided*, That nothing in this section authorizes deviation  
19 from established Reserve and National Guard personnel  
20 and training procedures.

21 SEC. 8045. (a) None of the funds available to the  
22 Department of Defense for any fiscal year for drug inter-  
23 diction or counter-drug activities may be transferred to  
24 any other department or agency of the United States ex-  
25 cept as specifically provided in an appropriations law.

1 (b) None of the funds available to the Central Intel-  
2 ligence Agency for any fiscal year for drug interdiction or  
3 counter-drug activities may be transferred to any other de-  
4 partment or agency of the United States except as specifi-  
5 cally provided in an appropriations law.

6 SEC. 8046. None of the funds appropriated by this  
7 Act may be used for the procurement of ball and roller  
8 bearings other than those produced by a domestic source  
9 and of domestic origin: *Provided*, That the Secretary of  
10 the military department responsible for such procurement  
11 may waive this restriction on a case-by-case basis by certi-  
12 fying in writing to the Committees on Appropriations of  
13 the House of Representatives and the Senate, that ade-  
14 quate domestic supplies are not available to meet Depart-  
15 ment of Defense requirements on a timely basis and that  
16 such an acquisition must be made in order to acquire ca-  
17 pability for national security purposes: *Provided further*,  
18 That this restriction shall not apply to the purchase of  
19 “commercial items”, as defined by section 103 of title 41,  
20 United States Code, except that the restriction shall apply  
21 to ball or roller bearings purchased as end items.

22 SEC. 8047. None of the funds made available by this  
23 Act for Evolved Expendable Launch Vehicle service com-  
24 petitive procurements may be used unless the competitive  
25 procurements are open for award to all certified providers

1 of Evolved Expendable Launch Vehicle-class systems: *Pro-*  
2 *vided*, That the award shall be made to the provider that  
3 offers the best value to the government.

4 SEC. 8048. In addition to the amounts appropriated  
5 or otherwise made available elsewhere in this Act,  
6 \$44,000,000 is hereby appropriated to the Department of  
7 Defense: *Provided*, That upon the determination of the  
8 Secretary of Defense that it shall serve the national inter-  
9 est, the Secretary shall make grants in the amounts speci-  
10 fied as follows: \$20,000,000 to the United Service Organi-  
11 zations and \$24,000,000 to the Red Cross.

12 SEC. 8049. None of the funds in this Act may be  
13 used to purchase any supercomputer which is not manu-  
14 factured in the United States, unless the Secretary of De-  
15 fense certifies to the congressional defense committees  
16 that such an acquisition must be made in order to acquire  
17 capability for national security purposes that is not avail-  
18 able from United States manufacturers.

19 SEC. 8050. Notwithstanding any other provision in  
20 this Act, the Small Business Innovation Research program  
21 and the Small Business Technology Transfer program set-  
22 asides shall be taken proportionally from all programs,  
23 projects, or activities to the extent they contribute to the  
24 extramural budget.

1       SEC. 8051. None of the funds available to the De-  
2       partment of Defense under this Act shall be obligated or  
3       expended to pay a contractor under a contract with the  
4       Department of Defense for costs of any amount paid by  
5       the contractor to an employee when—

6               (1) such costs are for a bonus or otherwise in  
7       excess of the normal salary paid by the contractor  
8       to the employee; and

9               (2) such bonus is part of restructuring costs as-  
10      sociated with a business combination.

11               (INCLUDING TRANSFER OF FUNDS)

12      SEC. 8052. During the current fiscal year, no more  
13      than \$30,000,000 of appropriations made in this Act  
14      under the heading “Operation and Maintenance, Defense-  
15      Wide” may be transferred to appropriations available for  
16      the pay of military personnel, to be merged with, and to  
17      be available for the same time period as the appropriations  
18      to which transferred, to be used in support of such per-  
19      sonnel in connection with support and services for eligible  
20      organizations and activities outside the Department of De-  
21      fense pursuant to section 2012 of title 10, United States  
22      Code.

23      SEC. 8053. During the current fiscal year, in the case  
24      of an appropriation account of the Department of Defense  
25      for which the period of availability for obligation has ex-

1   pired or which has closed under the provisions of section  
2   1552 of title 31, United States Code, and which has a  
3   negative unliquidated or unexpended balance, an obliga-  
4   tion or an adjustment of an obligation may be charged  
5   to any current appropriation account for the same purpose  
6   as the expired or closed account if—

7           (1) the obligation would have been properly  
8           chargeable (except as to amount) to the expired or  
9           closed account before the end of the period of avail-  
10          ability or closing of that account;

11          (2) the obligation is not otherwise properly  
12          chargeable to any current appropriation account of  
13          the Department of Defense; and

14          (3) in the case of an expired account, the obli-  
15          gation is not chargeable to a current appropriation  
16          of the Department of Defense under the provisions  
17          of section 1405(b)(8) of the National Defense Au-  
18          thorization Act for Fiscal Year 1991, Public Law  
19          101–510, as amended (31 U.S.C. 1551 note): *Pro-*  
20          *vided*, That in the case of an expired account, if sub-  
21          sequent review or investigation discloses that there  
22          was not in fact a negative unliquidated or unex-  
23          pended balance in the account, any charge to a cur-  
24          rent account under the authority of this section shall  
25          be reversed and recorded against the expired ac-

1 count: *Provided further*, That the total amount  
2 charged to a current appropriation under this sec-  
3 tion may not exceed an amount equal to 1 percent  
4 of the total appropriation for that account.

5 SEC. 8054. (a) Notwithstanding any other provision  
6 of law, the Chief of the National Guard Bureau may per-  
7 mit the use of equipment of the National Guard Distance  
8 Learning Project by any person or entity on a space-avail-  
9 able, reimbursable basis. The Chief of the National Guard  
10 Bureau shall establish the amount of reimbursement for  
11 such use on a case-by-case basis.

12 (b) Amounts collected under subsection (a) shall be  
13 credited to funds available for the National Guard Dis-  
14 tance Learning Project and be available to defray the costs  
15 associated with the use of equipment of the project under

18 SEC. 8055. None of the funds available to the De-

23 the command and control relationships which existed on  
24 October 1, 2004, shall remain in force unless changes are  
25 specifically authorized in a subsequent Act: *Provided fur-*

1 *ther*, That this section does not apply to administrative  
2 control of Navy Air and Missile Defense Command.

3 (INCLUDING TRANSFER OF FUNDS)

4 SEC. 8056. Of the funds appropriated in this Act  
5 under the heading “Operation and Maintenance, Defense-  
6 wide”, \$25,000,000 shall be for continued implementation  
7 and expansion of the Sexual Assault Special Victims’  
8 Counsel Program: *Provided*, That the funds are made  
9 available for transfer to the Department of the Army, the  
10 Department of the Navy, and the Department of the Air  
11 Force: *Provided further*, That funds transferred shall be  
12 merged with and available for the same purposes and for  
13 the same time period as the appropriations to which the  
14 funds are transferred: *Provided further*, That this transfer  
15 authority is in addition to any other transfer authority  
16 provided in this Act.

17 SEC. 8057. None of the funds appropriated in title  
18 IV of this Act may be used to procure end-items for deliv-  
19 ery to military forces for operational training, operational  
20 use or inventory requirements: *Provided*, That this restric-  
21 tion does not apply to end-items used in development,  
22 prototyping, and test activities preceding and leading to  
23 acceptance for operational use: *Provided further*, That this  
24 restriction does not apply to programs funded within the  
25 National Intelligence Program: *Provided further*, That the

1 Secretary of Defense may waive this restriction on a case-  
2 by-case basis by certifying in writing to the Committees  
3 on Appropriations of the House of Representatives and the  
4 Senate that it is in the national security interest to do  
5 so.

6 SEC. 8058. (a) The Secretary of Defense may, on a  
7 case-by-case basis, waive with respect to a foreign country  
8 each limitation on the procurement of defense items from  
9 foreign sources provided in law if the Secretary determines  
10 that the application of the limitation with respect to that  
11 country would invalidate cooperative programs entered  
12 into between the Department of Defense and the foreign  
13 country, or would invalidate reciprocal trade agreements  
14 for the procurement of defense items entered into under  
15 section 2531 of title 10, United States Code, and the

1 are adjusted for any reason other than the applica-  
2 tion of a waiver granted under subsection (a).

3 (c) Subsection (a) does not apply to a limitation re-  
4 garding construction of public vessels, ball and roller bear-  
5 ings, food, and clothing or textile materials as defined by  
6 section XI (chapters 50–65) of the Harmonized Tariff  
7 Schedule of the United States and products classified  
8 under headings 4010, 4202, 4203, 6401 through 6406,  
9 6505, 7019, 7218 through 7229, 7304.41 through  
10 7304.49, 7306.40, 7502 through 7508, 8105, 8108, 8109,  
11 8211, 8215, and 9404.

12 SEC. 8059. None of the funds appropriated or other-  
13 wise made available by this or other Department of De-  
14 fense Appropriations Acts may be obligated or expended  
15 for the purpose of performing repairs or maintenance to  
16 military family housing units of the Department of De-  
17 fense, including areas in such military family housing  
18 units that may be used for the purpose of conducting offi-  
19 cial Department of Defense business.

20 SEC. 8060. Notwithstanding any other provision of  
21 law, funds appropriated in this Act under the heading  
22 “Research, Development, Test and Evaluation, Defense-  
23 Wide” for any new start advanced concept technology  
24 demonstration project or joint capability demonstration  
25 project may only be obligated 45 days after a report, in-

1 cluding a description of the project, the planned acquisi-  
2 tion and transition strategy and its estimated annual and  
3 total cost, has been provided in writing to the congres-  
4 sional defense committees: *Provided*, That the Secretary  
5 of Defense may waive this restriction on a case-by-case  
6 basis by certifying to the congressional defense committees  
7 that it is in the national interest to do so.

8       SEC. 8061. The Secretary of Defense shall continue  
9 to provide a classified quarterly report to the House and  
10 Senate Appropriations Committees, Subcommittees on  
11 Defense on certain matters as directed in the classified  
12 annex accompanying this Act.

13       SEC. 8062. Notwithstanding section 12310(b) of title  
14 10, United States Code, a Reserve who is a member of  
15 the National Guard serving on full-time National Guard  
16 duty under section 502(f) of title 32, United States Code,  
17 may perform duties in support of the ground-based ele-  
18 ments of the National Ballistic Missile Defense System.

19       SEC. 8063. None of the funds provided in this Act  
20 may be used to transfer to any nongovernmental entity  
21 ammunition held by the Department of Defense that has  
22 a center-fire cartridge and a United States military no-  
23 menclature designation of “armor penetrator”, “armor  
24 piercing (AP)”, “armor piercing incendiary (API)”, or  
25 “armor-piercing incendiary tracer (API-T)”, except to an

1 entity performing demilitarization services for the Depart-  
2 ment of Defense under a contract that requires the entity  
3 to demonstrate to the satisfaction of the Department of  
4 Defense that armor piercing projectiles are either:

5 (1) rendered incapable of reuse by the demili-  
6 tarization process; or

7 (2) used to manufacture ammunition pursuant  
8 to a contract with the Department of Defense or the  
9 manufacture of ammunition for export pursuant to  
10 a License for Permanent Export of Unclassified  
11 Military Articles issued by the Department of State.

12 SEC. 8064. Notwithstanding any other provision of  
13 law, the Chief of the National Guard Bureau, or his des-  
14 ignee, may waive payment of all or part of the consider-  
15 ation that otherwise would be required under section 2667  
16 of title 10, United States Code, in the case of a lease of  
17 personal property for a period not in excess of 1 year to  
18 any organization specified in section 508(d) of title 32,  
19 United States Code, or any other youth, social, or fra-  
20 ternal nonprofit organization as may be approved by the  
21 Chief of the National Guard Bureau, or his designee, on  
22 a case-by-case basis.

23 (INCLUDING TRANSFER OF FUNDS)

24 SEC. 8065. Of the amounts appropriated in this Act  
25 under the heading “Operation and Maintenance, Army”,

1 \$75,950,170 shall remain available until expended: *Pro-*  
2 *vided*, That, notwithstanding any other provision of law,  
3 the Secretary of Defense is authorized to transfer such  
4 funds to other activities of the Federal Government: *Pro-*  
5 *vided further*, That the Secretary of Defense is authorized  
6 to enter into and carry out contracts for the acquisition  
7 of real property, construction, personal services, and oper-  
8 ations related to projects carrying out the purposes of this  
9 section: *Provided further*, That contracts entered into  
10 under the authority of this section may provide for such  
11 indemnification as the Secretary determines to be nec-  
12 essary: *Provided further*, That projects authorized by this  
13 section shall comply with applicable Federal, State, and  
14 local law to the maximum extent consistent with the na-  
15 tional security, as determined by the Secretary of Defense.

16 SEC. 8066. (a) None of the funds appropriated in this  
17 or any other Act may be used to take any action to mod-  
18 ify—

19 (1) the appropriations account structure for the  
20 National Intelligence Program budget, including  
21 through the creation of a new appropriation or new  
22 appropriation account;

23 (2) how the National Intelligence Program  
24 budget request is presented in the unclassified P-1,

1 R-1, and O-1 documents supporting the Depart-  
2 ment of Defense budget request;

3 (3) the process by which the National Intel-  
4 ligence Program appropriations are apportioned to  
5 the executing agencies; or

6 (4) the process by which the National Intel-  
7 ligence Program appropriations are allotted, obli-  
8 gated and disbursed.

9 (b) Nothing in section (a) shall be construed to pro-  
10 hibit the merger of programs or changes to the National  
11 Intelligence Program budget at or below the Expenditure  
12 Center level, provided such change is otherwise in accord-  
13 ance with paragraphs (a)(1)-(3).

14 (c) The Director of National Intelligence and the Sec-  
15 retary of Defense may jointly, only for the purposes of  
16 achieving auditable financial statements and improving  
17 fiscal reporting, study and develop detailed proposals for  
18 alternative financial management processes. Such study  
19 shall include a comprehensive counterintelligence risk as-  
20 sessment to ensure that none of the alternative processes  
21 will adversely affect counterintelligence.

22 (d) Upon development of the detailed proposals de-  
23 fined under subsection (c), the Director of National Intel-  
24 ligence and the Secretary of Defense shall—

1           (1) provide the proposed alternatives to all af-  
2           fected agencies;

3           (2) receive certification from all affected agen-  
4           cies attesting that the proposed alternatives will help  
5           achieve auditability, improve fiscal reporting, and  
6           will not adversely affect counterintelligence; and

7           (3) not later than 30 days after receiving all  
8           necessary certifications under paragraph (2), present  
9           the proposed alternatives and certifications to the  
10          congressional defense and intelligence committees.

11          (e) This section shall not be construed to alter or af-  
12          fect the application of section 1633 of the National De-  
13          fense Authorization Act for Fiscal Year 2016 to the  
14          amounts made available by this Act.

15          SEC. 8067. In addition to amounts provided else-  
16          where in this Act, \$5,000,000 is hereby appropriated to  
17          the Department of Defense, to remain available for obliga-  
18          tion until expended: *Provided*, That notwithstanding any  
19          other provision of law, that upon the determination of the  
20          Secretary of Defense that it shall serve the national inter-  
21          est, these funds shall be available only for a grant to the  
22          Fisher House Foundation, Inc., only for the construction  
23          and furnishing of additional Fisher Houses to meet the  
24          needs of military family members when confronted with

1 the illness or hospitalization of an eligible military bene-  
2 ficiary.

3 (INCLUDING TRANSFER OF FUNDS)

4 SEC. 8068. Of the amounts appropriated in this Act  
5 under the headings “Procurement, Defense-Wide” and  
6 “Research, Development, Test and Evaluation, Defense-  
7 Wide”, \$600,735,000 shall be for the Israeli Cooperative  
8 Programs: *Provided*, That of this amount, \$62,000,000  
9 shall be for the Secretary of Defense to provide to the Gov-  
10 ernment of Israel for the procurement of the Iron Dome  
11 defense system to counter short-range rocket threats, sub-  
12 ject to the U.S.-Israel Iron Dome Procurement Agree-  
13 ment, as amended; \$266,511,000 shall be for the Short  
14 Range Ballistic Missile Defense (SRBMD) program, in-  
15 cluding cruise missile defense research and development  
16 under the SRBMD program, of which \$150,000,000 shall  
17 be for co-production activities of SRBMD missiles in the  
18 United States and in Israel to meet Israel’s defense re-  
19 quirements consistent with each nation’s laws, regulations,  
20 and procedures, of which not more than \$90,000,000, sub-  
21 ject to previously established transfer procedures, may be  
22 obligated or expended until establishment of a U.S.-Israeli  
23 co-production agreement for SRBMD; \$204,893,000 shall  
24 be for an upper-tier component to the Israeli Missile De-  
25 fense Architecture, of which \$120,000,000 shall be for co-

1 production activities of Arrow 3 Upper Tier missiles in  
2 the United States and in Israel to meet Israel's defense  
3 requirements consistent with each nation's laws, regula-  
4 tions, and procedures, of which not more than  
5 \$70,000,000, subject to previously established transfer  
6 procedures, may be obligated or expended until establish-  
7 ment of a U.S.-Israeli co-production agreement for Arrow  
8 3 Upper Tier; and \$67,331,000 shall be for the Arrow  
9 System Improvement Program including development of  
10 a long range, ground and airborne, detection suite: *Pro-*  
11 *vided further*, That the transfer authority provided under  
12 this provision is in addition to any other transfer authority  
13 contained in this Act.

14 (INCLUDING TRANSFER OF FUNDS)

15 SEC. 8069. Of the amounts appropriated in this Act  
16 under the heading "Shipbuilding and Conversion, Navy",  
17 \$160,274,000 shall be available until September 30, 2017,  
18 to fund prior year shipbuilding cost increases: *Provided*,  
19 That upon enactment of this Act, the Secretary of the  
20 Navy shall transfer funds to the following appropriations  
21 in the amounts specified: *Provided further*, That the  
22 amounts transferred shall be merged with and be available  
23 for the same purposes as the appropriations to which  
24 transferred to:

1           (1) Under the heading “Shipbuilding and Con-  
2           version, Navy”, 2012/2017: LPD–17 Amphibious  
3           Transport Dock Program \$45,060,000;

4           (2) Under the heading “Shipbuilding and Con-  
5           version, Navy”, 2011/2017: DDG–51 Destroyer  
6           \$15,959,000;

7           (3) Under the heading “Shipbuilding and Con-  
8           version, Navy”, 2012/2017: Littoral Combat Ship  
9           \$3,600,000;

10          (4) Under the heading “Shipbuilding and Con-  
11          version, Navy”, 2013/2017: Littoral Combat Ship  
12          \$82,400,000;

13          (5) Under the heading “Shipbuilding and Con-  
14          version, Navy”, 2012/2017: Expeditionary Fast  
15          Transport \$6,710,000; and

16          (6) Under the heading “Shipbuilding and Con-  
17          version, Navy”, 2013/2017: Expeditionary Fast  
18          Transport \$6,545,000.

19          SEC. 8070. Funds appropriated by this Act, or made  
20          available by the transfer of funds in this Act, for intel-  
21          ligence activities are deemed to be specifically authorized  
22          by the Congress for purposes of section 504 of the Na-  
23          tional Security Act of 1947 (50 U.S.C. 3094) during fiscal  
24          year 2017 until the enactment of the Intelligence Author-  
25          ization Act for Fiscal Year 2017.

1           SEC. 8071. None of the funds provided in this Act  
2 shall be available for obligation or expenditure through a  
3 reprogramming of funds that creates or initiates a new  
4 program, project, or activity unless such program, project,  
5 or activity must be undertaken immediately in the interest  
6 of national security and only after written prior notifica-  
7 tion to the congressional defense committees.

8           SEC. 8072. The budget of the President for fiscal  
9 year 2018 submitted to the Congress pursuant to section  
10 1105 of title 31, United States Code, shall include sepa-  
11 rate budget justification documents for costs of United  
12 States Armed Forces' participation in contingency oper-  
13 ations for the Military Personnel accounts, the Operation  
14 and Maintenance accounts, the Procurement accounts,  
15 and the Research, Development, Test and Evaluation ac-  
16 counts: *Provided*, That these documents shall include a de-  
17 scription of the funding requested for each contingency op-  
18 eration, for each military service, to include all Active and  
19 Reserve components, and for each appropriations account:  
20 *Provided further*, That these documents shall include esti-  
21 mated costs for each element of expense or object class,  
22 a reconciliation of increases and decreases for each contin-  
23 gency operation, and programmatic data including, but  
24 not limited to, troop strength for each Active and Reserve  
25 component, and estimates of the major weapons systems

1 deployed in support of each contingency: *Provided further*,  
2 That these documents shall include budget exhibits OP-  
3 5 and OP-32 (as defined in the Department of Defense  
4 Financial Management Regulation) for all contingency op-  
5 erations for the budget year and the two preceding fiscal  
6 years.

7 SEC. 8073. None of the funds in this Act may be  
8 used for research, development, test, evaluation, procure-  
9 ment or deployment of nuclear armed interceptors of a  
10 missile defense system.

11 SEC. 8074. Notwithstanding any other provision of  
12 this Act, to reflect savings due to favorable foreign ex-  
13 change rates, the total amount appropriated in this Act  
14 is hereby reduced by \$573,400,000.

15 SEC. 8075. None of the funds appropriated or made  
16 available in this Act shall be used to reduce or disestablish  
17 the operation of the 53rd Weather Reconnaissance Squad-  
18 ron of the Air Force Reserve, if such action would reduce  
19 the WC-130 Weather Reconnaissance mission below the  
20 levels funded in this Act: *Provided*, That the Air Force  
21 shall allow the 53rd Weather Reconnaissance Squadron to  
22 perform other missions in support of national defense re-  
23 quirements during the non-hurricane season.

24 SEC. 8076. None of the funds provided in this Act  
25 shall be available for integration of foreign intelligence in-

1 formation unless the information has been lawfully col-  
2 lected and processed during the conduct of authorized for-  
3 eign intelligence activities: *Provided*, That information  
4 pertaining to United States persons shall only be handled  
5 in accordance with protections provided in the Fourth  
6 Amendment of the United States Constitution as imple-  
7 mented through Executive Order No. 12333.

8       SEC. 8077. (a) None of the funds appropriated by  
9 this Act may be used to transfer research and develop-  
10 ment, acquisition, or other program authority relating to  
11 current tactical unmanned aerial vehicles (TUAVs) from  
12 the Army.

13       (b) The Army shall retain responsibility for and oper-  
14 ational control of the MQ-1C Gray Eagle Unmanned Aer-  
15 ial Vehicle (UAV) in order to support the Secretary of De-  
16 fense in matters relating to the employment of unmanned  
17 aerial vehicles.

18       SEC. 8078. Up to \$15,000,000 of the funds appro-  
19 priated under the heading “Operation and Maintenance,  
20 Navy” may be made available for the Asia Pacific Re-  
21 gional Initiative Program for the purpose of enabling the  
22 Pacific Command to execute Theater Security Cooperation  
23 activities such as humanitarian assistance, and payment  
24 of incremental and personnel costs of training and exer-  
25 cising with foreign security forces: *Provided*, That funds

1 made available for this purpose may be used, notwith-  
2 standing any other funding authorities for humanitarian  
3 assistance, security assistance or combined exercise ex-  
4 penses: *Provided further*, That funds may not be obligated  
5 to provide assistance to any foreign country that is other-  
6 wise prohibited from receiving such type of assistance  
7 under any other provision of law.

8       SEC. 8079. None of the funds appropriated by this  
9 Act for programs of the Office of the Director of National  
10 Intelligence shall remain available for obligation beyond  
11 the current fiscal year, except for funds appropriated for  
12 research and technology, which shall remain available until  
13 September 30, 2018.

14       SEC. 8080. For purposes of section 1553(b) of title  
15 31, United States Code, any subdivision of appropriations  
16 made in this Act under the heading “Shipbuilding and  
17 Conversion, Navy” shall be considered to be for the same  
18 purpose as any subdivision under the heading “Ship-  
19 building and Conversion, Navy” appropriations in any  
20 prior fiscal year, and the 1 percent limitation shall apply  
21 to the total amount of the appropriation.

22       SEC. 8081. (a) Not later than 60 days after the date  
23 of enactment of this Act, the Director of National Intel-  
24 ligence shall submit a report to the congressional intel-  
25 ligence committees to establish the baseline for application

1 of reprogramming and transfer authorities for fiscal year  
2 2017: *Provided*, That the report shall include—

3 (1) a table for each appropriation with a sepa-  
4 rate column to display the President's budget re-  
5 quest, adjustments made by Congress, adjustments  
6 due to enacted rescissions, if appropriate, and the  
7 fiscal year enacted level;

8 (2) a delineation in the table for each appro-  
9 priation by Expenditure Center and project; and

10 (3) an identification of items of special congres-  
11 sional interest.

12 (b) None of the funds provided for the National Intel-  
13 ligence Program in this Act shall be available for re-  
14 programming or transfer until the report identified in sub-  
15 section (a) is submitted to the congressional intelligence  
16 committees, unless the Director of National Intelligence  
17 certifies in writing to the congressional intelligence com-  
18 mittees that such reprogramming or transfer is necessary  
19 as an emergency requirement.

20 SEC. 8082. None of the funds made available by this  
21 Act may be used to eliminate, restructure, or realign Army  
22 Contracting Command—New Jersey or make dispropor-  
23 tionate personnel reductions at any Army Contracting  
24 Command—New Jersey sites without 30-day prior notifi-  
25 cation to the congressional defense committees.



1       SEC. 8085. (a) None of the funds provided for the  
2 National Intelligence Program in this or any prior appro-  
3 priations Act shall be available for obligation or expendi-  
4 ture through a reprogramming or transfer of funds in ac-  
5 cordance with section 102A(d) of the National Security  
6 Act of 1947 (50 U.S.C. 3024(d)) that—

7           (1) creates a new start effort;

8           (2) terminates a program with appropriated  
9 funding of \$10,000,000 or more;

10          (3) transfers funding into or out of the Na-  
11 tional Intelligence Program; or

12          (4) transfers funding between appropriations,  
13 unless the congressional intelligence committees are  
14 notified 30 days in advance of such reprogramming  
15 of funds; this notification period may be reduced for  
16 urgent national security requirements.

17       (b) None of the funds provided for the National Intel-  
18 ligence Program in this or any prior appropriations Act  
19 shall be available for obligation or expenditure through a  
20 reprogramming or transfer of funds in accordance with  
21 section 102A(d) of the National Security Act of 1947 (50  
22 U.S.C. 3024(d)) that results in a cumulative increase or  
23 decrease of the levels specified in the classified annex ac-  
24 companying the Act unless the congressional intelligence  
25 committees are notified 30 days in advance of such re-

1 programming of funds; this notification period may be re-  
2 duced for urgent national security requirements.

3 SEC. 8086. The Director of National Intelligence  
4 shall submit to Congress each year, at or about the time  
5 that the President's budget is submitted to Congress that  
6 year under section 1105(a) of title 31, United States  
7 Code, a future-years intelligence program (including asso-  
8 ciated annexes) reflecting the estimated expenditures and  
9 proposed appropriations included in that budget. Any such  
10 future-years intelligence program shall cover the fiscal  
11 year with respect to which the budget is submitted and  
12 at least the four succeeding fiscal years.

13 SEC. 8087. For the purposes of this Act, the term  
14 "congressional intelligence committees" means the Perma-  
15 nent Select Committee on Intelligence of the House of  
16 Representatives, the Select Committee on Intelligence of  
17 the Senate, the Subcommittee on Defense of the Com-  
18 mittee on Appropriations of the House of Representatives,  
19 and the Subcommittee on Defense of the Committee on  
20 Appropriations of the Senate.

21 SEC. 8088. The Department of Defense shall con-  
22 tinue to report incremental contingency operations costs  
23 for Operation Inherent Resolve, Operation Freedom's Sen-  
24 tinel, and any named successor operations, on a monthly  
25 basis and any other operation designated and identified

1 by the Secretary of Defense for the purposes of section  
2 127a of title 10, United States Code, on a semi-annual  
3 basis in the Cost of War Execution Report as prescribed  
4 in the Department of Defense Financial Management  
5 Regulation Department of Defense Instruction 7000.14,  
6 Volume 12, Chapter 23 “Contingency Operations”, Annex  
7 1, dated September 2005.

8 (INCLUDING TRANSFER OF FUNDS)

9 SEC. 8089. During the current fiscal year, not to ex-  
10 ceed \$11,000,000 from each of the appropriations made  
11 in title II of this Act for “Operation and Maintenance,  
12 Army”, “Operation and Maintenance, Navy”, and “Oper-  
13 ation and Maintenance, Air Force” may be transferred by  
14 the military department concerned to its central fund es-  
15 tablished for Fisher Houses and Suites pursuant to sec-  
16 tion 2493(d) of title 10, United States Code.

17 (INCLUDING TRANSFER OF FUNDS)

18 SEC. 8090. Funds appropriated by this Act may be  
19 available for the purpose of making remittances and trans-  
20 fers to the Defense Acquisition Workforce Development  
21 Fund in accordance with section 1705 of title 10, United  
22 States Code.

23 SEC. 8091. (a) Any agency receiving funds made  
24 available in this Act, shall, subject to subsections (b) and  
25 (c), post on the public Web site of that agency any report

1 required to be submitted by the Congress in this or any  
2 other Act, upon the determination by the head of the agen-  
3 cy that it shall serve the national interest.

4 (b) Subsection (a) shall not apply to a report if—

5 (1) the public posting of the report com-  
6 promises national security; or

7 (2) the report contains proprietary information.

8 (c) The head of the agency posting such report shall  
9 do so only after such report has been made available to  
10 the requesting Committee or Committees of Congress for  
11 no less than 45 days.

12 SEC. 8092. (a) None of the funds appropriated or  
13 otherwise made available by this Act may be expended for  
14 any Federal contract for an amount in excess of  
15 \$1,000,000, unless the contractor agrees not to—

16 (1) enter into any agreement with any of its  
17 employees or independent contractors that requires,  
18 as a condition of employment, that the employee or  
19 independent contractor agree to resolve through ar-  
20 bitration any claim under title VII of the Civil  
21 Rights Act of 1964 or any tort related to or arising  
22 out of sexual assault or harassment, including as-  
23 sault and battery, intentional infliction of emotional  
24 distress, false imprisonment, or negligent hiring, su-  
25 pervision, or retention; or

1           (2) take any action to enforce any provision of  
2           an existing agreement with an employee or inde-  
3           pendent contractor that mandates that the employee  
4           or independent contractor resolve through arbitra-  
5           tion any claim under title VII of the Civil Rights Act  
6           of 1964 or any tort related to or arising out of sex-  
7           ual assault or harassment, including assault and  
8           battery, intentional infliction of emotional distress,  
9           false imprisonment, or negligent hiring, supervision,  
10          or retention.

11          (b) None of the funds appropriated or otherwise  
12          made available by this Act may be expended for any Fed-  
13          eral contract unless the contractor certifies that it requires  
14          each covered subcontractor to agree not to enter into, and  
15          not to take any action to enforce any provision of, any  
16          agreement as described in paragraphs (1) and (2) of sub-  
17          section (a), with respect to any employee or independent  
18          contractor performing work related to such subcontract.  
19          For purposes of this subsection, a “covered subcon-  
20          tractor” is an entity that has a subcontract in excess of  
21          \$1,000,000 on a contract subject to subsection (a).

22          (c) The prohibitions in this section do not apply with  
23          respect to a contractor’s or subcontractor’s agreements  
24          with employees or independent contractors that may not  
25          be enforced in a court of the United States.

1 (d) The Secretary of Defense may waive the applica-  
2 tion of subsection (a) or (b) to a particular contractor or  
3 subcontractor for the purposes of a particular contract or  
4 subcontract if the Secretary or the Deputy Secretary per-  
5 sonally determines that the waiver is necessary to avoid  
6 harm to national security interests of the United States,  
7 and that the term of the contract or subcontract is not  
8 longer than necessary to avoid such harm. The determina-  
9 tion shall set forth with specificity the grounds for the  
10 waiver and for the contract or subcontract term selected,  
11 and shall state any alternatives considered in lieu of a  
12 waiver and the reasons each such alternative would not  
13 avoid harm to national security interests of the United  
14 States. The Secretary of Defense shall transmit to Con-  
15 gress, and simultaneously make public, any determination  
16 under this subsection not less than 15 business days be-  
17 fore the contract or subcontract addressed in the deter-  
18 mination may be awarded.

19 (INCLUDING TRANSFER OF FUNDS)

20 SEC. 8093. From within the funds appropriated for  
21 operation and maintenance for the Defense Health Pro-  
22 gram in this Act, up to \$122,375,000, shall be available  
23 for transfer to the Joint Department of Defense-Depart-  
24 ment of Veterans Affairs Medical Facility Demonstration  
25 Fund in accordance with the provisions of section 1704

1 of the National Defense Authorization Act for Fiscal Year  
2 2010, Public Law 111–84: *Provided*, That for purposes  
3 of section 1704(b), the facility operations funded are oper-  
4 ations of the integrated Captain James A. Lovell Federal  
5 Health Care Center, consisting of the North Chicago Vet-  
6 erans Affairs Medical Center, the Navy Ambulatory Care  
7 Center, and supporting facilities designated as a combined  
8 Federal medical facility as described by section 706 of  
9 Public Law 110–417: *Provided further*, That additional  
10 funds may be transferred from funds appropriated for op-  
11 eration and maintenance for the Defense Health Program  
12 to the Joint Department of Defense-Department of Vet-  
13 erans Affairs Medical Facility Demonstration Fund upon  
14 written notification by the Secretary of Defense to the  
15 Committees on Appropriations of the House of Represent-  
16 atives and the Senate.

17       SEC. 8094. Appropriations available to the Depart-  
18 ment of Defense may be used for the purchase of heavy  
19 and light armored vehicles for the physical security of per-  
20 sonnel or for force protection purposes up to a limit of  
21 \$450,000 per vehicle, notwithstanding price or other limi-  
22 tations applicable to the purchase of passenger carrying  
23 vehicles.

24       SEC. 8095. None of the funds appropriated or other-  
25 wise made available by this Act may be used by the De-

1 partment of Defense or a component thereof in contraven-  
2 tion of the provisions of section 130h of title 10, United  
3 States Code.

4 (INCLUDING TRANSFER OF FUNDS)

5 SEC. 8096. Upon a determination by the Director of  
6 National Intelligence that such action is necessary and in  
7 the national interest, the Director may, with the approval  
8 of the Office of Management and Budget, transfer not to  
9 exceed \$1,000,000,000 of the funds made available in this  
10 Act for the National Intelligence Program: *Provided*, That  
11 such authority to transfer may not be used unless for  
12 higher priority items, based on unforeseen intelligence re-  
13 quirements, than those for which originally appropriated  
14 and in no case where the item for which funds are re-  
15 quested has been denied by the Congress: *Provided further*,  
16 That a request for multiple reprogrammings of funds  
17 using authority provided in this section shall be made  
18 prior to June 30, 2017.

19 SEC. 8097. None of the funds appropriated or other-  
20 wise made available in this or any other Act may be used  
21 to transfer, release, or assist in the transfer or release to  
22 or within the United States, its territories, or possessions  
23 Khalid Sheikh Mohammed or any other detainee who—  
24 (1) is not a United States citizen or a member  
25 of the Armed Forces of the United States; and

1           (2) is or was held on or after June 24, 2009,  
2           at United States Naval Station, Guantanamo Bay,  
3           Cuba, by the Department of Defense.

4           SEC. 8098. (a) None of the funds appropriated or  
5 otherwise made available in this or any other Act may be  
6 used to construct, acquire, or modify any facility in the  
7 United States, its territories, or possessions to house any  
8 individual described in subsection (c) for the purposes of  
9 detention or imprisonment in the custody or under the ef-  
10 fective control of the Department of Defense.

11          (b) The prohibition in subsection (a) shall not apply  
12 to any modification of facilities at United States Naval  
13 Station, Guantanamo Bay, Cuba.

14          (c) An individual described in this subsection is any  
15 individual who, as of June 24, 2009, is located at United  
16 States Naval Station, Guantanamo Bay, Cuba, and who—

17           (1) is not a citizen of the United States or a  
18 member of the Armed Forces of the United States;  
19 and

20           (2) is—

21           (A) in the custody or under the effective  
22 control of the Department of Defense; or

23           (B) otherwise under detention at United  
24 States Naval Station, Guantanamo Bay, Cuba.

1           SEC. 8099. None of the funds appropriated or other-  
2 wise made available in this Act may be used to transfer  
3 any individual detained at United States Naval Station  
4 Guantanamo Bay, Cuba, to the custody or control of the  
5 individual's country of origin, any other foreign country,  
6 or any other foreign entity except in accordance with sec-  
7 tion 1034 of the National Defense Authorization Act for  
8 Fiscal Year 2016 (Public Law 114-92) and section 1034  
9 of the National Defense Authorization Act for Fiscal Year  
10 2017.

11           SEC. 8100. None of the funds made available by this  
12 Act may be used in contravention of the War Powers Res-  
13 olution (50 U.S.C. 1541 et seq.).

14           SEC. 8101. None of the funds made available by this  
15 Act may be used by the Department of Defense or any  
16 other Federal agency to lease or purchase new light duty  
17 vehicles, for any executive fleet, or for any agency's fleet  
18 inventory, except in accordance with Presidential Memo-  
19 randum-Federal Fleet Performance, dated May 24, 2011.

20           SEC. 8102. (a) None of the funds appropriated or  
21 otherwise made available by this or any other Act may  
22 be used by the Secretary of Defense, or any other official  
23 or officer of the Department of Defense, to enter into a  
24 contract, memorandum of understanding, or cooperative  
25 agreement with, or make a grant to, or provide a loan

1 or loan guarantee to Rosoboronexport or any subsidiary  
2 of Rosoboronexport.

3 (b) The Secretary of Defense may waive the limita-  
4 tion in subsection (a) if the Secretary, in consultation with  
5 the Secretary of State and the Director of National Intel-  
6 ligence, determines that it is in the vital national security  
7 interest of the United States to do so, and certifies in writ-  
8 ing to the congressional defense committees that, to the  
9 best of the Secretary's knowledge:

10 (1) Rosoboronexport has ceased the transfer of  
11 lethal military equipment to, and the maintenance of  
12 existing lethal military equipment for, the Govern-  
13 ment of the Syrian Arab Republic;

14 (2) The armed forces of the Russian Federation  
15 have withdrawn from Crimea, other than armed  
16 forces present on military bases subject to agree-  
17 ments in force between the Government of the Rus-  
18 sian Federation and the Government of Ukraine;  
19 and

20 (3) Agents of the Russian Federation have  
21 ceased taking active measures to destabilize the con-  
22 trol of the Government of Ukraine over eastern  
23 Ukraine.

24 (c) The Inspector General of the Department of De-  
25 fense shall conduct a review of any action involving

1 Rosoboronexport with respect to a waiver issued by the  
2 Secretary of Defense pursuant to subsection (b), and not  
3 later than 90 days after the date on which such a waiver  
4 is issued by the Secretary of Defense, the Inspector Gen-  
5 eral shall submit to the congressional defense committees  
6 a report containing the results of the review conducted  
7 with respect to such waiver.

8       SEC. 8103. None of the funds made available in this  
9 Act may be used for the purchase or manufacture of a  
10 flag of the United States unless such flags are treated as  
11 covered items under section 2533a(b) of title 10, United  
12 States Code.

13       SEC. 8104. (a) Of the funds appropriated in this Act  
14 for the Department of Defense, amounts may be made  
15 available, under such regulations as the Secretary of De-  
16 fense may prescribe, to local military commanders ap-  
17 pointed by the Secretary, or by an officer or employee des-  
18 igned by the Secretary, to provide at their discretion ex  
19 gratia payments in amounts consistent with subsection (d)  
20 of this section for damage, personal injury, or death that  
21 is incident to combat operations of the Armed Forces in  
22 a foreign country.

23       (b) An ex gratia payment under this section may be  
24 provided only if—

1           (1) the prospective foreign civilian recipient is  
2           determined by the local military commander to be  
3           friendly to the United States;

4           (2) a claim for damages would not be compen-  
5           sable under chapter 163 of title 10, United States  
6           Code (commonly known as the “Foreign Claims  
7           Act”); and

8           (3) the property damage, personal injury, or  
9           death was not caused by action by an enemy.

10          (c) NATURE OF PAYMENTS.—Any payments provided  
11          under a program under subsection (a) shall not be consid-  
12          ered an admission or acknowledgement of any legal obliga-  
13          tion to compensate for any damage, personal injury, or  
14          death.

15          (d) AMOUNT OF PAYMENTS.—If the Secretary of De-  
16          fense determines a program under subsection (a) to be ap-  
17          propriate in a particular setting, the amounts of pay-  
18          ments, if any, to be provided to civilians determined to  
19          have suffered harm incident to combat operations of the  
20          Armed Forces under the program should be determined  
21          pursuant to regulations prescribed by the Secretary and  
22          based on an assessment, which should include such factors  
23          as cultural appropriateness and prevailing economic condi-  
24          tions.

1           (e) LEGAL ADVICE.—Local military commanders  
2 shall receive legal advice before making ex gratia pay-  
3 ments under this subsection. The legal advisor, under reg-  
4 ulations of the Department of Defense, shall advise on  
5 whether an ex gratia payment is proper under this section  
6 and applicable Department of Defense regulations.

7           (f) WRITTEN RECORD.—A written record of any ex  
8 gratia payment offered or denied shall be kept by the local  
9 commander and on a timely basis submitted to the appro-  
10 priate office in the Department of Defense as determined  
11 by the Secretary of Defense.

12          (g) REPORT.—The Secretary of Defense shall report  
13 to the congressional defense committees on an annual  
14 basis the efficacy of the ex gratia payment program in-  
15 cluding the number of types of cases considered, amounts  
16 offered, the response from ex gratia payment recipients,  
17 and any recommended modifications to the program.

18          SEC. 8105. None of the funds available in this Act  
19 to the Department of Defense, other than appropriations  
20 made for necessary or routine refurbishments, upgrades  
21 or maintenance activities, shall be used to reduce or to  
22 prepare to reduce the number of deployed and non-de-  
23 ployed strategic delivery vehicles and launchers below the  
24 levels set forth in the report submitted to Congress in ac-

1 cordance with section 1042 of the National Defense Au-  
2 thorization Act for Fiscal Year 2012.

3 SEC. 8106. The Secretary of Defense shall post grant  
4 awards on a public Web site in a searchable format.

5 SEC. 8107. None of the funds made available by this  
6 Act may be used to fund the performance of a flight dem-  
7 onstration team at a location outside of the United States:  
8 *Provided*, That this prohibition applies only if a perform-  
9 ance of a flight demonstration team at a location within  
10 the United States was canceled during the current fiscal  
11 year due to insufficient funding.

12 SEC. 8108. None of the funds made available by this  
13 Act may be used by the National Security Agency to—

14 (1) conduct an acquisition pursuant to section  
15 702 of the Foreign Intelligence Surveillance Act of  
16 1978 for the purpose of targeting a United States  
17 person; or

18 (2) acquire, monitor, or store the contents (as  
19 such term is defined in section 2510(8) of title 18,  
20 United States Code) of any electronic communica-  
21 tion of a United States person from a provider of  
22 electronic communication services to the public pur-  
23 suant to section 501 of the Foreign Intelligence Sur-  
24 veillance Act of 1978.

1       SEC. 8109. None of the funds made available by this  
2 Act may be obligated or expended to implement the Arms  
3 Trade Treaty until the Senate approves a resolution of  
4 ratification for the Treaty.

5       SEC. 8110. None of the funds made available in this  
6 or any other Act may be used to pay the salary of any  
7 officer or employee of any agency funded by this Act who  
8 approves or implements the transfer of administrative re-  
9 sponsibilities or budgetary resources of any program,  
10 project, or activity financed by this Act to the jurisdiction  
11 of another Federal agency not financed by this Act with-  
12 out the express authorization of Congress: *Provided*, That  
13 this limitation shall not apply to transfers of funds ex-  
14 pressly provided for in Defense Appropriations Acts, or  
15 provisions of Acts providing supplemental appropriations  
16 for the Department of Defense.

17       SEC. 8111. None of the funds made available in this  
18 Act may be obligated for activities authorized under sec-  
19 tion 1208 of the Ronald W. Reagan National Defense Au-  
20 thorization Act for Fiscal Year 2005 (Public Law 112–  
21 81; 125 Stat. 1621) to initiate support for, or expand sup-  
22 port to, foreign forces, irregular forces, groups, or individ-  
23 uals unless the congressional defense committees are noti-  
24 fied in accordance with the direction contained in the clas-  
25 sified annex accompanying this Act, not less than 15 days

1 before initiating such support: *Provided*, That none of the  
2 funds made available in this Act may be used under sec-  
3 tion 1208 for any activity that is not in support of an  
4 ongoing military operation being conducted by United  
5 States Special Operations Forces to combat terrorism:  
6 *Provided further*, That the Secretary of Defense may waive  
7 the prohibitions in this section if the Secretary determines  
8 that such waiver is required by extraordinary cir-  
9 cumstances and, by not later than 72 hours after making  
10 such waiver, notifies the congressional defense committees  
11 of such waiver.

12       SEC. 8112. None of the funds made available by this  
13 Act may be used with respect to Iraq in contravention of  
14 the War Powers Resolution (50 U.S.C. 1541 et seq.), in-  
15 cluding for the introduction of United States armed forces  
16 into hostilities in Iraq, into situations in Iraq where immi-  
17 nent involvement in hostilities is clearly indicated by the  
18 circumstances, or into Iraqi territory, airspace, or waters  
19 while equipped for combat, in contravention of the con-  
20 gressional consultation and reporting requirements of sec-  
21 tions 3 and 4 of such Resolution (50 U.S.C. 1542 and  
22 1543).

23       SEC. 8113. None of the funds made available by this  
24 Act may be used to divest, retire, transfer, or place in stor-  
25 age or on backup aircraft inventory status, or prepare to

1 divest, retire, transfer, or place in storage or on backup  
2 aircraft inventory status, any A-10 aircraft, or to dis-  
3 tablish any units of the active or reserve component associ-  
4 ated with such aircraft.

5       SEC. 8114. Of the funds provided for “Research, De-  
6 velopment, Test and Evaluation, Defense-Wide” in this  
7 Act, not less than \$2,800,000 shall be used to support  
8 the Department’s activities related to the implementation  
9 of the Digital Accountability and Transparency Act (Pub-  
10 lic Law 113-101; 31 U.S.C. 6101 note) and to support  
11 the implementation of a uniform procurement instrument  
12 identifier as described in subpart 4.16 of Title 48, Code  
13 of Federal Regulations, to include changes in business  
14 processes, workforce, or information technology.

15       SEC. 8115. None of the funds provided in this Act  
16 for the T-AO(X) program shall be used to award a new  
17 contract that provides for the acquisition of the following  
18 components unless those components are manufactured in  
19 the United States: Auxiliary equipment (including pumps)  
20 for shipboard services; propulsion equipment (including  
21 engines, reduction gears, and propellers); shipboard  
22 cranes; and spreaders for shipboard cranes.

23       SEC. 8116. The amount appropriated in title II for  
24 “Operation and Maintenance, Army” is hereby reduced by

1 \$336,000,000 to reflect excess cash balances in Depart-  
2 ment of Defense Working Capital Funds.

3 SEC. 8117. Notwithstanding any other provision of  
4 this Act, to reflect savings due to lower than anticipated  
5 fuel costs, the total amount appropriated in title II of this  
6 Act is hereby reduced by \$1,493,000,000.

7 SEC. 8118. None of the funds made available by this  
8 Act may be used to divest or retire, or to prepare to divest  
9 or retire, KC-10 aircraft.

10 SEC. 8119. None of the funds made available by this  
11 Act may be used to divest, retire, transfer, or place in stor-  
12 age or on backup aircraft inventory status, or prepare to  
13 divest, retire, transfer, or place in storage or on backup  
14 aircraft inventory status, any EC-130H aircraft.

15 SEC. 8120. None of the funds made available by this  
16 Act may be used for Government Travel Charge Card ex-  
17 penses by military or civilian personnel of the Department  
18 of Defense for gaming, or for entertainment that includes  
19 topless or nude entertainers or participants, as prohibited  
20 by Department of Defense FMR, Volume 9, Chapter 3  
21 and Department of Defense Instruction 1015.10 (enclo-  
22 sure 3, 14a and 14b).

23 SEC. 8121. None of the funds made available by this  
24 Act may be used to propose, plan for, or execute a new

1 or additional Base Realignment and Closure (BRAC)  
2 round.

3 SEC. 8122. Funds appropriated in title III of this Act  
4 may be used for a multiyear procurement contract as fol-  
5 lows: AH-64E Apache Helicopter and UH-60M  
6 Blackhawk Helicopter.

7 SEC. 8123. Of the amounts appropriated in this Act  
8 for “Operation and Maintenance, Navy”, \$274,524,000,  
9 to remain available until expended, may be used for any  
10 purposes related to the National Defense Reserve Fleet  
11 established under section 11 of the Merchant Ship Sales  
12 Act of 1946 (50 U.S.C. 4405): *Provided*, That such  
13 amounts are available for reimbursements to the Ready  
14 Reserve Force, Maritime Administration account of the  
15 United States Department of Transportation for pro-  
16 grams, projects, activities, and expenses related to the Na-  
17 tional Defense Reserve Fleet.

18 (INCLUDING TRANSFER OF FUNDS)

19 SEC. 8124. Of the funds previously appropriated for  
20 the “Ship Modernization, Operations and Sustainment  
21 Fund”, the Secretary of the Navy may transfer such funds  
22 to appropriations for research, development, test and eval-  
23 uation; and procurement, only for the purposes of sus-  
24 taining, equipping, and modernizing the Ticonderoga-class  
25 guided missile cruisers CG-63, CG-64, CG-65, CG-66, CG-

1 67, CG-68, CG-69, CG-70, CG-71, CG-72, CG-73, and the  
2 Whidbey Island-class dock landing ships LSD-41, LSD-  
3 42, and LSD-46: *Provided*, That funds transferred shall  
4 be merged with and be available for the same purposes  
5 and for the same time period as the appropriation to which  
6 they are transferred: *Provided further*, That the transfer  
7 authority provided herein shall be in addition to any other  
8 transfer authority provided in the Act: *Provided further*,  
9 That the Secretary of the Navy shall, not less than 30  
10 days prior to making any transfer from the “Ship Mod-  
11 ernization, Operations and Sustainment Fund”, notify the  
12 congressional defense committees in writing of the details  
13 of such transfer: *Provided further*, That the Secretary of  
14 the Navy shall transfer and obligate funds from the “Ship  
15 Modernization, Operations and Sustainment Fund” for  
16 modernization of not more than two Ticonderoga-class  
17 guided missile cruisers: *Provided further*, That no more  
18 than six Ticonderoga-class guided missile cruisers shall be  
19 in a phased modernization at any time: *Provided further*,  
20 That the Secretary of the Navy shall contract for the re-  
21 quired modernization equipment in the year prior to in-  
22 ducting a Ticonderoga-class cruiser for modernization:  
23 *Provided further*, That the prohibition in section 2244a(a)  
24 of title 10, United States Code, shall not apply to the use  
25 of any funds transferred pursuant to this section.

1       SEC. 8125. The Secretary of Defense may use up to  
2 \$95,000,000 appropriated in titles II and IV of this Act  
3 to develop, replace, and sustain Federal Government secu-  
4 rity and suitability background investigation information  
5 technology systems of the Office of Personnel Manage-  
6 ment: *Provided*, That such funds shall supplement, not  
7 supplant any other amounts made available to other Fed-  
8 eral agencies for such purposes.

9       SEC. 8126. None of the funds made available by this  
10 Act for the Joint Surveillance Target Attack Radar Sys-  
11 tem recapitalization program may be obligated or ex-  
12 pended for pre-milestone B activities after December 31,  
13 2017.

14       SEC. 8127. Using funds made available by this Act  
15 or any other Act, the Secretary of the Air Force, pursuant  
16 to a determination under section 2918 of title 10, United  
17 States Code, may implement cost-effective agreements for  
18 required heating facility modernization in the  
19 Kaiserslautern Military Community in the Federal Repub-  
20 lic of Germany: *Provided*, That in the City of  
21 Kaiserslautern and at the Rhine Ordnance Barracks area,  
22 such agreements shall include the use of energy sourced  
23 domestically within the United States as the base load en-  
24 ergy for municipal district heat to the United States De-  
25 fense installations: *Provided further*, That at Landstuhl

1 Army Regional Medical Center and Ramstein Air Base,  
2 furnished heat may be obtained from private, regional or  
3 municipal services, if provisions are included for the con-  
4 sideration of domestically sourced United States energy  
5 sources.

6 SEC. 8128. Of the amounts made available by this  
7 Act for “Defense Working Capital Funds” that are pro-  
8 vided for the Defense Working Capital Fund, Defense  
9 Commissary Agency (DeCA), not less than \$48,000,000  
10 shall be used to support the transportation of fresh fruits  
11 and vegetables to commissaries in Asia and the Pacific.

12 SEC. 8129. None of the funds provided in this Act  
13 shall be used for the acceptance of fresh fruits and vegeta-  
14 bles at any commissary in Asia and the Pacific unless such  
15 fresh fruits and vegetables were grown within the country  
16 in which the commissary was located or were accepted for  
17 use by the Defense Commissary Agency at a location in  
18 the continental United States.

19 SEC. 8130. None of the funds made available in this  
20 Act or any other Act making appropriations for the De-  
21 partment of Defense may be used to close, in part or in  
22 whole, or transfer, in part or in whole, from the jurisdic-  
23 tion of the Department of Defense of the United States,  
24 Naval Station Guantanamo Bay.

1 (INCLUDING TRANSFER OF FUNDS)

2 SEC. 8131. In addition to amounts provided else-  
3 where in this Act for military personnel pay, including ac-  
4 tive duty, reserve and National Guard personnel,  
5 \$340,000,000 is hereby appropriated to the Department  
6 of Defense and made available for transfer only to military  
7 personnel accounts: *Provided*, That the transfer authority  
8 provided under this heading is in addition to any other  
9 transfer authority provided elsewhere in this Act.

10 SEC. 8132. None of the funds made available by this  
11 Act may be used to enforce section 526 of the Energy  
12 Independence and Security Act of 2007 (Public Law 110-  
13 140; 42 U.S.C. 17142).

14 (INCLUDING TRANSFER OF FUNDS)

15 SEC. 8133. Additional readiness funds made available  
16 in title II of this Act for “Operation and Maintenance,  
17 Army”, “Operation and Maintenance, Navy”, “Operation  
18 and Maintenance, Marine Corps”, and “Operation and  
19 Maintenance, Air Force” may be transferred to and  
20 merged with any appropriation of the Department of De-  
21 fense for activities related to the Zika virus in order to  
22 provide health support for the full range of military oper-  
23 ations and sustain the health of the members of the Armed  
24 Forces, civilian employees of the Department of Defense,  
25 and their families, to include: research and development,

1 disease surveillance, vaccine development, rapid detection,  
2 vector controls and surveillance, training, and outbreak re-  
3 sponse: *Provided*, That the authority provided in this sec-  
4 tion is subject to the same terms and conditions as the  
5 authority provided in Sec. 8005 of this Act.

6 SEC. 8134. (a) The Secretary of Defense may provide  
7 from funds appropriated in title II of this Act up to  
8 \$5,000,000 for financial support for military service me-  
9 morials and museums in the acquisition, installation, and  
10 maintenance of exhibits, facilities, and programs that  
11 highlight the role of women in the military.

12 (b)(1) Subject to paragraph (2), the Secretary may  
13 carry out subsection (a) by entering into contracts with  
14 nonprofit organizations under which such an organization  
15 shall carry out the activities described in such subsection.

16 (2) The Secretary may not enter into a contract  
17 under paragraph (1) until the congressional defense com-  
18 mittees have received a report from the Secretary that de-  
19 scribes how the use of such a contract will help educate  
20 and inform the public on the history and mission of the  
21 military, or support training and leadership development  
22 of military personnel, and is in the best interests of the  
23 Department of Defense.

24 SEC. 8135. (a) None of the funds made available in  
25 this Act may be used to maintain or establish a computer

1 network unless such network blocks the viewing,  
2 downloading, and exchanging of pornography.

3 (b) Nothing in subsection (a) shall limit the use of  
4 funds necessary for any Federal, State, tribal, or local law  
5 enforcement agency or any other entity carrying out crimi-  
6 nal investigations, prosecution, or adjudication activities,  
7 or for any activity necessary for the national defense, in-  
8 cluding intelligence activities.

11 RESERVE PERSONNEL, MARINE CORPS

12 For an additional amount for “Reserve Personnel,  
13 Marine Corps”, \$3,087,000: *Provided*, That such amount  
14 is designated by the Congress for Overseas Contingency  
15 Operations/Global War on Terrorism pursuant to section  
16 251(b)(2)(A)(ii) of the Balanced Budget and Emergency

18 RESERVE PERSONNEL, AIR FORCE

19 For an additional amount for “Reserve Personnel,  
20 Air Force”, \$15,979,000: *Provided*, That such amount is

13 equipment procured using funds provided under this head-  
14 ing in this or prior Acts that was transferred to the secu-  
15 rity forces of Ukraine and returned by such forces to the  
16 United States: *Provided further*, That equipment procured  
17 using funds provided under this heading in this or prior  
18 Acts, and not yet transferred to the military or National  
19 Security Forces of Ukraine or returned by such forces to  
20 the United States, may be treated as stocks of the Depart-  
21 ment of Defense upon written notification to the congress-  
22 sional defense committees: *Provided further*, That amounts  
23 made available by this section are designated by the Con-  
24 gress for Overseas Contingency Operations/Global War on

1 Terrorism pursuant to section 251(b)(2)(A)(ii) of the Bal-  
2 anced Budget and Emergency Deficit Control Act of 1985.

3 SEC. 9015. Funds appropriated in this title shall be  
4 available for replacement of funds for items provided to  
5 the Government of Ukraine from the inventory of the  
6 United States to the extent specifically provided for in sec-  
7 tion 9014 of this Act.

8 SEC. 9016. None of the funds made available by this  
9 Act under section 9014 for “Assistance and Sustainment  
10 to the Military and National Security Forces of Ukraine”  
11 may be used to procure or transfer man-portable air de-  
12 fense systems.

13 SEC. 9017. (a) None of the funds appropriated or  
14 otherwise made available by this Act under the heading  
15 “Operation and Maintenance, Defense-Wide” for pay-  
16 ments under section 1233 of Public Law 110–181 for re-  
17 imbursement to the Government of Pakistan may be made  
18 available unless the Secretary of Defense, in coordination  
19 with the Secretary of State, certifies to the congressional  
20 defense committees that the Government of Pakistan is—

21 (1) cooperating with the United States in  
22 counterterrorism efforts against the Haqqani Net-  
23 work, the Quetta Shura Taliban, Lashkar e-Tayyiba,  
24 Jaish-e-Mohammed, Al Qaeda, and other domestic  
25 and foreign terrorist organizations, including taking

1 steps to end support for such groups and prevent  
2 them from basing and operating in Pakistan and  
3 carrying out cross border attacks into neighboring  
4 countries;

5 (2) not supporting terrorist activities against  
6 United States or coalition forces in Afghanistan, and  
7 Pakistan's military and intelligence agencies are not  
8 intervening extra-judicially into political and judicial  
9 processes in Pakistan;

10 (3) dismantling improvised explosive device  
11 (IED) networks and interdicting precursor chemicals  
12 used in the manufacture of IEDs;

13 (4) preventing the proliferation of nuclear-re-  
14 lated material and expertise;

15 (5) implementing policies to protect judicial  
16 independence and due process of law;

17 (6) issuing visas in a timely manner for United  
18 States visitors engaged in counterterrorism efforts  
19 and assistance programs in Pakistan; and

20 (7) providing humanitarian organizations access  
21 to detainees, internally displaced persons, and other  
22 Pakistani civilians affected by the conflict.

23 (b) The Secretary of Defense, in coordination with  
24 the Secretary of State, may waive the restriction in sub-  
25 section (a) on a case-by-case basis by certifying in writing

1 to the congressional defense committees that it is in the  
2 national security interest to do so: *Provided*, That if the  
3 Secretary of Defense, in coordination with the Secretary  
4 of State, exercises such waiver authority, the Secretaries  
5 shall report to the congressional defense committees on  
6 both the justification for the waiver and on the require-  
7 ments of this section that the Government of Pakistan was  
8 not able to meet: *Provided further*, That such report may  
9 be submitted in classified form if necessary.

10 (INCLUDING TRANSFER OF FUNDS)

11 SEC. 9018. In addition to amounts otherwise made  
12 available in this Act, \$500,000,000 is hereby appropriated  
13 to the Department of Defense and made available for  
14 transfer only to the operation and maintenance, military  
15 personnel, and procurement accounts, to improve the intel-  
16 ligence, surveillance, and reconnaissance capabilities of the  
17 Department of Defense: *Provided*, That the transfer au-  
18 thority provided in this section is in addition to any other  
19 transfer authority provided elsewhere in this Act: *Provided*  
20 *further*, That not later than 30 days prior to exercising  
21 the transfer authority provided in this section, the Sec-  
22 retary of Defense shall submit a report to the congres-  
23 sional defense committees on the proposed uses of these  
24 funds: *Provided further*, That the funds provided in this  
25 section may not be transferred to any program, project,

1 or activity specifically limited or denied by this Act: *Pro-*  
2 *vided further*, That amounts made available by this section  
3 are designated by the Congress for Overseas Contingency  
4 Operations/Global War on Terrorism pursuant to section  
5 251(b)(2)(A)(ii) of the Balanced Budget and Emergency  
6 Deficit Control Act of 1985: *Provided further*, That the  
7 authority to provide funding under this section shall termi-  
8 nate on September 30, 2017.

9 SEC. 9019. None of the funds made available by this  
10 Act may be used with respect to Syria in contravention  
11 of the War Powers Resolution (50 U.S.C. 1541 et seq.),  
12 including for the introduction of United States armed or  
13 military forces into hostilities in Syria, into situations in  
14 Syria where imminent involvement in hostilities is clearly  
15 indicated by the circumstances, or into Syrian territory,  
16 airspace, or waters while equipped for combat, in con-  
17 travention of the congressional consultation and reporting  
18 requirements of sections 3 and 4 of that law (50 U.S.C.  
19 1542 and 1543).

20 (RESCISSIONS)

21 SEC. 9020. Of the funds appropriated in Department  
22 of Defense Appropriations Acts, the following funds are  
23 hereby rescinded from the following accounts and pro-  
24 grams in the specified amounts: *Provided*, That such  
25 amounts are designated by the Congress for Overseas

1 Contingency Operations/Global War on Terrorism pursu-  
2 ant to section 251(b)(2)(A)(ii) of the Balanced Budget  
3 and Emergency Deficit Control Act of 1985, as amended:

4 (1) “Operation and Maintenance, Defense-  
5 Wide, DSCA Coalition Support Fund”, 2016/2017,  
6 \$300,000,000;

7 (2) “Counterterrorism Partnership Fund”,  
8 2016/2017, \$200,000,000; and

9 (3) “Other Procurement, Air Force”, 2016/  
10 2018, \$169,000,000.

11 SEC. 9021. Each amount designated in this Act by  
12 the Congress for Overseas Contingency Operations/Global  
13 War on Terrorism pursuant to section 251(b)(2)(A)(ii) of  
14 the Balanced Budget and Emergency Deficit Control Act  
15 of 1985 shall be available only if the President subse-  
16 quently so designates all such amounts and transmits such  
17 designations to the Congress.

### 19 SPENDING REDUCTION ACCOUNT

20 SEC. 10001. The amount by which the applicable al-  
21 location of new budget authority made by the Committee  
22 on Appropriations of the House of Representatives under  
23 section 302(b) of the Congressional Budget Act of 1974  
24 exceeds the amount of proposed new budget authority is  
25 \$0.
