AMENDMENT TO LABOR, HHS, EDUCATION APPROPRIATIONS BILL OFFERED BY MR. COLE OF OKLAHOMA

Page 37, beginning on line 1, revise section 110 to read as follows:

1 SEC. 110. Notwithstanding any other provision of 2 law, beginning October 1, 2015, the Secretary of Labor, in consultation with the Secretary of Agriculture may se-3 4 lect an entity to operate a Civilian Conservation Center on a competitive basis in accordance with section 147 of 5 6 the WIOA, if the Secretary of Labor determines such Center has had consistently low performance under the per-7 8 formance accountability system in effect for the Job Corps 9 program prior to July 1, 2016, or with respect to expected 10 levels of performance established under section 159(c) of 11 such Act beginning on July 1, 2016.

Page 74, lines 15 through 23, strike all after ": *Pro*vided further," and insert the following:

12 That none of the funds made available under this heading
13 may be used by an eligible system (as defined in section
14 102 of the Protection and Advocacy for Individuals with
15 Mental Illness Act (42 U.S.C. 10802)) to institute or pur-

1 sue any legal action in a Federal or State court on behalf of an individual with a developmental disability (as defined 2 in section 102(8)(A) of the Developmental Disabilities and 3 Assistance and Bill of Rights Act of 2000 (20 U.S.C. 4 $15002(8)(\Lambda)$) that is attributable to a mental impairment 5 (or a combination of mental and physical impairments), 6 unless such system has first obtained written consent from 7 the individual or, in the case of mental incapacitation, the 8 individual's legal guardian, to institute or pursue such 9 10 suit.

Page 99, line 7, insert the following:

11 SEC. 233. (a) None of the funds described in sub-12 section (b) may be used to issue or facilitate the issuance 13 of any recommendations of the United States Preventive 14 Services Task Force with respect to breast cancer screen-15 ing, mammography, and prevention.

16 (b) For purposes of subsection (a), funds described17 in this subsection include the following:

18 (1) Funds appropriated by this Act (including19 funds appropriated to any trust fund).

20 (2) Funds provided under previous appropria21 tions Acts to the agencies funded by this title that
22 remain available for obligation or expenditure.

Page 134, line 21, insert "217(g)," after "201(m),".

On page 9 of the report, in the second full paragraph, insert at the end the following: "These duplicative and unauthorized programs undermine the steps Congress took in WIOA to consolidate and streamline Federal workforce development efforts.".

On page 10 of the report, insert after the paragraph relating to Reintegration of ex-offenders the following new paragraph:

Peer-to-Peer Mentoring.—The Committee recognizes the role of peer-to-peer mentoring and counseling in efforts to address employment barriers faced by incarcerated and formerly incarcerated individuals. The Committee urges ETA to incorporate this type of mentoring and counseling in its grant programs.

On page 16 of the report, in the first paragraph under the heading "Office of Workers' Compensation Programs—Salaries and Expenses", strike "\$112,685,000" and insert "\$112,665,000".

On page 22 of the report, in the third full paragraph, insert at the end of the first sentence (before the period) the following: "and that recent changes required by the MSHA increase the amount of rock dust required and the frequency of its application".

On page 34 of the report, after the table, insert the following:

The Committee is aware of the current insufficient rate of organ donation to meet nationwide need. Further, the Committee is concerned that in some circumstances there is significant regional disparity in donation volume. The Committee urges the Secretary to allocate resources toward increasing the organ donor pool and coordinate efforts by the Organ Procurement and Transplantation Network and the Centers for Medicare and Medicaid Services in regions with disproportionately low numbers of organ donors. The Committee directs the Secretary to establish a coordinated initiative to increase the number of donated organs successfully procured and transplanted throughout the United States. The Committee requests a report not later than 90 days after enactment regarding the Department's efforts to increase the number of organ donors in the United States.

On page 39 of the report, in the table, revise the overall recommendation for Core Infectious Diseases to be "\$334,598,000".

On page 50 of the report, in the table, revise the overall recommendation for State and Local Preparedness and Response Capability to be "\$692,700,000".

On page 54 of the report, after the paragraph relating to CDC Duplication of Research, insert the following new paragraph:

Cross-Border Disease Control.—The Committee requests CDC to provide a report in the fiscal year 2017 budget request on how CDC coordinates its various programs with State and local public health departments to measure, track, control, and manage cross-border infectious disease in high volume port cities.

On page 69 of the report, strike "NATIONAL CENTER FOR COMPLEMENTARY AND ALTERNATIVE MEDICINE (NCCAM)" and "NCCAM" and insert "NATIONAL CENTER FOR COMPLEMENTARY AND INTEGRATIVE HEALTH (NCCIH)" and "NCCIH", respectively.

On page 69 of the report, strike "complementary and alternative medicine (CAM) practices" and "CAM systems" and insert "complementary and integrative health (CIH) practices" and "CIH systems", respectively.

On page 72 of the report, insert after the last paragraph the following new paragraph:

Women's Health Research.—The Committee appreciates NIH's recent work to improve the gender balance in pre-clinical research and continues to encourage all future NIH-funded research to include both sexes unless there is a specific reason not to include them. The Committee requests an update on NIH's new policy to require that both sexes be represented in preclinical research. That report should include an analysis of the impact on applications for funding in fiscal year 2015, the projected impact in 2016, and NIH's plan to ensure the analysis of data by sex and other subgroup demographics as a part of grant progress reporting and the compliance of institute directors for funding studies on sex differences and conditions that predominantly impact women.

On page 81 of the report, in the paragraph relating to Updates, insert "Lymphangioleiomyomatosis;" in the list below "Interstitial Cystitis;".

On page 81 of the report, in the paragraph relating to Updates, insert the following after "Science, Technology, Education and Mathematics" (before the semicolon): "(to include specific actions related to Hispanic .

Serving Institutions, and other minority serving institutions)".

On page 89 of the report, in the paragraph relating to section 1115 waivers, strike "*Medicare*" and "Medicare" and insert "*Medicaid*" and "Medicaid", respectively.

On page 91 of the report, insert after the paragraph relating to Treatment Resistance Depression (TRD) the following new paragraph:

Two Midnights Rule.—The Committee is concerned with the potential negative impact to Medicare beneficiaries if CMS continues to move forward with its proposed "Two Midnights" rule that was introduced and implemented through the fiscal year 2014 Inpatient Prospective Payment System regulation. The Committee requests the Secretary to review the negative consequences of the Two Midnights rule and work with impacted stakeholders on alternative options.

On page 99 of the report, in the paragraph under the heading "Aging Network Support Activities", insert at the end the following: "The total amount includes \$2,500,000 to help provide supportive services for aging Holocaust survivors living in the United States.".

On page 99 of the report, in the paragraph under the heading "Elder Rights Support Activities", insert at the end the following: "The total amount includes \$4,000,000 for Elder Justice to provide competitive grants to States to test and evaluate innovative approaches to preventing and responding to elder abuse.".

On page 110 of the report, in the paragraph relating to Sickle Cell, strike "the Office of the Surgeon General" and insert "HRSA".

On page 110 of the report, insert after the paragraph relating to Office of Women's Health the following new paragraph:

Quick Health Data Online System.—The Committee directs the Secretary to continue the operation of the Quick Health Data Online system. The Committee also requests a report with a recommendation on the feasibility of moving the Quick Health Data Online system to another HHS agency.

On page 125 of the report, in the paragraph under the heading "Promise Neighborhoods", strike "\$93,246,000,000" and insert "\$93,246,000".

On page 137 of the report, in the paragraph under the heading "Federal TRIO Programs", insert at the end the following: "The bill does not include funding for the

TRIO Demonstration Initiative proposed by the Department in the budget request.".

On page 142 of the report, insert after the paragraph relating to Interagency Collaboration the following new paragraph:

Expulsions from Early Education Programs.—The Committee is deeply concerned about expulsions and suspensions that occur in preschool settings and K-3 classrooms, particularly given the racial and gender disparities that exist. This is problematic given the research that indicates these practices can adversely affect development, health and education outcomes. The Committee strongly urges the Departments of Education and HHS to highlight evidence-based interventions and identify opportunities, including through relevant programs and the provision of technical assistance, that help prevent and severely limit expulsion and suspension practices in preschool settings and K-3 classrooms and ensure the safety and well-being of all young children.

On page 151 of the report, insert after the paragraph relating to Report on LAE Expenditures the following new paragraphs:

Huntington's Disease.—The Committee urges the Social Security Administration to work with the National Institutes of Health to immediately revise the Huntington's disease (HD) SSDI guidelines, used to determine disability for individuals with the disease, to reflect the most up-to-date medical understandings of the physical, cognitive, and behavioral symptoms. The Committee understands that some believe the current guidelines do not fully recognize the emotional and psychological symptoms of Huntington's disease. Some research sources indicate that the emotional and psychological symptoms appear years before physical symptoms are exhibited. The Committee urges SSA to work with NIH to ensure the SSDI HD guidelines reflect the most current scientific data.

Muscular Dystrophy.—The Committee is aware that SSA was added to the Muscular Dystrophy Coordinating Committee through the Muscular Dystrophy CARE Act Amendments enacted in September 2014. The Committee requests that the agency provide relevant data within the fiscal year 2017 budget request on the rate at which persons with Duchenne and Becker Muscular Dystrophy utilize SSA programs, particularly those focused on promoting employment and community independence such as the Ticket to Work program.

In the Committee Report, on page 94, after the 1st paragraph under the heading "CHILDREN AND FAMILIES SERVICES PROGRAMS", insert the following:

1 The Committee recommendation below for "Social 2 Services/Income Maintenance Research" includes \$750,000 for the Secretary to enter into an agreement 3 with the National Academy of Sciences to provide an evi-4 dence-based, non-partisan analysis of the macroeconomic, 5 health, and crime/social costs of child poverty, to study 6 current efforts aimed at reducing poverty, and to propose 7 recommendations with the goal of reducing the number 8 of children living in poverty in the United States by half 9 10 in 10 years.

Without proper guidance, school districts are at risk of losing funding, which can result in cuts to programs designed to address the emotional, psychological, and educational needs of military dependent students. The Committee urges the Department of Education to provide school districts with clear and timely guidance on how to measure a school district's tax rate compared to the State average tax rate."

And fi-11 nally, the Secretary of Health and Human Services shall 12 review how the Federal Government has achieved competi-13 14 tive cost reductions for drugs since 2001.
