A BILL

Making appropriations for Agriculture, Rural Development, Food and Drug Administration, and Related Agencies programs for the fiscal year ending September 30, 2016, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for Ag-
5 riculture, Rural Development, Food and Drug Administra-
6 tion, and Related Agencies programs for fiscal year ending
7 September 30, 2016, and for other purposes, namely:

8 TITLE I

9 AGRICULTURAL PROGRAMS

10 PRODUCTION, PROCESSING AND MARKETING

11 OFFICE OF THE SECRETARY

12 (INCLUDING TRANSFERS OF FUNDS)

13 For necessary expenses of the Office of the Secretary,
14 \$41,151,000, of which not to exceed \$5,051,000 shall be
15 available for the Immediate Office of the Secretary; not
16 to exceed \$498,000 shall be available for the Office of
17 Tribal Relations; not to exceed \$1,496,000 shall be avail-
18 able for the Office of Homeland Security and Emergency
19 Coordination; not to exceed \$1,209,000 shall be available
20 for the Office of Advocacy and Outreach; not to exceed
21 \$23,590,000 shall be available for the Office of the Assist-
22 ant Secretary for Administration, of which \$22,786,000
23 shall be available for Departmental Administration to pro-
24 vide for necessary expenses for management support serv-
25 ices to offices of the Department and for general adminis-

1 tration, security, repairs and alterations, and other mis-
2 cellaneous supplies and expenses not otherwise provided
3 for and necessary for the practical and efficient work of
4 the Department; not to exceed \$3,772,000 shall be avail-
5 able for the Office of Assistant Secretary for Congres-
6 sional Relations to carry out the programs funded by this
7 Act, including programs involving intergovernmental af-
8 fairs and liaison within the executive branch; and not to
9 exceed \$5,535,000 shall be available for the Office of Com-
10 munications: *Provided*, That the Secretary of Agriculture
11 is authorized to transfer funds appropriated for any office
12 of the Office of the Secretary to any other office of the
13 Office of the Secretary: *Provided further*, That no appro-
14 priation for any office shall be increased or decreased by
15 more than 5 percent: *Provided further*, That not to exceed
16 \$11,000 of the amount made available under this para-
17 graph for the immediate Office of the Secretary shall be
18 available for official reception and representation ex-
19 penses, not otherwise provided for, as determined by the
20 Secretary: *Provided further*, That the amount made avail-
21 able under this heading for Departmental Administration
22 shall be reimbursed from applicable appropriations in this
23 Act for travel expenses incident to the holding of hearings
24 as required by 5 U.S.C. 551–558: *Provided further*, That
25 funds made available under this heading for the Office of

1 the Assistant Secretary for Congressional Relations may
2 be transferred to agencies of the Department of Agri-
3 culture funded by this Act to maintain personnel at the
4 agency level: *Provided further*, That no funds made avail-
5 able under this heading for the Office of Assistant Sec-
6 retary for Congressional Relations may be obligated after
7 30 days from the date of enactment of this Act, unless
8 the Secretary has notified the Committees on Appropria-
9 tions of both Houses of Congress on the allocation of these
10 funds by USDA agency.

11 EXECUTIVE OPERATIONS

12 OFFICE OF THE CHIEF ECONOMIST

13 For necessary expenses of the Office of the Chief
14 Economist, \$16,777,000, of which \$4,000,000 shall be for
15 grants or cooperative agreements for policy research under
16 7 U.S.C. 3155.

17 NATIONAL APPEALS DIVISION

18 For necessary expenses of the National Appeals Divi-
19 sion, \$12,841,000.

20 OFFICE OF BUDGET AND PROGRAM ANALYSIS

21 For necessary expenses of the Office of Budget and
22 Program Analysis, \$9,081,000.

23 OFFICE OF THE CHIEF INFORMATION OFFICER

24 For necessary expenses of the Office of the Chief In-
25 formation Officer, \$44,031,000, of which not less than

1 \$27,000,000 is for cybersecurity requirements of the De-
2 partment.

3 OFFICE OF THE CHIEF FINANCIAL OFFICER

4 For necessary expenses of the Office of the Chief Fi-
5 nancial Officer, \$6,028,000.

6 OFFICE OF THE ASSISTANT SECRETARY FOR CIVIL

7 RIGHTS

8 For necessary expenses of the Office of the Assistant
9 Secretary for Civil Rights, \$893,000.

10 OFFICE OF CIVIL RIGHTS

11 For necessary expenses of the Office of Civil Rights,
12 \$23,871,000.

13 AGRICULTURE BUILDINGS AND FACILITIES

14 (INCLUDING TRANSFERS OF FUNDS)

15 For payment of space rental and related costs pursu-
16 ant to Public Law 92–313, including authorities pursuant
17 to the 1984 delegation of authority from the Adminis-
18 trator of General Services to the Department of Agri-
19 culture under 40 U.S.C. 121, for programs and activities
20 of the Department which are included in this Act, and for
21 alterations and other actions needed for the Department
22 and its agencies to consolidate unneeded space into con-
23 figurations suitable for release to the Administrator of
24 General Services, and for the operation, maintenance, im-
25 provement, and repair of Agriculture buildings and facili-

1 ties, and for related costs, \$54,730,000, to remain avail-
2 able until expended, for buildings operations and mainte-
3 nance expenses: *Provided*, That the Secretary may use un-
4 obligated prior year balances of an agency or office that
5 are no longer available for new obligation for the sole pur-
6 pose of covering shortfalls incurred in prior or current
7 year rental payments for such agency or office.

8 HAZARDOUS MATERIALS MANAGEMENT

9 (INCLUDING TRANSFERS OF FUNDS)

10 For necessary expenses of the Department of Agri-
11 culture, to comply with the Comprehensive Environmental
12 Response, Compensation, and Liability Act (42 U.S.C.
13 9601 et seq.) and the Resource Conservation and Recovery
14 Act (42 U.S.C. 6901 et seq.), \$3,600,000, to remain avail-
15 able until expended: *Provided*, That appropriations and
16 funds available herein to the Department for Hazardous
17 Materials Management may be transferred to any agency
18 of the Department for its use in meeting all requirements
19 pursuant to the above Acts on Federal and non-Federal
20 lands.

21 OFFICE OF INSPECTOR GENERAL

22 For necessary expenses of the Office of Inspector
23 General, including employment pursuant to the Inspector
24 General Act of 1978, \$95,643,000, including such sums
25 as may be necessary for contracting and other arrange-

1 ments with public agencies and private persons pursuant
2 to section 6(a)(9) of the Inspector General Act of 1978,
3 and including not to exceed \$125,000 for certain confiden-
4 tial operational expenses, including the payment of inform-
5 ants, to be expended under the direction of the Inspector
6 General pursuant to Public Law 95-452 and section 1337
7 of Public Law 97-98.

8 OFFICE OF THE GENERAL COUNSEL

9 For necessary expenses of the Office of the General
10 Counsel, \$43,313,000.

11 OFFICE OF ETHICS

12 For necessary expenses of the Office of Ethics,
13 \$3,440,000.

14 OFFICE OF THE UNDER SECRETARY FOR RESEARCH,
15 EDUCATION, AND ECONOMICS

16 For necessary expenses of the Office of the Under
17 Secretary for Research, Education, and Economics,
18 \$893,000.

19 ECONOMIC RESEARCH SERVICE

20 For necessary expenses of the Economic Research
21 Service, \$78,058,000.

22 NATIONAL AGRICULTURAL STATISTICS SERVICE

23 For necessary expenses of the National Agricultural
24 Statistics Service, \$161,206,000, of which up to
25 \$44,525,000 shall be available until expended for the Cen-

1 sus of Agriculture: *Provided*, That amounts made available
2 for the Census of Agriculture may be used to conduct Cur-
3 rent Industrial Report surveys subject to 7 U.S.C.
4 2204g(d) and (f).

5 AGRICULTURAL RESEARCH SERVICE

6 SALARIES AND EXPENSES

7 For necessary expenses of the Agricultural Research
8 Service and for acquisition of lands by donation, exchange,
9 or purchase at a nominal cost not to exceed \$100, and
10 for land exchanges where the lands exchanged shall be of
11 equal value or shall be equalized by a payment of money
12 to the grantor which shall not exceed 25 percent of the
13 total value of the land or interests transferred out of Fed-
14 eral ownership, \$1,122,454,000: *Provided*, That appro-
15 priations hereunder shall be available for the operation
16 and maintenance of aircraft and the purchase of not to
17 exceed one for replacement only: *Provided further*, That
18 appropriations hereunder shall be available pursuant to 7
19 U.S.C. 2250 for the construction, alteration, and repair
20 of buildings and improvements, but unless otherwise pro-
21 vided, the cost of constructing any one building shall not
22 exceed \$375,000, except for headhouses or greenhouses
23 which shall each be limited to \$1,200,000, and except for
24 10 buildings to be constructed or improved at a cost not
25 to exceed \$750,000 each, and the cost of altering any one

1 building during the fiscal year shall not exceed 10 percent
2 of the current replacement value of the building or
3 \$375,000, whichever is greater: *Provided further*, That the
4 limitations on alterations contained in this Act shall not
5 apply to modernization or replacement of existing facilities
6 at Beltsville, Maryland: *Provided further*, That appropria-
7 tions hereunder shall be available for granting easements
8 at the Beltsville Agricultural Research Center: *Provided*
9 *further*, That the foregoing limitations shall not apply to
10 replacement of buildings needed to carry out the Act of
11 April 24, 1948 (21 U.S.C. 113a): *Provided further*, That
12 appropriations hereunder shall be available for granting
13 easements at any Agricultural Research Service location
14 for the construction of a research facility by a non-Federal
15 entity for use by, and acceptable to, the Agricultural Re-
16 search Service and a condition of the easements shall be
17 that upon completion the facility shall be accepted by the
18 Secretary, subject to the availability of funds herein, if the
19 Secretary finds that acceptance of the facility is in the
20 interest of the United States: *Provided further*, That funds
21 may be received from any State, other political subdivi-
22 sion, organization, or individual for the purpose of estab-
23 lishing or operating any research facility or research
24 project of the Agricultural Research Service, as authorized
25 by law: *Provided further*, That of the appropriations here-

1 under, \$56,123,000 may not be obligated until the Sec-
2 retary of Agriculture certifies in writing to the Committees
3 on Appropriations of both Houses of Congress that the
4 Agricultural Research Service has updated its animal care
5 policies and that all Agricultural Research Service re-
6 search facilities at which animal research is conducted
7 have a fully functioning Institutional Animal Care and
8 Use Committee, including all appropriate and necessary
9 record keeping.

10 BUILDINGS AND FACILITIES

11 For the acquisition of land, construction, repair, im-
12 provement, extension, alteration, and purchase of fixed
13 equipment or facilities as necessary to carry out the agri-
14 cultural research programs of the Department of Agri-
15 culture, where not otherwise provided, \$45,000,000 to re-
16 main available until expended.

17 NATIONAL INSTITUTE OF FOOD AND AGRICULTURE

18 RESEARCH AND EDUCATION ACTIVITIES

19 For payments to agricultural experiment stations, for
20 cooperative forestry and other research, for facilities, and
21 for other expenses, \$781,510,000, which shall be for the
22 purposes, and in the amounts, specified in the table titled
23 “National Institute of Food and Agriculture, Research
24 and Education Activities” in the report accompanying this
25 Act: *Provided*, That funds for research grants for 1994

1 institutions, education grants for 1890 institutions, the
2 agriculture and food research initiative, veterinary medi-
3 cine loan repayment, multicultural scholars, graduate fel-
4 lowship and institution challenge grants, and grants man-
5 agement systems shall remain available until expended:
6 *Provided further*, That each institution eligible to receive
7 funds under the Evans-Allen program receives no less
8 than \$1,000,000: *Provided further*, That funds for edu-
9 cation grants for Alaska Native and Native Hawaiian-
10 serving institutions be made available to individual eligible
11 institutions or consortia of eligible institutions with funds
12 awarded equally to each of the States of Alaska and Ha-
13 waii: *Provided further*, That funds for education grants for
14 1890 institutions shall be made available to institutions
15 eligible to receive funds under 7 U.S.C. 3221 and 3222:
16 *Provided further*, That not more than 5 percent of the
17 amounts made available by this or any other Act to carry
18 out the Agriculture and Food Research Initiative under
19 7 U.S.C. 450i(b) may be retained by the Secretary of Ag-
20 riculture to pay administrative costs incurred by the Sec-
21 retary in carrying out that authority.

22 NATIVE AMERICAN INSTITUTIONS ENDOWMENT FUND

23 For the Native American Institutions Endowment
24 Fund authorized by Public Law 103-382 (7 U.S.C. 301
25 note), \$11,880,000, to remain available until expended.

1 EXTENSION ACTIVITIES

2 For payments to States, the District of Columbia,
3 Puerto Rico, Guam, the Virgin Islands, Micronesia, the
4 Northern Marianas, and American Samoa, \$472,051,000,
5 which shall be for the purposes, and in the amounts, speci-
6 fied in the table titled “National Institute of Food and
7 Agriculture, Extension Activities” in the report accom-
8 panying this Act: *Provided*, That funds for facility im-
9 provements at 1890 institutions shall remain available
10 until expended: *Provided further*, That institutions eligible
11 to receive funds under 7 U.S.C. 3221 for cooperative ex-
12 tension receive no less than \$1,000,000: *Provided further*,
13 That funds for cooperative extension under sections 3(b)
14 and (c) of the Smith-Lever Act (7 U.S.C. 343(b) and (c))
15 and section 208(c) of Public Law 93–471 shall be avail-
16 able for retirement and employees’ compensation costs for
17 extension agents.

18 INTEGRATED ACTIVITIES

19 For the integrated research, education, and extension
20 grants programs, including necessary administrative ex-
21 penses, \$30,900,000, which shall be for the purposes, and
22 in the amounts, specified in the table titled “National In-
23 stitute of Food and Agriculture, Integrated Activities” in
24 the report accompanying this Act: *Provided*, That funds

1 for the Food and Agriculture Defense Initiative shall re-
2 main available until September 30, 2017.

3 OFFICE OF THE UNDER SECRETARY FOR MARKETING
4 AND REGULATORY PROGRAMS

5 For necessary expenses of the Office of the Under
6 Secretary for Marketing and Regulatory Programs,
7 \$893,000.

8 ANIMAL AND PLANT HEALTH INSPECTION SERVICE
9 SALARIES AND EXPENSES

10 (INCLUDING TRANSFERS OF FUNDS)

11 For necessary expenses of the Animal and Plant
12 Health Inspection Service, including up to \$30,000 for
13 representation allowances and for expenses pursuant to
14 the Foreign Service Act of 1980 (22 U.S.C. 4085),
15 \$870,945,000, of which \$470,000, to remain available
16 until expended, shall be available for the control of out-
17 breaks of insects, plant diseases, animal diseases and for
18 control of pest animals and birds (“contingency fund”) to
19 the extent necessary to meet emergency conditions; of
20 which \$11,520,000, to remain available until expended,
21 shall be used for the cotton pests program for cost share
22 purposes or for debt retirement for active eradication
23 zones; of which \$35,000,000, to remain available until ex-
24 pended, shall be for Animal Health Technical Services; of
25 which \$697,000 shall be for activities under the authority

1 of the Horse Protection Act of 1970, as amended (15
2 U.S.C. 1831); of which \$55,340,000, to remain available
3 until expended, shall be used to support avian health; of
4 which \$4,251,000, to remain available until expended,
5 shall be for information technology infrastructure; of
6 which \$158,000,000, to remain available until expended,
7 shall be for specialty crop pests; of which, \$8,826,000, to
8 remain available until expended, shall be for field crop and
9 rangeland ecosystem pests; of which \$45,519,000, to re-
10 main available until expended, shall be for tree and wood
11 pests; of which \$3,973,000, to remain available until ex-
12 pended, shall be for the National Veterinary Stockpile; of
13 which up to \$1,500,000, to remain available until ex-
14 pended, shall be for the scrapie program for indemnities;
15 of which \$1,500,000, to remain available until expended,
16 shall be for the wildlife damage management program for
17 aviation safety: *Provided*, That of amounts available under
18 this heading for wildlife services methods development,
19 \$1,000,000 shall remain available until expended: *Pro-*
20 *vided further*, That of amounts available under this head-
21 ing for the screwworm program, \$4,990,000 shall remain
22 available until expended: *Provided further*, That no funds
23 shall be used to formulate or administer a brucellosis
24 eradication program for the current fiscal year that does
25 not require minimum matching by the States of at least

1 40 percent: *Provided further*, That this appropriation shall
2 be available for the operation and maintenance of aircraft
3 and the purchase of not to exceed four, of which two shall
4 be for replacement only: *Provided further*, That in addi-
5 tion, in emergencies which threaten any segment of the
6 agricultural production industry of this country, the Sec-
7 retary may transfer from other appropriations or funds
8 available to the agencies or corporations of the Depart-
9 ment such sums as may be deemed necessary, to be avail-
10 able only in such emergencies for the arrest and eradi-
11 cation of contagious or infectious disease or pests of ani-
12 mals, poultry, or plants, and for expenses in accordance
13 with sections 10411 and 10417 of the Animal Health Pro-
14 tection Act (7 U.S.C. 8310 and 8316) and sections 431
15 and 442 of the Plant Protection Act (7 U.S.C. 7751 and
16 7772), and any unexpended balances of funds transferred
17 for such emergency purposes in the preceding fiscal year
18 shall be merged with such transferred amounts: *Provided*
19 *further*, That appropriations hereunder shall be available
20 pursuant to law (7 U.S.C. 2250) for the repair and alter-
21 ation of leased buildings and improvements, but unless
22 otherwise provided the cost of altering any one building
23 during the fiscal year shall not exceed 10 percent of the
24 current replacement value of the building.

1 In fiscal year 2016, the agency is authorized to collect
2 fees to cover the total costs of providing technical assist-
3 ance, goods, or services requested by States, other political
4 subdivisions, domestic and international organizations,
5 foreign governments, or individuals, provided that such
6 fees are structured such that any entity's liability for such
7 fees is reasonably based on the technical assistance, goods,
8 or services provided to the entity by the agency, and such
9 fees shall be reimbursed to this account, to remain avail-
10 able until expended, without further appropriation, for
11 providing such assistance, goods, or services.

12 BUILDINGS AND FACILITIES

13 For plans, construction, repair, preventive mainte-
14 nance, environmental support, improvement, extension, al-
15 teration, and purchase of fixed equipment or facilities, as
16 authorized by 7 U.S.C. 2250, and acquisition of land as
17 authorized by 7 U.S.C. 428a, \$3,175,000, to remain avail-
18 able until expended.

19 AGRICULTURAL MARKETING SERVICE

20 MARKETING SERVICES

21 For necessary expenses of the Agricultural Marketing
22 Service, \$80,743,000: *Provided*, That this appropriation
23 shall be available pursuant to law (7 U.S.C. 2250) for the
24 alteration and repair of buildings and improvements, but
25 the cost of altering any one building during the fiscal year

1 shall not exceed 10 percent of the current replacement
2 value of the building.

3 Fees may be collected for the cost of standardization
4 activities, as established by regulation pursuant to law (31
5 U.S.C. 9701).

6 LIMITATION ON ADMINISTRATIVE EXPENSES

7 Not to exceed \$60,982,000 (from fees collected) shall
8 be obligated during the current fiscal year for administra-
9 tive expenses: *Provided*, That if crop size is understated
10 and/or other uncontrollable events occur, the agency may
11 exceed this limitation by up to 10 percent with notification
12 to the Committees on Appropriations of both Houses of
13 Congress.

14 FUNDS FOR STRENGTHENING MARKETS, INCOME, AND
15 SUPPLY (SECTION 32)

16 (INCLUDING TRANSFERS OF FUNDS)

17 Funds available under section 32 of the Act of Au-
18 gust 24, 1935 (7 U.S.C. 612c), shall be used only for com-
19 modity program expenses as authorized therein, and other
20 related operating expenses, except for: (1) transfers to the
21 Department of Commerce as authorized by the Fish and
22 Wildlife Act of August 8, 1956; (2) transfers otherwise
23 provided in this Act; and (3) not more than \$20,186,000
24 for formulation and administration of marketing agree-

1 ments and orders pursuant to the Agricultural Marketing
2 Agreement Act of 1937 and the Agricultural Act of 1961.

3 PAYMENTS TO STATES AND POSSESSIONS

4 For payments to departments of agriculture, bureaus
5 and departments of markets, and similar agencies for
6 marketing activities under section 204(b) of the Agricul-
7 tural Marketing Act of 1946 (7 U.S.C. 1623(b)),
8 \$1,235,000.

9 GRAIN INSPECTION, PACKERS AND STOCKYARDS

10 ADMINISTRATION

11 SALARIES AND EXPENSES

12 For necessary expenses of the Grain Inspection,
13 Packers and Stockyards Administration, \$43,048,000:
14 *Provided*, That this appropriation shall be available pursu-
15 ant to law (7 U.S.C. 2250) for the alteration and repair
16 of buildings and improvements, but the cost of altering
17 any one building during the fiscal year shall not exceed
18 10 percent of the current replacement value of the build-
19 ing.

20 LIMITATION ON INSPECTION AND WEIGHING SERVICES

21 EXPENSES

22 Not to exceed \$55,000,000 (from fees collected) shall
23 be obligated during the current fiscal year for inspection
24 and weighing services: *Provided*, That if grain export ac-
25 tivities require additional supervision and oversight, or

1 other uncontrollable factors occur, this limitation may be
2 exceeded by up to 10 percent with notification to the Com-
3 mittees on Appropriations of both Houses of Congress.

4 OFFICE OF THE UNDER SECRETARY FOR FOOD SAFETY

5 For necessary expenses of the Office of the Under
6 Secretary for Food Safety, \$811,000.

7 FOOD SAFETY AND INSPECTION SERVICE

8 For necessary expenses to carry out services author-
9 ized by the Federal Meat Inspection Act, the Poultry
10 Products Inspection Act, and the Egg Products Inspection
11 Act, including not to exceed \$50,000 for representation
12 allowances and for expenses pursuant to section 8 of the
13 Act approved August 3, 1956 (7 U.S.C. 1766),
14 \$1,011,557,000; and in addition, \$1,000,000 may be cred-
15 ited to this account from fees collected for the cost of lab-
16 oratory accreditation as authorized by section 1327 of the
17 Food, Agriculture, Conservation and Trade Act of 1990
18 (7 U.S.C. 138f): *Provided*, That funds provided for the
19 Public Health Data Communication Infrastructure system
20 shall remain available until expended: *Provided further*,
21 That no fewer than 148 full-time equivalent positions shall
22 be employed during fiscal year 2016 for purposes dedi-
23 cated solely to inspections and enforcement related to the
24 Humane Methods of Slaughter Act: *Provided further*, That
25 this appropriation shall be available pursuant to law (7

1 U.S.C. 2250) for the alteration and repair of buildings
2 and improvements, but the cost of altering any one build-
3 ing during the fiscal year shall not exceed 10 percent of
4 the current replacement value of the building.

5 OFFICE OF THE UNDER SECRETARY FOR FARM AND
6 FOREIGN AGRICULTURAL SERVICES

7 For necessary expenses of the Office of the Under
8 Secretary for Farm and Foreign Agricultural Services,
9 \$893,000.

10 FARM SERVICE AGENCY

11 SALARIES AND EXPENSES

12 (INCLUDING TRANSFERS OF FUNDS)

13 For necessary expenses of the Farm Service Agency,
14 \$1,183,025,000: *Provided*, That not more than 50 percent
15 of the \$129,546,000 made available under this heading
16 for information technology related to farm program deliv-
17 ery, including the Modernize and Innovate the Delivery of
18 Agricultural Systems and other farm program delivery
19 systems, may be obligated until the Secretary submits to
20 the Committees on Appropriations of both Houses of Con-
21 gress a plan for expenditure that (1) identifies for each
22 project/investment over \$25,000 (a) the functional and
23 performance capabilities to be delivered and the mission
24 benefits to be realized, (b) the estimated lifecycle cost, in-
25 cluding estimates for development as well as maintenance

1 and operations, and (c) key milestones to be met; (2) dem-

11 is authorized to use the services, facilities, and authorities
12 (but not the funds) of the Commodity Credit Corporation
13 to make program payments for all programs administered
14 by the Agency: *Provided further*, That other funds made
15 available to the Agency for authorized activities may be
16 advanced to and merged with this account: *Provided fur-*
17 *ther*, That funds made available to county committees
18 shall remain available until expended: *Provided further*,
19 That none of the funds available to the Farm Service
20 Agency shall be used to close Farm Service Agency county
21 offices: *Provided further*, That none of the funds available
22 to the Farm Service Agency shall be used to permanently
23 relocate county based employees that would result in an
24 office with two or fewer employees without prior notifica-

1 tion and approval of the Committees on Appropriations
2 of both Houses of Congress.

4 For grants pursuant to section 502(b) of the Agricul-

8 For necessary expenses to carry out wellhead or
9 groundwater protection activities under section 12400 of
10 the Food Security Act of 1985 (16 U.S.C. 3839bb–2),
11 \$5,526,000, to remain available until expended.

12 DAIRY INDEMNITY PROGRAM

13 (INCLUDING TRANSFER OF FUNDS)

14 For necessary expenses involved in making indemnity
15 payments to dairy farmers and manufacturers of dairy
16 products under a dairy indemnity program, such sums as
17 may be necessary, to remain available until expended: *Pro-*
18 *vided*, That such program is carried out by the Secretary
19 in the same manner as the dairy indemnity program de-
20 scribed in the Agriculture, Rural Development, Food and
21 Drug Administration, and Related Agencies Appropria-
22 tions Act, 2001 (Public Law 106–387, 114 Stat. 1549A–
23 12).

1 in section 502 of the Congressional Budget Act of 1974,
2 as follows: farm operating loans, \$53,961,000 for direct
3 operating loans, \$14,352,000 for unsubsidized guaranteed

4 funds and borrowing authority available to each such cor-
5 poration or agency and in accord with law, and to make
6 contracts and commitments without regard to fiscal year
7 limitations as provided by section 104 of the Government
8 Corporation Control Act as may be necessary in carrying
9 out the programs set forth in the budget for the current
10 fiscal year for such corporation or agency, except as here-
11 inafter provided.

12 FEDERAL CROP INSURANCE CORPORATION FUND

13 For payments as authorized by section 516 of the
14 Federal Crop Insurance Act (7 U.S.C. 1516), such sums
15 as may be necessary, to remain available until expended.

16 COMMODITY CREDIT CORPORATION FUND

17 REIMBURSEMENT FOR NET REALIZED LOSSES

18 (INCLUDING TRANSFERS OF FUNDS)

19 For the current fiscal year, such sums as may be nec-
20 essary to reimburse the Commodity Credit Corporation for
21 net realized losses sustained, but not previously reim-
22 bursed, pursuant to section 2 of the Act of August 17,
23 1961 (15 U.S.C. 713a-11): *Provided*, That of the funds
24 available to the Commodity Credit Corporation under sec-
25 tion 11 of the Commodity Credit Corporation Charter Act

1 (15 U.S.C. 714i) for the conduct of its business with the
2 Foreign Agricultural Service, up to \$5,000,000 may be
3 transferred to and used by the Foreign Agricultural Serv-

8 (LIMITATION ON EXPENSES)

12 and maintenance expenses to comply with the requirement
13 of section 107(g) of the Comprehensive Environmental

15 9607(g)), and section 6001 of the Resource Conservation
16 and Recovery Act (42 U.S.C. 6961).

3 For necessary expenses for carrying out the provi-
4 sions of the Act of April 27, 1935 (16 U.S.C. 590a-f),
5 including preparation of conservation plans and establish-
6 ment of measures to conserve soil and water (including
7 farm irrigation and land drainage and such special meas-
8 ures for soil and water management as may be necessary
9 to prevent floods and the siltation of reservoirs and to con-
10 trol agricultural related pollutants); operation of conserva-
11 tion plant materials centers; classification and mapping of
12 soil; dissemination of information; acquisition of lands,
13 water, and interests therein for use in the plant materials

12 For necessary expenses of the Office of the Under

14 RURAL DEVELOPMENT SALARIES AND EXPENSES

15 (INCLUDING TRANSFERS OF FUNDS)

16 For necessary expenses for carrying out the adminis-
17 tration and implementation of programs in the Rural De-
18 velopment mission area, including activities with institu-
19 tions concerning the development and operation of agricul-
20 tural cooperatives; and for cooperative agreements;
21 \$222,705,000: *Provided*, That no less than \$19,500,000
22 shall be for the Comprehensive Loan Accounting System:
23 *Provided further*, That notwithstanding any other provi-
24 sion of law, funds appropriated under this heading may
25 be used for advertising and promotional activities that

1 support the Rural Development mission area: *Provided*
2 *further*, That any balances available from prior years for
3 the Rural Utilities Service, Rural Housing Service, and
4 the Rural Business–Cooperative Service salaries and ex-
5 penses accounts shall be transferred to and merged with
6 this appropriation.

7 RURAL HOUSING SERVICE

8 RURAL HOUSING INSURANCE FUND PROGRAM ACCOUNT

9 (INCLUDING TRANSFERS OF FUNDS)

10 For gross obligations for the principal amount of di-
11 rect and guaranteed loans as authorized by title V of the
12 Housing Act of 1949, to be available from funds in the
13 rural housing insurance fund, as follows: \$900,000,000
14 shall be for direct loans and \$24,000,000,000 shall be for
15 unsubsidized guaranteed loans; \$26,278,000 for section
16 504 housing repair loans; \$28,398,000 for section 515
17 rental housing; \$150,000,000 for section 538 guaranteed
18 multi-family housing loans; \$10,000,000 for credit sales
19 of single family housing acquired property; \$5,000,000 for
20 section 523 self-help housing land development loans; and
21 \$5,000,000 for section 524 site development loans.

22 For the cost of direct and guaranteed loans, including

19 entered into or renewed during the current fiscal year

24 agreements may be transferred and used for the purposes

20 *vided further*, That of the funds made available under this
21 heading, \$17,000,000 shall be available for a demonstra-
22 tion program for the preservation and revitalization of the

24 properties to restructure existing USDA multi-family
25 housing loans, as the Secretary deems appropriate, ex-

1 pressly for the purposes of ensuring the project has suffi-
2 cient resources to preserve the project for the purpose of

4 dents and farm laborers including reducing or eliminating

15 For gross obligations for the principal amount of di-
16 rect and guaranteed loans as authorized by section 306
17 and described in section 381E(d)(1) of the Consolidated
18 Farm and Rural Development Act, \$2,200,000,000 for di-
19 rect loans and \$73,222,000 for guaranteed loans.

20 For the cost of guaranteed loans, including the cost
21 of modifying loans, as defined in section 502 of the Con-
22 gressional Budget Act of 1974, \$1,728,000, to remain
23 available until expended.

24 For the cost of grants for rural community facilities
25 programs as authorized by section 306 and described in

1 section 381E(d)(1) of the Consolidated Farm and Rural
2 Development Act, \$26,778,000, to remain available until
3 expended: *Provided*, That \$4,000,000 of the amount ap-
4 propriated under this heading shall be available for a
5 Rural Community Development Initiative: *Provided fur-*
6 *ther*, That such funds shall be used solely to develop the
7 capacity and ability of private, nonprofit community-based
8 housing and community development organizations, low-
9 income rural communities, and Federally Recognized Na-
10 tive American Tribes to undertake projects to improve
11 housing, community facilities, community and economic
12 development projects in rural areas: *Provided further*,
13 That such funds shall be made available to qualified pri-
14 vate, nonprofit and public intermediary organizations pro-
15 posing to carry out a program of financial and technical
16 assistance: *Provided further*, That such intermediary orga-
17 nizations shall provide matching funds from other sources,
18 including Federal funds for related activities, in an

16 expended: *Provided*, That of the amount appropriated
17 under this heading, not to exceed \$500,000 shall be made
18 available for one grant to a qualified national organization
19 to provide technical assistance for rural transportation in
20 order to promote economic development: *Provided further*,
21 That \$4,000,000 of the amount appropriated under this
22 heading shall be for business grants to benefit Federally
23 Recognized Native American Tribes, including \$250,000
24 for a grant to a qualified national organization to provide
25 technical assistance for rural transportation in order to

1 promote economic development: *Provided further*, That for
2 purposes of determining eligibility or level of program as-
3 sistance the Secretary shall not include incarcerated pris-
4 on populations: *Provided further*, That sections 381E–H
5 and 381N of the Consolidated Farm and Rural Develop-
6 ment Act are not applicable to funds made available under
7 this heading.

8 INTERMEDIARY RELENDING PROGRAM FUND ACCOUNT
9 (INCLUDING TRANSFER OF FUNDS)

10 For the principal amount of direct loans, as author-
11 ized by the Intermediary Relending Program Fund Ac-
12 count (7 U.S.C. 1936b), \$18,889,000.

13 For the cost of direct loans, \$5,217,000, as author-
14 ized by the Intermediary Relending Program Fund Ac-
15 count (7 U.S.C. 1936b), of which \$531,000 shall be avail-
16 able through June 30, 2016, for Federally Recognized Na-
17 tive American Tribes; and of which \$1,021,000 shall be
18 available through June 30, 2016, for Mississippi Delta Re-
19 gion counties (as determined in accordance with Public
20 Law 100–460): *Provided*, That such costs, including the
21 cost of modifying such loans, shall be as defined in section
22 502 of the Congressional Budget Act of 1974.

23 In addition, for administrative expenses to carry out
24 the direct loan programs, \$4,410,000 shall be transferred

1 to and merged with the appropriation for “Rural Develop-

20 gram: *Provided*, That not to exceed \$3,000,000 shall be
21 for grants for cooperative development centers, individual
22 cooperatives, or groups of cooperatives that serve socially

1 groups; and of which \$10,000,000, to remain available

11 of loan guarantees, including the cost of modifying such
12 loans, shall be as defined in section 502 of the Congres-
13 sional Budget Act of 1974.

14 RURAL UTILITIES SERVICE

15 RURAL WATER AND WASTE DISPOSAL PROGRAM ACCOUNT

16 (INCLUDING TRANSFERS OF FUNDS)

17 For the cost of direct loans, loan guarantees, and
18 grants for the rural water, waste water, waste disposal,
19 and solid waste management programs authorized by sec-
20 tions 306, 306A, 306C, 306D, 306E, and 310B and de-
21 scribed in sections 306C(a)(2), 306D, 306E, and
22 381E(d)(2) of the Consolidated Farm and Rural Develop-
23 ment Act, \$473,897,000, to remain available until ex-
24 pended, of which not to exceed \$1,000,000 shall be avail-
25 able for the rural utilities program described in section

1 306(a)(2)(B) of such Act, and of which not to exceed
2 \$993,000 shall be available for the rural utilities program
3 described in section 306E of such Act: *Provided*, That not
4 to exceed \$10,000,000 of the amount appropriated under
5 this heading shall be for grants authorized by section
6 306A(i)(2) of the Consolidated Farm and Rural Develop-
7 ment Act in addition to funding authorized by section
8 306A(i)(1) of such Act: *Provided further*, That not to ex-
9 ceed \$54,240,000 of the amount appropriated under this
10 heading shall be for loans and grants including water and
11 waste disposal systems grants authorized by section
12 306C(a)(2)(B) and section 306D of the Consolidated
13 Farm and Rural Development Act, Federally Recognized
14 Native American Tribes authorized by 306C(a)(1) of such
15 Act, and the Department of Hawaiian Home Lands (of
16 the State of Hawaii): *Provided further*, That funding pro-
17 vided for section 306D of the Consolidated Farm and
18 Rural Development Act may be provided to a consortium

21 funding provided for section 306D of the Consolidated
22 Farm and Rural Development Act may be used by the
23 State of Alaska for training and technical assistance pro-
24 grams and not more than 2 percent of the funding pro-
25 vided for section 306D of the Consolidated Farm and

1 Rural Development Act may be used by a consortium
2 formed pursuant to section 325 of Public Law 105–83 for
3 training and technical assistance programs: *Provided fur-*
4 *ther*, That not to exceed \$19,000,000 of the amount ap-
5 propriated under this heading shall be for technical assist-
6 ance grants for rural water and waste systems pursuant
7 to section 306(a)(14) of such Act, unless the Secretary
8 makes a determination of extreme need, of which
9 \$6,000,000 shall be made available for a grant to a quali-
10 fied nonprofit multi-State regional technical assistance or-
11 ganization, with experience in working with small commu-
12 nities on water and waste water problems, the principal

23 In addition, \$10,372,000, to remain available until
24 expended, for a grant program to finance broadband
25 transmission in rural areas eligible for Distance Learning

17 and the rental of space (to include multiple year leases),
18 in the District of Columbia and elsewhere, and overhead
19 expenses for the Office of the Inspector General such as
20 training, lease of space, utilities, communications, print-
21 ing, supplies, equipment, and other services,

12 ment of Agriculture for the current fiscal year under this
13 Act shall be available for the purchase, in addition to those
14 specifically provided for, of not to exceed 71 passenger
15 motor vehicles of which 68 shall be for replacement only,
16 and for the hire of such vehicles: *Provided*, That notwith-
17 standing this section, the only purchase of new passenger
18 vehicles shall be for those determined by the Secretary to
19 be necessary for transportation safety, to reduce oper-
20 ational costs, and for the protection of life, property, and
21 public safety.

22 SEC. 702. Notwithstanding any other provision of
23 this Act, the Secretary of Agriculture may transfer unobli-
24 gated balances of discretionary funds appropriated by this
25 Act or any other available unobligated discretionary bal-

1 ances that are remaining available of the Department of
2 Agriculture to the Working Capital Fund for the acquisi-
3 tion of plant and capital equipment necessary for the deliv-
4 ery of financial, administrative, and information tech-
5 nology services of primary benefit to the agencies of the
6 Department of Agriculture, such transferred funds to re-
7 main available until expended: *Provided*, That none of the
8 funds made available by this Act or any other Act shall
9 be transferred to the Working Capital Fund without the
10 prior approval of the agency administrator: *Provided fur-*
11 *ther*, That none of the funds transferred to the Working
12 Capital Fund pursuant to this section shall be available
13 for obligation without the written notification and prior
14 approval of the Committees on Appropriations of both
15 Houses of Congress: *Provided further*, That none of the
16 funds appropriated by this Act or made available to the
17 Department's Working Capital Fund shall be available for
18 obligation or expenditure to make any changes to the De-
19 partment's National Finance Center without written noti-
20 fication to and prior approval of the Committees on Ap-
21 propriations of both Houses of Congress as required by
22 section 717 of this Act: *Provided further*, That of annual
23 income amounts in the Working Capital Fund of the De-
24 partment of Agriculture allocated for the National Fi-
25 nance Center, the Secretary may reserve not more than

1 4 percent for the replacement or acquisition of capital
2 equipment, including equipment for the improvement and
3 implementation of a financial management plan, informa-
4 tion technology, and other systems of the National Fi-
5 nance Center or to pay any unforeseen, extraordinary cost
6 of the National Finance Center: *Provided further*, That
7 none of the amounts reserved shall be available for obliga-
8 tion unless the Secretary submits written notification of
9 the obligation to the Committees on Appropriations of
10 both Houses of Congress: *Provided further*, That the limi-
11 tation on the obligation of funds pending notification to
12 Congressional Committees shall not apply to any obliga-
13 tion that, as determined by the Secretary, is necessary to
14 respond to a declared state of emergency that significantly
15 impacts the operations of the National Finance Center;
16 or to evacuate employees of the National Finance Center
17 to a safe haven to continue operations of the National Fi-
18 nance Center.

19 SEC. 703. No part of any appropriation contained in
20 this Act shall remain available for obligation beyond the
21 current fiscal year unless expressly so provided herein.

22 SEC. 704. No funds appropriated by this Act may be
23 used to pay negotiated indirect cost rates on cooperative
24 agreements or similar arrangements between the United
25 States Department of Agriculture and nonprofit institu-

1 tions in excess of 10 percent of the total direct cost of
2 the agreement when the purpose of such cooperative ar-
3 rangements is to carry out programs of mutual interest
4 between the two parties. This does not preclude appro-
5 priate payment of indirect costs on grants and contracts
6 with such institutions when such indirect costs are com-
7 puted on a similar basis for all agencies for which appro-
8 priations are provided in this Act.

9 SEC. 705. Appropriations to the Department of Agri-
10 culture for the cost of direct and guaranteed loans made
11 available in the current fiscal year shall remain available
12 until expended to disburse obligations made in the current
13 fiscal year for the following accounts: the Rural Develop-
14 ment Loan Fund program account, the Rural Electrifica-
15 tion and Telecommunication Loans program account, and
16 the Rural Housing Insurance Fund program account.

17 SEC. 706. None of the funds made available to the
18 Department of Agriculture by this Act may be used to ac-
19 quire new information technology systems or significant
20 upgrades, as determined by the Office of the Chief Infor-
21 mation Officer, without the approval of the Chief Informa-
22 tion Officer and the concurrence of the Executive Informa-
23 tion Technology Investment Review Board: *Provided*, That
24 notwithstanding any other provision of law, none of the
25 funds appropriated or otherwise made available by this

1 Act may be transferred to the Office of the Chief Informa-
2 tion Officer without written notification to and the prior
3 approval of the Committees on Appropriations of both
4 Houses of Congress: *Provided further*, That, notwith-
5 standing section 11319 of title 40, United States Code,
6 none of the funds available to the Department of Agri-
7 culture for information technology shall be obligated for
8 projects over \$25,000 prior to receipt of written approval
9 by the Chief Information Officer.

10 SEC. 707. Funds made available under section 524(b)
11 of the Federal Crop Insurance Act (7 U.S.C. 1524(b)) in
12 the current fiscal year shall remain available until ex-
13 pended to disburse obligations made in the current fiscal
14 year.

15 SEC. 708. Notwithstanding any other provision of
16 law, any former RUS borrower that has repaid or prepaid
17 an insured, direct or guaranteed loan under the Rural
18 Electrification Act of 1936, or any not-for-profit utility
19 that is eligible to receive an insured or direct loan under
20 such Act, shall be eligible for assistance under section
21 313(b)(2)(B) of such Act in the same manner as a bor-
22 rower under such Act.

23 SEC. 709. Except as otherwise specifically provided
24 by law, not more than \$20,000,000 in unobligated bal-
25 ances from appropriations made available for salaries and

1 expenses in this Act for the Farm Service Agency shall
2 remain available through September 30, 2017, for infor-
3 mation technology expenses: *Provided*, That except as oth-
4 erwise specifically provided by law, unobligated balances
5 from appropriations made available for salaries and ex-
6 penses in this Act for the Rural Development mission area
7 shall remain available through September 30, 2017, for
8 information technology expenses.

9 SEC. 710. None of the funds appropriated or other-
10 wise made available by this Act may be used for first-class
11 travel by the employees of agencies funded by this Act in
12 contravention of sections 301–10.122 through 301–10.124
13 of title 41, Code of Federal Regulations.

14 SEC. 711. In the case of each program established
15 or amended by the Agricultural Act of 2014 (Public Law
16 113–79), other than by title I or subtitle A of title III
17 of such Act, or programs for which indefinite amounts
18 were provided in that Act, that is authorized or required
19 to be carried out using funds of the Commodity Credit
20 Corporation—

21 (1) such funds shall be available for salaries
22 and related administrative expenses, including tech-
23 nical assistance, associated with the implementation
24 of the program, without regard to the limitation on
25 the total amount of allotments and fund transfers

1 contained in section 11 of the Commodity Credit
2 Corporation Charter Act (15 U.S.C. 714i); and

3 (2) the use of such funds for such purpose shall
4 not be considered to be a fund transfer or allotment
5 for purposes of applying the limitation on the total
6 amount of allotments and fund transfers contained
7 in such section.

8 SEC. 712. Of the funds made available by this Act,
9 not more than \$2,000,000 shall be used to cover necessary
10 expenses of activities related to all advisory committees,
11 panels, commissions, and task forces of the Department
12 of Agriculture, except for panels used to comply with nego-
13 tiated rule makings and panels used to evaluate competi-
14 tively awarded grants.

15 SEC. 713. None of the funds in this Act shall be avail-
16 able to pay indirect costs charged against any agricultural
17 research, education, or extension grant awards issued by
18 the National Institute of Food and Agriculture that exceed
19 30 percent of total Federal funds provided under each
20 award: *Provided*, That notwithstanding section 1462 of
21 the National Agricultural Research, Extension, and
22 Teaching Policy Act of 1977 (7 U.S.C. 3310), funds pro-
23 vided by this Act for grants awarded competitively by the
24 National Institute of Food and Agriculture shall be avail-
25 able to pay full allowable indirect costs for each grant

1 awarded under section 9 of the Small Business Act (15
2 U.S.C. 638).

3 SEC. 714. None of the funds appropriated or other-
4 wise made available by this or any other Act shall be used
5 to pay the salaries and expenses of personnel to carry out
6 the following:

7 (1) A program authorized by section 14(h)(1)
8 of the Watershed Protection and Flood Prevention
9 Act (16 U.S.C. 1012(h)(1)). Of the funds available
10 under section 14(h)(1) of such Act for fiscal year
11 2016, \$69,000,000 are rescinded.

12 (2) An Environmental Quality Incentives Pro-
13 gram as authorized by sections 1240–1240H of the
14 Food Security Act of 1985 (16 U.S.C. 3839aa–
15 3839aa–8) in excess of \$1,349,000,000: *Provided*,
16 That this limitation shall apply only to funds pro-
17 vided by section 1241(a)(5)(C) of the Food Security
18 Act of 1985 (16 U.S.C. 3841(a)(5)(C)).

19 (3) The Conservation Stewardship Program as
20 authorized by sections 1238D–1238G of the Food
21 Security Act of 1985 (16 U.S.C. 3838d–3838g) in
22 excess of 7,741,000 acres.

23 (4) The Biomass Crop Assistance Program au-
24 thorized by section 9011 of the Farm Security and

1 Rural Investment Act of 2002 (7 U.S.C. 8111) in
2 excess of \$12,000,000 in new obligational authority.

3 (5) The Biorefinery, Renewable Chemical and
4 Biobased Product Manufacturing Assistance pro-
5 gram as authorized by section 9003(g)(1) of the
6 Farm Security and Rural Investment Act of 2002 (7
7 U.S.C. 8103(g)(1)) in excess of \$147,000,000.

8 (6) The Rural Energy for America Program as
9 authorized by section 9007(g)(1) of the Farm Secu-
10 rity and Rural Investment Act of 2002 (7 U.S.C.
11 8107(g)(1)) in excess of \$35,000,000.

12 SEC. 715. None of the funds appropriated or other-
13 wise made available by this or any other Act shall be used
14 to pay the salaries and expenses of personnel to carry out
15 a program under subsection (b)(2)(A)(viii) of section
16 14222 of Public Law 110–246 in excess of \$884,980,000,
17 as follows: Child Nutrition Programs Entitlement Com-
18 modities—\$465,000,000; State Option Contracts—
19 \$5,000,000; Removal of Defective Commodities—
20 \$2,500,000: *Provided*, That none of the funds made avail-
21 able in this Act or any other Act shall be used for salaries
22 and expenses to carry out in this fiscal year section
23 19(i)(1)(E) of the Richard B. Russell National School
24 Lunch Act, as amended, except in an amount that ex-
25 cludes the transfer of \$125,000,000 of the funds to be

1 transferred under subsection (e) of section 14222 of Pub-
2 lic Law 110–246, until October 1, 2016: *Provided further*,
3 That \$125,000,000 made available on October 1, 2016,
4 to carry out section 19(i)(1)(E) of the Richard B. Russell
5 National School Lunch Act, as amended, shall be excluded
6 from the limitation described in subsection (b)(2)(A)(ix)
7 of section 14222 of Public Law 110–246: *Provided further*,
8 That none of the funds appropriated or otherwise made
9 available by this or any other Act shall be used to pay
10 the salaries or expenses of any employee of the Depart-
11 ment of Agriculture or officer of the Commodity Credit
12 Corporation to carry out clause 3 of section 32 of the Agri-
13 cultural Adjustment Act of 1935 (Public Law 74–320, 7
14 U.S.C. 612c, as amended), or for any surplus removal ac-
15 tivities or price support activities under section 5 of the
16 Commodity Credit Corporation Charter Act: *Provided fur-*
17 *ther*, That of the available unobligated balances under
18 (b)(2)(A)(viii) of section 14222 of Public Law 110–246,
19 \$293,020,000 are rescinded.

20 SEC. 716. None of the funds appropriated by this or
21 any other Act shall be used to pay the salaries and ex-
22 penses of personnel who prepare or submit appropriations
23 language as part of the President’s budget submission to
24 the Congress for programs under the jurisdiction of the
25 Appropriations Subcommittees on Agriculture, Rural De-

1 velopment, Food and Drug Administration, and Related
2 Agencies that assumes revenues or reflects a reduction
3 from the previous year due to user fees proposals that
4 have not been enacted into law prior to the submission
5 of the budget unless such budget submission identifies
6 which additional spending reductions should occur in the
7 event the user fees proposals are not enacted prior to the
8 date of the convening of a committee of conference for
9 the fiscal year 2017 appropriations Act.

10 SEC. 717. (a) None of the funds provided by this Act,
11 or provided by previous appropriations Acts to the agen-
12 cies funded by this Act that remain available for obligation
13 or expenditure in the current fiscal year, or provided from
14 any accounts in the Treasury derived by the collection of
15 fees available to the agencies funded by this Act, shall be
16 available for obligation or expenditure through a re-
17 programming, transfer of funds, or reimbursements as au-
18 thorized by the Economy Act, or in the case of the Depart-
19 ment of Agriculture, through use of the authority provided
20 by section 702(b) of the Department of Agriculture Or-
21 ganic Act of 1944 (7 U.S.C. 2257) or section 8 of Public
22 Law 89–106 (7 U.S.C. 2263), that—

- 23 (1) creates new programs;
- 24 (2) eliminates a program, project, or activity;

1 (3) increases funds or personnel by any means
2 for any project or activity for which funds have been
3 denied or restricted;

4 (4) relocates an office or employees;

5 (5) reorganizes offices, programs, or activities;

6 or

7 (6) contracts out or privatizes any functions or
8 activities presently performed by Federal employees;
9 unless the Secretary of Agriculture, the Secretary of
10 Health and Human Services, or the Chairman of the Com-
11 modity Futures Trading Commission (as the case may be)
12 notifies in writing and receives approval from the Commit-
13 tees on Appropriations of both Houses of Congress at least
14 30 days in advance of the reprogramming of such funds
15 or the use of such authority.

16 (b) None of the funds provided by this Act, or pro-
17 vided by previous Appropriations Acts to the agencies
18 funded by this Act that remain available for obligation or
19 expenditure in the current fiscal year, or provided from
20 any accounts in the Treasury derived by the collection of
21 fees available to the agencies funded by this Act, shall be
22 available for obligation or expenditure for activities, pro-
23 grams, or projects through a reprogramming or use of the
24 authorities referred to in subsection (a) involving funds

1 in excess of \$500,000 or 10 percent, whichever is less,
2 that—

3 (1) augments existing programs, projects, or ac-
4 tivities;

5 (2) reduces by 10 percent funding for any exist-
6 ing program, project, or activity, or numbers of per-
7 sonnel by 10 percent as approved by Congress; or

8 (3) results from any general savings from a re-
9 duction in personnel which would result in a change
10 in existing programs, activities, or projects as ap-
11 proved by Congress; unless the Secretary of Agri-
12 culture, the Secretary of Health and Human Serv-
13 ices, or the Chairman of the Commodity Futures
14 Trading Commission (as the case may be) notifies in
15 writing and receives approval from the Committees
16 on Appropriations of both Houses of Congress at
17 least 30 days in advance of the reprogramming or
18 transfer of such funds or the use of such authority.

19 (c) The Secretary of Agriculture, the Secretary of
20 Health and Human Services, or the Chairman of the Com-
21 modity Futures Trading Commission shall notify in writ-
22 ing and receive approval from the Committees on Appro-
23 priations of both Houses of Congress before implementing
24 any program or activity not carried out during the pre-

1 vious fiscal year unless the program or activity is funded
2 by this Act or specifically funded by any other Act.

3 (d) None of the funds provided by this Act, or pro-
4 vided by previous Appropriations Acts to the agencies
5 funded by this Act that remain available for obligation or
6 expenditure in the current fiscal year, or provided from
7 any accounts in the Treasury derived by the collection of
8 fees available to the agencies funded by this Act, shall be
9 available for—

10 (1) modifying major capital investments fund-
11 ing levels, including information technology systems,
12 that involves increasing or decreasing funds in the
13 current fiscal year for the individual investment in
14 excess of \$500,000 or 10 percent of the total cost,
15 whichever is less;

16 (2) realigning or reorganizing new, current, or
17 vacant positions or agency activities or functions to
18 establish a center, office, branch, or similar entity
19 with five or more personnel; or

20 (3) carrying out activities or functions that
21 were not described in the budget request; unless the
22 agencies funded by this Act notify, in writing, the
23 Committees on Appropriations of both Houses of
24 Congress at least 30 days in advance of using the
25 funds for these purposes.

1 (e) As described in this section, no funds may be used
2 for any activities unless the Secretary of Agriculture, the
3 Secretary of Health and Human Services, or the Chair-
4 man of the Commodity Futures Trading Commission re-
5 ceives from the Committee on Appropriations of both
6 Houses of Congress written or electronic mail confirma-
7 tion of receipt of the notification as required in this sec-
8 tion.

9 SEC. 718. Notwithstanding section 310B(g)(5) of the
10 Consolidated Farm and Rural Development Act (7 U.S.C.
11 1932(g)(5)), the Secretary may assess a one-time fee for
12 any guaranteed business and industry loan in an amount
13 that does not exceed 3 percent of the guaranteed principal
14 portion of the loan.

15 SEC. 719. None of the funds appropriated or other-
16 wise made available to the Department of Agriculture, the
17 Food and Drug Administration, the Commodity Futures
18 Trading Commission, or the Farm Credit Administration
19 shall be used to transmit or otherwise make available re-
20 ports, questions, or responses to questions that are a re-
21 sult of information requested for the appropriations hear-
22 ing process to any non-Department of Agriculture, non-
23 Department of Health and Human Services, non-Com-
24 modity Futures Trading Commission, or non-Farm Credit
25 Administration employee.

1 SEC. 720. Unless otherwise authorized by existing
2 law, none of the funds provided in this Act, may be used
3 by an executive branch agency to produce any pre-
4 packaged news story intended for broadcast or distribution
5 in the United States unless the story includes a clear noti-
6 fication within the text or audio of the prepackaged news
7 story that the prepackaged news story was prepared or
8 funded by that executive branch agency.

9 SEC. 721. No employee of the Department of Agri-
10 culture may be detailed or assigned from an agency or
11 office funded by this Act or any other Act to any other
12 agency or office of the Department for more than 60 days
13 in a fiscal year unless the individual's employing agency
14 or office is fully reimbursed by the receiving agency or
15 office for the salary and expenses of the employee for the
16 period of assignment.

17 SEC. 722. None of the funds made available by this
18 Act may be used to pay the salaries and expenses of per-
19 sonnel who provide nonrecourse marketing assistance
20 loans for mohair under section 1201 of the Agricultural
21 Act of 2014 (Public Law 113–79).

22 SEC. 723. Not later than 30 days after the date of
23 enactment of this Act, the Secretary of Agriculture, the
24 Commissioner of the Food and Drug Administration, the
25 Chairman of the Commodity Futures Trading Commis-

1 sion, and the Chairman of the Farm Credit Administra-
2 tion shall submit to the Committees on Appropriations of
3 both Houses of Congress a detailed spending plan by pro-
4 gram, project, and activity for all the funds made available
5 under this Act including appropriated user fees, as defined
6 in the report accompanying this Act.

7 SEC. 724. Funds made available under title II of the
8 Food for Peace Act (7 U.S.C. 1721 et seq.) may only be
9 used to provide assistance to recipient nations if adequate
10 monitoring and controls, as determined by the Adminis-
11 trator of the U.S. Agency for International Development,
12 are in place to ensure that emergency food aid is received
13 by the intended beneficiaries in areas affected by food
14 shortages and not diverted for unauthorized or inappro-
15 priate purposes.

16 SEC. 725. The Secretary shall continue the pilot pro-
17 gram in effect for fiscal year 2013 for packaging and re-
18 viewing section 502 single family direct loans. The Sec-
19 retary shall continue agreements with current inter-
20 mediary organizations and not later than 90 days after
21 enactment of this Act enter into additional agreements
22 necessary for a total not less than 10 qualified inter-
23 mediary organizations. The Secretary shall work with
24 these organizations to increase the effectiveness of the sec-
25 tion 502 single family direct loan program in rural com-

1 munities and shall set aside and make available from the
2 national reserve section 502 loans an amount necessary
3 to support the work of such intermediaries and provide
4 a priority for review of such loans.

5 SEC. 726. For loans and loan guarantees that do not
6 require budget authority and the program level has been
7 established in this Act, the Secretary of Agriculture may
8 increase the program level for such loans and loan guaran-
9 tees by not more than 25 percent: *Provided*, That prior
10 to the Secretary implementing such an increase, the Sec-
11 retary notifies, in writing, the Committees on Appropria-
12 tions of both Houses of Congress at least 15 days in ad-
13 vance.

14 SEC. 727. None of the credit card refunds or rebates
15 transferred to the Working Capital Fund pursuant to sec-
16 tion 729 of the Agriculture, Rural Development, Food and
17 Drug Administration, and Related Agencies Appropria-
18 tions Act, 2002 (7 U.S.C. 2235a; Public Law 107-76)
19 shall be available for obligation without written notifica-
20 tion to, and the prior approval of, the Committees on Ap-
21 propriations of both Houses of Congress: *Provided*, That
22 the refunds or rebates so transferred shall be available for
23 obligation only for the acquisition of plant and capital
24 equipment necessary for the delivery of financial, adminis-

1 trative, and information technology services of primary
2 benefit to the agencies of the Department of Agriculture.

3 SEC. 728. (a) Section 5b(k)(5) of the Commodity Ex-
4 change Act (7 U.S.C. 7a-1(k)(5)) is amended to read as
5 follows:

6 “(5) CONFIDENTIALITY AGREEMENT.—Be-
7 fore the Commission may share information with any enti-
8 ty described in paragraph (4), the Commission shall re-
9 ceive a written agreement from each entity stating that
10 the entity shall abide by the confidentiality requirements
11 described in section 8 relating to the information on swaps
12 transactions that is provided.”.

13 (b) Section 21(d) of the Commodity Exchange Act
14 (7 U.S.C. 24a(d)) is amended to read as follows:

15 “(d) Confidentiality Agreement.— Before the
16 swap data repository may share information with
17 any entity described in subsection (c)(7), the swap
18 data repository shall receive a written agreement
19 from each entity stating that the entity shall abide
20 by the confidentiality requirements described in sec-
21 tion 8 relating to the information on swap trans-
22 actions that is provided.”.

23 (c) The amendments made by this section shall take
24 effect as if enacted on July 12, 2010.

1 SEC. 729. None of the funds made available by this
2 Act may be used to procure processed poultry products
3 imported into the United States from the People's Repub-
4 lic of China for use in the school lunch program under
5 the Richard B. Russell National School Lunch Act (42
6 U.S.C. 1751 et seq.), the Child and Adult Food Care Pro-
7 gram under section 17 of such Act (42 U.S.C. 1766), the
8 Summer Food Service Program for Children under section
9 13 of such Act (42 U.S.C. 1761), or the school breakfast
10 program under the Child Nutrition Act of 1966 (42
11 U.S.C. 1771 et seq.).

12 SEC. 730. In response to an eligible community where
13 the drinking water supplies are inadequate due to a nat-
14 ural disaster, as determined by the Secretary, including
15 drought or severe weather, the Secretary may provide po-
16 table water through the Emergency Community Water As-
17 sistance Grant Program for an additional period of time
18 not to exceed 120 days beyond the established period pro-
19 vided under the Program in order to protect public health.

20 SEC. 731. Funds provided by this or any prior Appro-
21 priations Act for the Agriculture and Food Research Ini-
22 tiative under 7 U.S.C. 450i(b) shall be made available
23 without regard to section 7128 of the Agricultural Act of
24 2014 (7 U.S.C. 3371 note), under the matching require-
25 ments in laws in effect on the date before the date of en-

1 actment of such section: *Provided*, That the requirements
2 of 7 U.S.C. 450i(b)(9) shall continue to apply.

3 SEC. 732. For the period beginning on the date of
4 enactment of this Act through school year 2016–2017,
5 with respect to the school lunch program established under
6 the Richard B. Russell National School Lunch Act (42
7 U.S.C. 1751 et seq.) or the school breakfast program es-
8 tablished under the Child Nutrition Act of 1966 (42
9 U.S.C. 1771 et seq.) and final regulations published by
10 the Department of Agriculture in the Federal Register on
11 January 26, 2012 (77 Fed. Reg. 4088 et seq.), the Sec-
12 retary shall allow States to grant an exemption from the
13 whole grain requirements that took effect on or after July
14 1, 2014, and the States shall establish a process for evalu-
15 ating and responding, in a reasonable amount of time, to
16 requests for an exemption: *Provided*, That school food au-
17 thorities demonstrate hardship, including financial hard-
18 ship, in procuring specific whole grain products which are
19 acceptable to the students and compliant with the whole
20 grain-rich requirements: *Provided further*, That school
21 food authorities shall comply with the applicable grain
22 component or standard with respect to the school lunch
23 or school breakfast program that was in effect prior to
24 July 1, 2014.

1 SEC. 733. None of the funds appropriated or other-
2 wise made available by this or any other Act shall be used
3 to pay the salaries and expenses of personnel to implement
4 any regulations under the Richard B. Russell National
5 School Lunch Act (42 U.S.C. 1751 et seq.), the Child Nu-
6 trition Act of 1966 (42 U.S.C. 1771 et seq.), the Healthy,
7 Hunger-Free Kids Act of 2010 (Public Law 111–296), or
8 any other law that would require a reduction in the quan-
9 tity of sodium contained in federally reimbursed meals,
10 foods, and snacks sold in schools below Target 1 (as de-
11 scribed in section 220.8(f)(3) of title 7, Code of Federal
12 Regulations (or successor regulations)) until the latest sci-
13 entific research establishes the reduction is beneficial for
14 children.

15 SEC. 734. None of the funds made available by this
16 Act may be used to release or implement the final version
17 of the eighth edition of the Dietary Guidelines for Ameri-
18 cans, revised pursuant to section 301 of the National Nu-
19 trition Monitoring and Related Research Act of 1990 (7
20 U.S.C. 5341), unless the Secretary of Agriculture and the
21 Secretary of Health and Human Services comply with
22 each of the following requirements:

23 (1) Each revision to any nutritional or dietary
24 information or guideline contained in the 2010 edi-
25 tion of the Dietary Guidelines for Americans and

1 any new nutritional or dietary information or guide-
2 line to be included in the eighth edition of the Die-
3 tary Guidelines for Americans—

4 (A) shall be based on scientific evidence
5 that has been rated “Grade I: Strong” by the
6 grading rubric developed by the Nutrition Evi-
7 dence Library of the Department of Agri-
8 culture; and

9 (B) shall be limited in scope to only mat-
10 ters of diet and nutrient intake.

11 (2) The Secretaries shall release a preliminary
12 draft of the eighth edition of the Dietary Guidelines
13 for Americans, including a list of all the scientific
14 studies and evidence supporting each revised or new
15 nutritional or dietary information or guideline, for a
16 period of public comment of at least 90 days.

17 (3) Following the end of the public comment
18 period, the Secretaries shall provide a period for
19 agency review of public comments of at least 60
20 days.

21 SEC. 735. None of the funds made available by this
22 Act may be used by the Secretary of Agriculture, acting
23 through the Food and Nutrition Service, to commence any
24 new research and evaluation projects until the Secretary
25 submits to the Committees on Appropriations of both

1 Houses of Congress a research and evaluation plan for fis-
2 cal year 2016, prepared in coordination with the Research,
3 Education, and Economics mission area of the Depart-
4 ment of Agriculture, and a period of 30 days beginning
5 on the date of the submission of the plan expires to permit
6 Congressional review of the plan.

7 SEC. 736. The unobligated balances identified by the
8 Treasury Appropriation Fund Symbol 12X0113 are re-
9 scinded.

10 SEC. 737. Of the unobligated prior year balance can-
11 cellations identified by Treasury Appropriation Fund
12 Symbol 12X1980, \$13,000,000 is rescinded.

13 SEC. 738. The unobligated balances identified by the
14 Treasury Appropriation Fund Symbol 12X3318,
15 12X1010, 12X1090, 12X1003, 12X1907, 12X0402,
16 12X3508, and 12X3322 are rescinded.

17 SEC. 739. Section 166 of the Federal Agriculture Im-
18 provement and Reform Act of 1996 (7 U.S.C. 7286) is
19 amended—

20 (1) by striking “and title I of the Food, Con-
21 servation, and Energy Act of 2008” both places it
22 appears and inserting “title I of the Food, Conserva-
23 tion, and Energy Act of 2008, and Subtitle B of title
24 I of the Agricultural Act of 2014”; and

1 (2) by amending paragraph (3) of subsection
2 (c) to read as follows: “(3) APPLICATION OF AU-
3 THORITY.—The Secretary shall carry out para-
4 graph (1) under the same terms and conditions as
5 were in effect for the 2008 crop year for loans made
6 to producers under subtitle B of title I of the Food,
7 Conservation, and Energy Act of 2008 (7 U.S.C.
8 8701 et. seq.).”.

9 SEC. 740. Of the unobligated balances identified by
10 the Treasury Appropriation Fund Symbol 12X1072,
11 \$20,000,000 is hereby rescinded: *Provided*, That no
12 amounts may be rescinded from amounts that were des-
13 ignated by Congress as an emergency requirement or for
14 disaster relief requirement pursuant to a Concurrent Res-
15 olution on the Budget or the Balanced Budget and Emer-
16 gency Deficit Control Act of 1985.

17 SEC. 741. In carrying out subsection (h) of section
18 502 of the Housing Act of 1949 (42 U.S.C. 1472), the
19 Secretary of Agriculture shall have the same authority
20 with respect to loans guaranteed under such section and
21 eligible lenders for such loans as the Secretary has under
22 subsections (h) and (j) of section 538 of such Act (42
23 U.S.C. 1490p–2) with respect to loans guaranteed under
24 such section 538 and eligible lenders for such loans.

1 SEC. 742. Of the unobligated balances of appropria-
2 tions in Public Law 108–199, Public Law 109–234, and
3 Public Law 110–28 made available for the “Emergency
4 Watershed Protection Program”, \$2,400,000 shall be
5 available for the purposes of such program for any dis-
6 aster occurring fiscal year 2016 or fiscal year 2017, and
7 shall remain available until expended.

8 SEC. 743. None of the funds made available by this
9 Act may be used to propose, promulgate, or implement
10 any rule, or take any other action with respect to, allowing
11 or requiring information intended for a prescribing health
12 care professional, in the case of a drug or biological prod-
13 uct subject to section 503(b)(1) of the Federal Food,
14 Drug, and Cosmetic Act (21 U.S.C. 353(b)(1)), to be dis-
15 tributed to such professional electronically (in lieu of in
16 paper form) unless and until a Federal law is enacted to
17 allow or require such distribution.

18 SEC. 744. None of the funds made available by this
19 Act may be used to implement, administer, or enforce the
20 final rule entitled “Food Labeling; Nutrition Labeling of
21 Standard Menu Items in Restaurants and Similar Retail
22 Food Establishments” published by the Food and Drug
23 Administration in the Federal Register on December 1,
24 2014 (79 Fed. Reg. 71156 et seq.) until the later of—

25 (1) December 1, 2016; or

1 (2) the date that is one year after the date on
2 which the Secretary of Health and Human Services
3 publishes Level 1 guidance with respect to nutrition
4 labeling of standard menu items in restaurants and
5 similar retail food establishments in accordance with
6 paragraphs (g)(1)(i), (g)(1)(ii), (g)(1)(iii), and
7 (g)(1)(iv) of section 10.155 of title 21, Code of Fed-
8 eral Regulations.

9 SEC. 745. None of the funds made available by this
10 Act may be used to review or approve an application for
11 an exemption for investigational use of a drug or biological
12 product under section 505(i) of the Federal Food, Drug,
13 and Cosmetic Act (21 U.S.C. 335(i)) or section 351(a)(3)
14 of the Public Health Service Act (42 U.S.C. 262(a)(3))
15 in research in which a human embryo is intentionally cre-
16 ated or modified to include a heritable genetic modifica-
17 tion.

18 SEC. 746. None of the funds made available by this
19 or any other Act may be used to implement or enforce
20 any provision of the FDA Food Safety Modernization Act
21 (P.L. 111–353), including the amendments made thereby,
22 with respect to the regulation of the distribution, sale, or
23 receipt of dried spent grain byproducts of the alcoholic
24 beverage production process, irrespective of whether such
25 byproducts are solely intended for use as animal feed.

1 SEC. 747. For each tobacco product which the Sec-
2 retary of Health and Human Services, by regulation under
3 section 901(b) of the Federal Food, Drug, and Cosmetic
4 Act, deems to be subject to chapter IX of such Act, none
5 of the funds made available in this Act or any other Act
6 may be used to treat any reference in sections 905 and
7 910 of such Act to February 15, 2007, as other than a
8 reference to the effective date of the regulation under
9 which a tobacco product is deemed subject to the require-
10 ments of such Act pursuant to section 901(b)(1) of such
11 Act, and any reference in such sections to 21 months after
12 the date of enactment of the Family Smoking Prevention
13 and Tobacco Control Act as other than a reference to 21
14 months after the date of such final deeming regulation.

15 SEC. 748. The program ineligibility penalty that pro-
16 hibits payment by the Federal Crop Insurance Corpora-
17 tion of any portion of a crop insurance premium, otherwise
18 required by sections 1211(a)(1)(E) and 1221(c) of the
19 Food Security Act of 1985 (16 U.S.C. 3811(a)(1)(E),
20 3821(c)) as added by section 2611 of the Agricultural Act
21 of 2014, shall not apply or be enforced for the 2016 rein-
22 surance year: *Provided*, That the delay in enforcement im-
23 posed by this section shall not be construed to limit the
24 authority of the Department of Agriculture to assist pro-
25 ducers, particularly producers subject to sections 1211

1 and 1221 of the Food Security Act of 1985 for the first
2 time solely due to an amendment made by section 2611
3 of the Agricultural Act of 2014, to come into compliance
4 with the requirements of such sections in a timely manner:
5 *Provided further*, That a producer that comes into compli-
6 ance before June 30, 2016, shall not be ineligible for pay-
7 ment of a portion of a crop insurance premium for the
8 2016 or 2017 reinsurance year on account of non-compli-
9 ance before that date.

10 SPENDING REDUCTION ACCOUNT

11 SEC. 749. The amount by which the applicable alloca-
12 tion of new budget authority made by the Committee on
13 Appropriations of the House of Representatives under sec-
14 tion 302(b) of the Congressional Budget Act of 1974 ex-
15 ceeds the amount of proposed new budget authority is \$0.

16 This Act may be cited as the “Agriculture, Rural De-
17 velopment, Food and Drug Administration, and Related
18 Agencies Appropriations Act, 2016”.
